Supporting Information

- 1. Draft service plans for 2001-02 were reported to the former Strategy Panel on 15 November 2000 containing PPF proposals on key outcomes and targets for 2001-2002 in the light of the budget policy steers.
- 2. As agreed by the former Policy Resources Committee these Service Plans were prepared on the basis of pre-modernisation service plan areas, and they have not been revised to take account of the new portfolios.
- 3. At the Cabinet meeting held on 18 December 2000, Cabinet Members were asked to finalise and agree individual Service Plans within their portfolio areas once the final budget recommendations had been made. The budget was agreed by Council at its meeting on 22 February 2001. Following on from that the Council's Local Performance Plan has also been agreed by Council on 23 March 2001.
