## Part 1 Description of service

## Purpose of service

To facilitate the provision of adequate Public Passenger Transport, Education Transport and Social Services Transport services to meet the Council's stated aims, objectives and obligations.

## What are the statutory parameters that regulate how the service operates?

Public transport is regulated under the terms of the Transport Act 1985, which mandates on local authorities the establishment and publication of policies, but gives discretion in the scale of services that are delivered.

Education Transport is provided primarily under the (consolidated) Education Act 1996, the Further & Higher Education Act 1992 and the Transport Act 1985; services are provided principally to meet statutory obligations, but with some discretionary and self-financing supplementary provision.

Social Services Transport is provided to meet the needs of individual clients in accordance with agreed care arrangements

## Volume of service (2001/2)

#### Number of customers/users

- 12,000 entitled students receive free home-to school transport each day
- A further 4,000 students receive assisted transport through the discretionary travel scheme or 16+ Student Travel Scheme
- Approximately 12 million passenger journeys are made annually on local bus services in the county.

#### Number of contracts

- About 60 contracts for local bus services funded from the Council's Passenger Transport budget, 20 de minimis agreements and support for 5 dial-a-ride schemes;
- Financial contributions to 4 cross-boundary bus services secured by neighbouring local authorities:
- A further 18 contracts and 10 de minimis agreements covering new or enhanced bus services funded by means of the Rural Bus Service Grant;

- One community minibus scheme funded from the Rural Bus Challenge Competition (1998) and a new network of wheelchair-accessible bus services to start in Autumn 2000 with funding from the 1999 Rural Bus Challenge Competition;
- About 900 education transport contracts and in-house services catering for home-to-school transport (and weekly transport for swimming classes);

21.4 FTE, of whom 12 FTE are engaged in the administration of home-to-school transport on behalf of the Education Department.
