
I am writing on behalf of the St Leonards PCC to you in your capacity as the Chairman of the Governors at Hawridge and Cholesbury C of E School.

I hope the open meeting in February goes well.

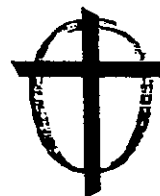
