I have finally managed to collate some comments on the Draft Plan for inclusion in the discussion at the forthcoming SOC meeting on 24 September. Our comments are set out below - please let me know if you need any further clarification.

- 4.2 and 6.1 I expect that the impact of the plans for 'A Vibrant Aylesbury Vale' has been considered in the draft plan as this has been presented at several other meetings recently. I understand that an additional 29K houses will be built in the Aylesbury Vale area by 2031.
- 6.8: Linking the Quality of Provision to Raising Standards: Building Schools for the Future this is now available and it would be appropriuate for the SOC plans to reflect the LEAs plans for this, together with the way forward for the process.
- 6.12 4 post-16 students per 100 houses appears low.

Positive approach encouraging lots of collaboration. Would be helpful to include the LSC in the promotion of community cohesion (p 21.)

Could you identify which 11-16 schools will be providing some post-16 provision?

11.0 (p 43) - it might be worth considering adding some context to the info set out here as there is no reference to numbers on roll for individual schools elsewhere in the document.
