

# CABINET DECISION NOTICE

The following decision(s) were taken by Cabinet at its meeting held on **Tuesday 6 October 2015**  
:-

## 1. **FOOD SERVICE PLAN**

### (a) **Decision(s)**

- (1) That the revised Food Service Plan be commended for adoption by Council and the Environment and Living Scrutiny Committee be thanked for its input.
- (2) That, for the reasons outlined in the Cabinet report, Council be recommended to remove the Plan from the Policy Framework and to delegate approval of the Plan to the Cabinet Member for Environment and Waste, after having been the subject of scrutiny.

### (b) **Reason(s) for Decision(s)**

The amount of discretion that can be exercised by the Council is limited in terms of the requirements set by the FSA and the above proposal would be a more efficient way of reviewing the Plan. This will still involve scrutiny which is considered to be an important part of the process.

### (c) **Alternative Option(s) Considered**

To continue with the current approval process.

### (d) **Relevant Scrutiny Committee**

Environment and Living. That Committee has reviewed the revised Plan and its comments have been taken into account. As the Plan will be submitted for final approval by full Council, Cabinet's decisions are not subject to call-in.

### (e) **Conflicts of Interest/Dispensation(s)**

## **2. RISK MANAGEMENT STRATEGY AND STRATEGIC RISK**

### **(a) Decision(s)**

That, subject to reference being made to the work of the wider south-east authorities in the sources of assurance in relation to the delivery of the Vale of Aylesbury Local Plan (VALP) (page 7 of Appendix 3 to the Cabinet report), the updated Risk Management Strategy, Risk Appetite Statement and Strategic Risk Register be approved.

### **(b) Reason(s) for Decision(s)**

To reflect properly the Council's approach to risk in a continually changing operational environment whilst at the same time ensuring a robust governance structure. The reference to the work of the wider south-east authorities reflected the Council's dependency on this being delivered within the expected timeline for delivery of VALP.

### **(c) Alternative Option(s) Considered**

To do nothing. However this would not reflect the current operational environment.

### **(d) Relevant Scrutiny Committee**

Finance and Services Scrutiny Committee.
