Application to Vary the Licence of the Grand Junction Public House, 13 High Street, Buckingham

I have looked at the application and the voluntary conditions which are listed in Part P of the application form.

I am aware that anecdotally the premises has created noise in the neighbourhood. However since an application was made in 2005 the Environmental Health Department has only received one complaint alleging noise from the premises, and this complaint was more than 12 months ago.

Having recently visited the premises I am aware that changes have been made to make the rear external areas more attractive and therefore providing an environment for people to smoke outside in compliance with the Health Act 2006 (smoke-free legislation) and away from noise sensitive dwellings opposite the front of the premises. The applicant has also put forward a condition concerning the control of persons outside and in the vicinity of the premises. I am aware that this will not control all aspects of antisocial behaviour, however it should control noise disturbance at the front of the premises.

I understand that historically people have raised issues concerning noise escape from the fire exit doors which lead onto Corwall Meadow. In the revised application the applicant has retained the condition concerning the Break Glass Lock on this door, and if this condition is adhered to noise breakout should be minimal.

The application also states that live and recorded music will not be provided as regulated entertainment externally. This means that although some music can be played at background levels it should not cause a disturbance to any residents. If music is louder than background then this would be a breach of their licence. (there is no numeric level to define background, however I would suggest that if people have to raise their voice to talk to someone the music is louder than background).

The only issue I would raise is that the condition in part P(d) concerning windows and doors remaining closed during regulated entertainment. I have spoken to John Birch and he has agreed that this condition is reworded to state:

Other than for entry and exit purposes, when regulated entertainment is taking place, all windows and external doors shall remain closed. The only exception is the front door on the main building which opens on to the High Street, however the internal lobby door shall remain closed other than for entry and exit

The purpose of the wording is just to clarify the condition and it does not change the requirements which it is aimed to achieved.

Buckingham and Winslow Access for All represents those people with mobility difficulties. Their impairments range from lameness to poor eyesight. Our organisation has members in the central Buckingham area, living in Mary McManus Drive and Stratford Rd. Their hinterland includes the The Grand Junction.

Members have mentioned this public house in meetings over the last three years. The comments have been about the Inn's poor record in keeping to its licence: drinking and noise often spills out, particularly at the side and the rear of the property, partly because fire doors after left open. The pub's clientele contain a number of rowdy, youthful types who are noisy when leaving the premises and unpleasant for those with motor difficulties to meet in the street because their loudness and cocky behaviour is amplified by excessive drinking.

Our members do not believe that this Public House operates its present licence in a proper manner that is sensitive to the needs of neighbours and local residents. We have no confidence that the extension to that licence will result in an improvement to the existing poor situation and we fear very much that the situation will expand and result in further aggravation and loss of amenity. We oppose any extension to the pub's licence with vigour.

There is a groundswell of opposition in Buckingham to the proposal by the **Grand Junction Public House** at 13 High Street, Buckingham MK18 1NT to vary the existing premises licence PR0275. Residents living in close proximity to the premises are increasingly dismayed at the constant noise emanating from the premises late at night, and by the anti-social behaviour of many of its patrons when they leave the premises.

This has been a growing problem for some time. The Grand Junction management have a poor record of complying with existing licensing conditions, with instances of on-street drinking, fire doors being left open, and late-night music etc noise being regularly reported. Many of their patrons (they seem to encourage the younger set) are clearly the worst for wear when they do eventually leave the premises – often well beyond the stated closing time – and then present a very real nuisance by their rowdy and often aggressive behaviour which often extends to 1.30am or later. The latest instances include shouting and swearing in the vicinity at 1.30am last Saturday morning, a fracas near the vet surgery resulting in someone injuring their hand, and urinating on a doorstep.

That the Grand Junction now wishes to extend its opening hours still further, and have music played outdoors (with additional speakers installed for this purpose), can only add to the problem that residents have already had to put up with long enough. In fact, for many residing in the area, this latest application represents the last straw.

The licence holder's inability to operate in the prescribed manner, coupled with his apparent disregard of the

distressing effects of his business on the local community, lead me to suggest that he is unsuitable to hold his current licence, let alone be granted consent to extend his current trading hours.

Buckingham residents are entitled to enjoy peace and quiet late at night and in the early hours of the morning.

Thank you for taking the time to read this letter.

In the application reference is made to the "Main building" but no mention is made of the separate **Barn or Function building**, close by, which I think is available for hire. Is this application only dealing with the Main building? What licence permissions does ,or will, the separate building have?

I object to the following parts of the above application:-

In regard to Part F. I object to any music being played outside.

Part O, d) The Application says "The Volume of recorded music relayed to the patio area shall not be audble at any point outside of the premises boundary". This, from my limited technical knowledge, is not possible. The premises is bounded on two sides by the public highway; people live on three sides of it. At present the music is clearly audible from the pavement and that is when it is played inside the building!! No music should be allowed out side of the Main building or outside of the separate Funtion Room.

When ever the weather is warm the Fire Door (which opens directly onto the street) and the Front door are left open. Noise from the music and conversation in the bar can be heard on the street. Also instance of 'humourous' abuse from those standing at the bar to members of the public passing by has happened.

On hot evenings the custumers treat the street as an extention of the bar and stand outside drinking. In itself this is not against the law but it demonstrates the way the premises is used.

In summary; the statement from P, d), fifth sentence, "OTHER THAN FOR THE ENTRY AND EXIT PURPOSES, WHEN REGULATED ENTERTAINMENT IS TAKING PLACE, ALL WINDOWS AND DOORS, INCLUDING FIRE DOORS, SHALL REMAIN CLOSED." is not happening at present.

Further to your letter and a letter received from the Buckingham and Maids Moreton neighbourhood action group I would like to extend my objections to the new license being applied for.

As you know, I have already made one formal complaint in regards to the Grand Junction not adhering to the current licence. These included the noise levels from the pub, incorrect fire door not being installed, Fire door being left open each night, and the rubbish, such as cigarette butts being thrown on the floor out side of the pub.

Since your visit, the Fire door has been closed, I do not know if it is now the correct door but it has been kept closed which has at least made the late evenings more bearable.

I did read that all doors and windows were to be kept closed, however the front door is always kept open.

Buckingham is a small town, which during the day has a wonderful atmosphere, during the night along the High Street it becomes not a very nice place to live, which of course has disappointed me since moving in this year.

There is a well known alcohol problem in the UK, and Buckingham is no exception. Late at night we have screaming, shouting, swearing, fighting etc until 2am – 3am in the morning. We also have vehicles parking outside our homes due to the fact we have no residence parking and people whom drink in the pub use the spaces in front of our homes. The taxi rank, which is set up in the same area means many people just stand in the front of our homes waiting for taxis, it would seem so sensible to use the public car park at night for a taxi rank which would force people to go there where there are no residents. We have cars driving at high speed, skidding around the road at night, with exhausts to make the car sound very loud and playing music at very high volumes. Taking into account the market which sets up every Saturday at 6am in fort of our homes we get very little quiet, rest already.

So, to the point in question.

I object to the extending of licensing hours on a Monday, Tuesday and Wednesday as this is currently the only time we get some peace and quiet and I do not feel we should be encouraging late night drinking anymore.

I object to the sales of alcohol for retail purposes, we have a off licence already in Buckingham and this will only be taking there business away from them and I am positive

people will be drinking the alcohol outside of the public house, and with little police presence this will not be stopped.

I object to the playing of any music outside and additional speakers as it will no doubt be louder than expected and it will interfere with local residents. I can only go on the current owners past history of not adhering to his/her current agreement

The making of music, I am not clear about what there intention is, but I object unless they can assure me that the music will not interfere with my living space and is kept inside to the rear of the property.

I object to the playing of music outside, the Grand Junction sits within a residential area and this is totally unacceptable, surely if people want to have this type of establishment they would have a public house in a non residential town/ area.

I do not object to the extended hours for Christmas and New year as this is a time for celebration.

2 weeks ago, we had 8 cars park in front of my home, all of which all were playing music and everyone was using it as a meeting place, I did go outside at 2.30am to ask them to move away when much abuse were thrown at me. These were young people of 18-22 yrs of age and I find it totally unacceptable. The police presence in Buckingham at night seems to be very limited and I do not feel we are getting the support we need.

I have on three occasion now had people being sick on my door step and on one occasion a fight happened and the blood was all along the path way on high street.

Twice I have had people urinating on my front garden which I find absolutely disgusting and it is not acceptable. Why should the local residents have to put up with this anti social behaviour.

My daughter is three years old and I really do not want her to hear or see this type of behaviour. I want her to have a good start I life and not to be afraid of scared.

I would like to highlight how it is the local residents that are the heart and sole of the town, we use the local amenities, we invest thousands of pounds on our very old properties to ensure they are in a good state and the centre of town remains a very attractive town. Why should we do this when the local area is becoming very unpleasant and not a place to have a home.

The reason I have highlighted all my concerns is because I feel it is important you consider all the goings on and you may then fully understand why local residents object to the Grand Junctions request.

Dear Mr Seal and Mr Swan,

I write to object to the application to vary the existing premises licence at the Grand Junction, High Street Buckingham. This public house is situated in a predominantly residential area of our High Street in our beautiful market town, and I live diagonally opposite it. I object to the variation of the license for the reasons as stated below:

1. Extension to Midnight on Monday, Tuesday and Wednesday

I strongly object to a later license on Monday, Tuesday and Wednesday. There is constant unacceptable level of noise from the Grand Junction late at night and anti-social behaviour by many of its customers when they leave the premises. This would set a president for all other public houses in the town to open later, and no one in Buckingham wants this including all those residents living in and near the town centre, the Town Council and the Neighbourhood Action Group. I have on at least 8 separate occasions in the last year had to go to the Grand Junction, asked to see the Landlord, and been fobbed off that he/she is not there. On these 8 occasions I have had to ask a doorman or member of staff to turn down the DJ's music, and shut the fire exit. In just one specific recent example at 1.30am on Saturday 3rd of November 2007, I was woken up by a gang of approx 10 youths who had left the Grand Junction and set up camp right outside my house. Not only was there the usual shouting, screaming and swearing, a young lad was nursing his bleeding and injured hand, and discussing the fracas that took place outside the vets surgery (located next to the Grand Junction). Another lad then proceeded to urinate on my doorstep. Please be advised that this is not isolated incident and it is now commonplace at least EVERY Friday and Saturday that my family and I are woken in the early hours of the morning. In fact, 10 Youths hanging around at night is frankly mild, normally is more like 70 people from this pub - blind drunk, shouting, screaming, swearing, littering and vandalising from 1:00am until 2:30am. In April 2006, I was the victim of vandalism when a 20 stone plus drunk swan-dived on the bonnet of my car causing £635 worth of damage.

2. Sale of Alcohol for consumption off the Premises

Given my objections in the paragraph above, it would be extremely unwise (read clear stupidity) to permit any license to supply alcohol for sale off the premises from this pub. This would only serve to fuel the already drunk customers when they turn out into the High Street, and indeed encourage them to sit on the benches and drink yet more, smash the glass bottles in the street and use the bottles as missiles or weapons.

3. Music, Live Music and Dance License

Over the past 4 weeks I have noticed that there currently appears to be no Dj at the pub on a Friday and Saturday evening playing from the usual speaker system so loud it would easily fill the new Wembley Stadium. Long may the Djs absence continue! The area where the Dj traditionally sets up is currently (and I believe temporarily) housing a pool table - no doubt to lure the licensing, environmental health and Council officials when they visit it in the daytime, that this is not indeed a nightclub, which is exactly what it has been for the past year or so. I fear that the DJ will return once a license variation is granted. I would encourage both the licensing and environmental health teams to visit our town on a Friday and Saturday evening between 1:00am and 2:00am.

4. Additional Outdoor Speaker covering the Patio Area Quite how ANY music relayed to the patio area would not being audible at any point outside the premises boundary is physically impossible. There is an archway to the side of the pub facing the High Street, and when I walked past it on Monday 12th November at 9pm, the speaker that they already have outside was audible. Given the history of noise disturbance and complaints about this pub, I strongly object to ANY outdoor music.

5. No New Customers to be admitted after 24:00

It is my understanding that the other pubs in the town do not allow admittance after 23:00 on a Friday and Saturday evening. The Grand Junction should be brought in line with these other pubs, as this is reducing anti-social behaviour between 23:00 and 24:00.

Other Issues to Consider

WPC Beckie Jones reported to the Neighbourhood Action Group on 26th Sept 2007, that Thames Valley Police had received 6 complaints regarding the Grand Junction, mainly public order issues and one instance of under-age drinking.

Summary

I would like to see the Landlords adhering to the current license, for a period of lets say six months, before ANY variation of their license is permitted. Buckingham residents are entitled to enjoy peace and quiet late at night and in the early hours of the morning. Extending the licensing hours, allowing sale of alcohol off the premises, and permitting live music and a dance license will only further worsen our situation. As the representative for the Neighbourhood Action Group for the town centre I strongly object to the variations being proposed to this license.

It has come to my notice that the Grand Junction Public House proposes to extend its drinking hours until midnight on Mondays, Tuesdays and Wednesdays. It is already open until midnight on Thursdays and 1 o'clock on Fridays and Saturdays which, in my opinion, is more than enough. In fact, it is too much. It is little wonder that young people are getter liver disease when the people responsible for licensing laws make it so easy for them.

I live in Castle Street in Buckingham. It is several hundred yards from the Grand Junction but at the weekends I am disturbed late into the night by lager louts (of both sexes) shouting, swearing, singing, being sick and often fighting who are all drunk and staggering their way home from pubs in the town. I live in a town house which fronts directly onto the pavement and my bedroom window faces the road. As well as being disturbed, more often than not I find empty cans and glasses on my doorstep — not to mention the vomit and urine!

You may have gathered from the above, that I oppose this proposal by the Grand Junction. I just wish we could get back to the day when pubs closed at 11 o'clock and we were all able to get some rest.

Re: The Grand Junction, 13 The High Street, Buckingham.

I protested at the first application made by this public house for extended hours plus a licence for music, and my objections for this renewed application are even more emphatic.

Nature of proposed variation.

- (1) I am against longer opening hours, especially if these include music. because this will mean even later noise after closing time when those leaving are shouting to each other in loud voices till well after the doors have been shut.
- (2) I feel very strongly opposed to any music outside. I note that should the licence for this be granted, the music will be audible only inside the building, but I do not see that this would be possible.
- (3) I feel slightly mean in opposing this request, but this year Christmas Day falls on a Tuesday so that if granted, this means we shall have noisy nights on the previous Friday, Saturday, possibly Sunday, Monday and Tuesday and this will also apply to the days round New Year. Now that smoking is banned in pubs, smokers go outside for a fag and, therefore, there will be more noise on the street during these long hours.
- (4) (5) (6) (7) I oppose the removal of any of these conditions.
- (8) I would certainly not oppose this application.
- (9) provided there is no extension of noise I would agree with this.

As you will gather from the above, my chief concern is for noise level of both music and the shrieks and yells that can take place between 11.30 till well after closing time. The north side of the High Street is largely residential and we do like to entertain our own friends and it is embarrassing when, if they are staying over night, they hear loud voices and music coming from the Grand Junction — especially the loud bellows that can come during the last few minutes before the music stops. I would add that on warm nights it would be nice to be able to open our bedroom windows. Sometimes we have to choose between being stifled and trying to get to sleep, or being kept awake by noise, and we would like to be able to sit in our gardens, but over Fridays and Saturdays that is impossible — noise again — and not everybody has the same taste in music!!!!

REF: VARIATION OF PREMISES LICENCE, GRAND JUNCTION HOTEL 13 HIGH STREET, BUCKINGHAM

At the interim meeting of the Council held on Monday 5th November 2007, Members discussed these proposals at some length, noting that the conditions in section P, which were the only ones to be retained, were not currently adhered to by the management or enforced by the Authority. It was also felt that extending the hours for one public house would lead to other premises lodging similar applications. Concerns were also expressed that the nature of the late night refreshment was not described: if this were to be meals rather than snacks 'eating-up time' would have to be allowed for, even if no further drinks could be served, and the closing time and concomitant noise and disturbance for residents advanced into the following morning. On the matter of recorded music outside the premises, Members felt that enforcement of the condition that the music not be audible outside the garden would be untenable.

Christmas Eve should be treated differently to New Year's Eve; whereas extended hours for the latter might be acceptable, Members felt that the former did not merit exceptional treatment, and would have liked to see extensions for each date applied for separately.

No objections were raised to the proposed indoor sporting events.

Members decided that this Council would oppose the entire application and ask for individual extension applications for Christmas Eve and New Year's Eve. It was also felt that adherence to the existing conditions should be demonstrated by the management before any variation could be contemplated.
