

This is a development site for which no rateable value has been fixed referable to the proposed development in respect of which this application relates and in respect of which building works have yet to commence - as such a Band A fee would appear to be payable.

It is intended that the proposed premises will operate as a food led pub restaurant and hotel under the Premier Inn and Beefeater brands. The food led pub restaurant will be housed in a separate building from the Premier Inn and will be laid out as is usual for a development of this type at ground floor level.

The separate Premier Inn hotel accommodation block will have a secure entrance lobby with hotel reception at ground floor level. The bedrooms (which will be unlicensed) will comprise in all some 82 rooms over 3 floors. On site car parking will be provided.

The details of the development are shown on the drawings identified below, deposited with this application.

A Licensed Premises Notification will be given for 2 gaming machines under the Gambling Act 2005.

It is proposed that the permitted hours for Ilcensable activities for these premises should be :-

Monday to Sunday: 10:00-00:30 inclusive with the premises closing to the general public 30 minutes thereafter. However, the premises will remain open 24 hours a day to hotel residents.

This application seeks to licence the premises specifically to authorise under the Licensing Act 2003 the following activities:

- Occasional regulated entertainment comprising: Live music and amplified voice, recorded music by music systems and similar forms of entertainment - limited to 15 occasions a year
- The sale of alcohol and such regulated entertainment as specified in the appropriate boxes below.
