MINUTES OF THE MEETING OF THE BUCKINGHAMSHIRE LOCAL ACCESS FORUM HELD ON WEDNESDAY 7 NOVEMBER 2018, IN COUNTY HALL, AYLESBURY, COMMENCING AT 10.00 AM AND CONCLUDING AT 11.46 AM.

OTHERS PRESENT

1. APOLOGIES FOR ABSENCE

Apologies were received from Mr A Clark, Mr B Chapple, Ms S Bayne and Mr N Harris.

Two visitors were welcomed to the meeting.

- Ms Helen Hall, Programme Manager, HS2 AONB Review Group, Chilterns Conservation Board, had been looking to allocate £3m environmental mitigation from HS2 along a 3km corridor either side of the new railway through the Chilterns, including improvements to access and recreation and wanted to meet members.
- Mr Paul Harris, Access Strategy and Development Officer, Oxfordshire County Council, Secretary of the Oxfordshire Local Access Forum and Member of the Wiltshire Local Access Forum was in attendance to observe.

2. DECLARATIONS OF INTEREST

There were none.

3. ACTION NOTES / MATTERS ARISING

RESOLVED: The minutes of the meeting held on 25 July 2018 were AGREED as an accurate record and were signed by the Chairman.

4. RIGHTS OF WAY IMPROVEMENT PLAN 2008-18 REVIEW

The background on reviewing the Rights of Way Improvement Plan (ROWIP) was provided by Mr J Clark, Strategic Access Officer, as follows:

- Mrs S Bayne, a consultant, had been undertaking ROWIP work.
- The review for the ROWIP consultation had started and would be completed by December 2018, ready for sign-off by the Cabinet Member Mr Chapple.
- The proposed timetable had slipped due to Mrs S Bayne starting later than planned, but consultation on the new Plan would start early 2019.
- Mrs C Hudson stated that the Plan would be finished in January 2020, condensed a little from the original target of April 2020.
- Mr J Clark stated the council would be 1-year without a Plan.
- Mr Clark confirmed the government had proposed a single Unitary Council for Buckinghamshire, with a new Chief Executive and Senior Management Team likely to be in place by early 2019. The May 2019 District Council elections were likely to be delayed until May 2020.
- Mr J Clark hoped the Local Access Forum (LAF) would have the opportunity to voice any concerns on the shape of the new council to ensure that there was a continuous rights of way service to the public in the new authority.

A member discussion session followed, structured around the objectives of Chapters 5 and 7 and aiming to inform the ongoing ROWIP review. A written summary would be presented in the papers of the 20th March 2019 meeting.

ACTION: Mr J Clark

RESOLVED: Members of the forum NOTED the report.

A minutes silence was held in honour of Sir John Johnson, ex-Chairman of the Chilterns Conservation Board, champion of the countryside who had a long association with promoting walking and recreation, who had died recently.

5. **RIGHTS OF WAY GROUP REPORT**

The Rights of Way Group report was presented to the forum by Mrs C Hudson, Definitive Map and Land Charges Team Lead and Mr J Clark, Strategic Access Officer.

Mrs Hudson noted item number 20 at Berkhamstead, a Definitive Map Modification Orders (DMMO) for a public bridleway and one of Ms A Heath's applications, was being moved up to number 7 on the list of investigations as it was now supported by user evidence.

The Chairman questioned the 4-year backlog. Mrs Hudson stated that was probably about right. Ms Hudson stated that they had recruited to another Definitive Map Officer post, so there would be three officers plus a senior officer and Team Leader working on all Public Path Orders (PPOs) and Definitive Map Modification Orders (DMMO's). This would ensure quicker completion.

East West Rail

Mr Clark gave an update on East West Rail. The Transport and Works Act order to build the scheme was submitted to government in July 2018. There were some enabling works starting early next year, such as access routes and environmental mitigation. The Council had registered a number of objections which would be heard at a public inquiry in early 2019. Construction would take place between 2020 and 2024.

<u>HS2</u>

Mr Clark gave an update on HS2. Environmental mitigation and moving utilities continued, with the next project being around Quainton and Grendon Underwood, where national grid would move electricity pylons. Mr D Briggs questioned the length of closure. Mr Clark clarified they would be much shorter than 18 months, but needed to be that long to account for contingencies. Mr Clark also highlighted that members of the forum might be aware of the Great Missenden Haul Road which had uncovered important archaeological remains.

Oxford to Cambridge Expressway

Mr Clark gave an update on the Oxford to Cambridge Expressway: a Highways England promoted motorway proposal between the two towns to support 1m new homes. The Council were invited to comment on possible route options, but it was unlikely rights of way would shape or impact on the final route choice. Mr Clark stated however that if the motorway did follow the East West Rail corridor it would provide opportunities for a multi-user route between Oxford and Milton Keynes, running through Buckinghamshire that could link to railway stations and improve people's travel choices. The Council's baseline requirements were set out in the reports included in the agenda as well as Highways England's plan outlining their preferred route, corridors B1 and B3.

Mr P Harris stated from Oxfordshire's perspective that the Council was very concerned about the proposal in the B corridor which would use the A34, because it was already past capacity and the Council thought it should go to the south-east of Oxford. He said there was a document by the Infrastructure Commission entitled: 'A New Deal for the Cambridge, Milton Keynes and Oxford Arc', and he would circulate a link to the forum.

ACTION: Mr J Clark

Mr Clark stated the Council's position supported a route nearer to Aylesbury, but Highways England rejected that proposal. A member of the forum asked where the new houses were going. Mr J Clark stated that he was unsure, however thought that it would likely be around Bicester and Milton Keynes.

A member of the forum asked if there would be money to mitigate problems that arise from where the road cuts across rights of way and opportunities to improve routes, especially across county boundaries. Mr Clark confirmed there would be ROW mitigation and opportunities for improvements.

Mr Clark stated there had been a meeting of the Chiltern Society's Rights of Way Group along with some of the maintenance volunteers. It was an annual meeting to look at working practices and how the volunteers could work better together. The meeting would take place at the Full Moon Pub at 10am on Friday 30 November 2018; and members of the forum were invited to attend.

RESOLVED: The members of the forum NOTED the report.

6. LAF MEMBERS' REPORT

The LAF Members' report was presented to the forum by Mr J Clark.

The following updates were highlighted:

The Slough Local Access Forum site meeting took place which Bucks LAF members were invited to attend. The meeting looked at a possible multi-user bridge between Black Park and Langley Park. No members were able to attend, but feedback was provided by Mr A Fowler, Head of County Parks. He had helpfully sketched a bridge for the papers, but suggested a bridge was likely to be prohibitively expensive, having to span four lanes of traffic and complicated by the fact Langley was a Grade II listed historic landscape. The Chairman raised his concern and asked why had Slough met in Bucks and who would pay for a bridge. Mr Clark explained many Slough residents accessed both Bucks Country Parks so they had an interest. A new bridge would likely be funded by any Slough growth into South Bucks, which had its own political sensitivities.

- There was a BBQ held at Black Park, attended by LAF Members Mr G Caspersz, Mr A Clark and Mrs Heath and hosted by LAF Member and Cabinet Member Mr B Chapple, to thank volunteers for their work in the county. Mr G Caspersz confirmed it was an excellent event, with opportunities to network and the park was well worth a visit. The Chairman suggested better notice would improve attendance next year.
- The National Land Access Centre had been launched by Natural England opened by Lord Blencathra at Aston Rowan, and attended by LAF Members, Mr Caspersz and Mr A Clark. A written guide was included in the appendix for members to visit at their leisure. All gates had been numbered and follow a set 'course'.
- Mr Caspersz asked if it was council policy to buy gates from only one supplier; how much was spent on gates per year; and what restricted the council installing more gates. Mr Clark confirmed there was no set policy, but the company Centrewire Ltd were the leaders in gate design and delivered good value for money. However, their delivery time was slow. Centrewire gates were installed at the National Land Access Centre. The council spent around £20,000 to £25,000 per year on gates. The restriction on installations was officer time agreeing gate locations with landowners and undertaking utility searches, then having a workforce available to install the gates. However, the ramblers 'RIPPLE' volunteers did a great job installing one gate per week in North Bucks.

A member asked about different ways of funding new gates mentioned at the last meeting. Mr Clark confirmed the Donate-a-Gate Scheme in the south was very successful as was the North Bucks Donate-a-Gate Scheme run by RIPPLE, with both combining to contribute around £10,000 per year in private funding. It was confirmed Mr Caspersz was actually referring to new Government Legislation, post-Brexit, funding access, on the basis of landowners providing new or improved access, with rural payments made to reflect the public benefit. It was confirmed this was just a proposal at present.

RESOLVED: Members of the forum NOTED the report.

7. ANY OTHER BUSINESS

Ridgeway Delivery Group report was presented by Mr B Worrell, Rights of Way Officer. Mr Worrell highlighted the following:

- Chiltern Gates Project continued successfully, with 18 new gates installed which include five in Buckinghamshire.
- Signage upgrade continued.
- The next Strategic Links would be Tring, Watlington and Princes Risborough.
- The promoted routes spreadsheet was to be re-circulated for comment as there were some routes under discussion to take off and some to be put on.

ACTION: Mr J Clark

- Ms S Wright, Project Officer would discuss HS2 with Mr J Clark to ensure a joined-up approach to improvements.
- The draft paper entitled 'Driving on the Ridgeway' was nearing completion and would be available for comment. It would include a list of Traffic Regulation Orders TROs for review.

Having opened on 28th January 2019 and continuing until 31st March 2019, the 'information gathering' phase of ROWIP 2 is underway. All responses will be collated and reviewed up to 31st August 2019, after which a draft ROWIP 2 will be written. A further public consultation will be held between September and November 2019 to invite comments on the proposed plan.

At 25th February 2019, a summary of engagement activities are as follows:

- All **parish councils** have received a letter and have been invited to fill in a survey, with 32 of 173 having responded;
- All **Local Area Forums** will receive a briefing presented by Buckinghamshire County Council staff;
- A range of **organisations** have received letters inviting their views (see next page), with the option to complete a stakeholder survey. Some of these have been offered the opportunity to meet;
- A public survey has been posted online. Buckinghamshire communications and web teams have been further promoting through social media and all organisations receiving letters have been invited to circulate the link. The response rate has been extremely high, with 1,100 responses. The survey closes on 31st March 2019 and the web link is: https://www.surveymonkey.co.uk/r/Bucks_CC_ROWIP
- A range of **focus groups** are being arranged for early April 2019 to engage with sectors of the community who are not 'usual' public rights of way users. The focus group exercise aims to engage with those with disabilities, health issues, people from ethnic and minority groups and those living in new communities. Several prospective organisations have been suggested by health and community engagement officers at Buckinghamshire County Council. Those who are not invited to the focus groups will receive a letter to invite their views.

The results of the engagement exercise will help to inform priorities and opportunities for inclusion in ROWIP 2. The results will be reported to the LAF at the extraordinary meeting on 21st May 2019 after which members can draw conclusions discuss their priorities for ROWIP 2. A report of the review of ROWIP 1 will also be shared with the LAF. Further details of the agenda of the extraordinary LAF meeting will be forwarded prior to the meeting.

Ridgeway Riding Route

The Ridgeway Partnership hope to make it possible for cyclists and horse riders to connect between Goring on Thames and Ivinghoe Beacon. Cycling UK and the British Horse Society are working with the National Trail Officer to create a Ridgeway Riding Route and volunteers are gearing-up to start surveys.

The Buckinghamshire Local Access Forum members are invited to provide their thoughts and comments.

Circular Routes Vision

A vision document (APPENDIX 1) has been drafted on circular and linear walks and rides that connect with The Ridgeway. This vision aims to set out how the demand for shorter, day walks and rides can be met, alongside the long distance walking and riding provided on the Ridgeway.

In the attached vision, there is a draft list of Ridgeway landmarks and highlights that visitors may be interested to discover whilst using the Trail – these have been linked to the Ridgeway's 5 themes (ancient, natural, creative, living, sporting), with the idea being that the circular walks and rides could include the best of these attractions and so open up the area for people to explore the trail corridor.

Vision for Ridgeway circular and linear routes promoted by The Ridgeway Partnership

We aspire to offer a set of circular and linear walks and rides which:

- 1. Provide opportunities for all Ridgeway user groups walkers, cyclists, horse riders.
- 2. Offers experiences for the full range of abilities within these user groups, from easy/introductory to moderate to difficult/challenging. However, since a National Trail is pitched as being an 'introduction' to long distance walking/riding and since as many people as possible are invited to enjoy Trails, the main focus should be upon easy to moderate. This applies to The Ridgeway in terms of distance, complexity of navigation, distance from services/remoteness, gradient and surface condition. See table below.

- 3. There should be at least one walk and one ride in the Chilterns and in the North Wessex Downs AONB which could be considered 'easy access', i.e. family friendly, accessible to disabled people using trampers.
- 4. Inspires people to visit The Ridgeway and try areas they have not visited before.
- 5. Provides positive visitor experiences throughout the year.
- 6. Is convenient to travel to, e.g. train station, car parking.
- 7. Promotes good quality and distinctive local businesses.
- 8. Encourages sustainable and responsible behaviour.
- 9. Meet or are close to meeting ? National Trail standards in terms of the quality of the signage, structures and surfaces.
- 10. Strengthens The Ridgeway and National Trail brand, including the website.
- 11. Recognises the assistance of partners and volunteers in the maintenance of the routes.
- 12. Celebrates the highlights/landmarks on and very near The Ridgeway, giving people positive experiences of these features. These features do not necessarily have to be well-known but they must be special. Together these features must convey the full 'story' and local distinctiveness of the Trail in terms of range of natural and cultural heritage, local communities, great local services, sporting challenge etc. They have been grouped into first and second tier and their attributes linked to the Partnership's 5 themes see following table.

DEFINITIVE MAP TEAM – Outstanding Caseload

A. MATTERS PREVIOUSLY DETERMINED BY COMMITTEE

- 1. Great Missenden application to record route across Widmer Field. Application dated 10 October 2014. The Order was advertised and objections received; the Order and objections will be referred to the Secretary of State for determination. Awaiting permission from one of the landowners to allow an Inspector access to the land to walk the Order route.
- Denham application to upgrade Shire Lane from bridleway to restricted byway. Application dated 23 January 2016. Order made and advertised, objections received. Awaiting response from Objector. If objection not withdrawn the Order will be sent off.
- Chenies, Chalfont St Peter, Denham application to record Shire Lane as part restricted byway and part byway open to all traffic. Application dated 14 March 2016. Connected with No.2 above. Order made and advertised, objections received.
- 4. Great and Little Kimble and Ellesborough Prohibition Order along BOAT Nos. 40, 40A and 62. Draft Order advertised, objections received and under consideration. Second report presented to Committee 26 February 2019. Committee agreed to implement an all year round Prohibition Order preventing access for motor vehicles. Motorcycles and quadbikes to be permitted 12 months of the year but must apply for a yearly permit to use the byway. The Prohibition Order will be reviewed after 12 months.
- 5. **Hedgerley** application to upgrade public footpath No. 14 to public bridleway status based on historical evidence. **Application dated 5 December 2013. Application accepted by Committee. An Order will be made and advertised.**

B. DEFINITIVE MAP APPLICATIONS TO BE INVESTIGATED AND REPORTED TO COMMITTEE.

E. STRATEGIC ACCESS UPDATE (JONATHAN CLARK)

32. HS2: at present there is little disruption to the rights of way network as a result of HS2 construction, with contractors allowing for minor diversions while temporary utility, fencing, archaeology and ecology works are undertaken. Any closures or diversions are advertised on the council's website at the following location, where a link can be found named 'HS2 Construction Closures and Diversions' with maps enclosed.

33. We continue to process applications under Schedule 4, Part 2 of the HS2 Act 2017 to grant permission for HS2 related works and attend monthly meetings with HS2 and their contractors as part of the Traffic Liaison Group. Denham Bridleway 3 alongside the M25 near Maple Cross (Chalfont Lane) remains the only route fully closed (estimated 7 years) in order to construct the Chilterns tunnel portal. Contractors have shared with us preliminary bridge designs for rights of way crossings and we have made early representations regarding surface construction

and legally recorded widths. We have also had our first meeting with HS2 contractor Eiffarge Kier to discuss detailed bridge designs between Chesham Road, Great Missenden and Bowood Lane, Wendover.

- 34. Bilateral meetings are scheduled with Heathrow Airport Ltd throughout 2019 with regard to the 3rd Runway and associated development. We have suggested strategic connections from Heathrow to Iver, Black Park, Pinewood Studios and Slough. So far only proposals within the development's red line have been made (i.e. outside Buckinghamshire), but the council are lobbying for wider 'Blue' (flood storage) and Green Infrastructure improvements.
- 35. District Council planning consultations continue apace, with the number affecting rights of way remaining high, for example, 63 responses were made in January 2019, mainly to AVDC. Major development areas include the site named 'Land West Aylesbury', situated along the 'infill' between Ellen Road, Aylesbury and HS2, to include a new link road with the A418. Outline applications have also been submitted north-west of the railway line in Princes Risborough as part of the town's planned growth. This will potentially involve around 4 crossings being closed and diverted or provided with a bridge or underpass.
- 36. The Chilterns Donate-a-Gate scheme has had 30 new donors in 2019 totalling 55 gates. The Ramblers Donate-a-Gate project through RIPPLE's (North Bucks) continues to provide significant funds to purchase new gates.

F. ROW OPERATIONS UPDATE (Joanne Taylor)

- The current staff structure is 6 FTE staff: I RoW Team Leader, 2 Area RoW Officers, 2 Assistant RoW Officers and 1 Bridge Structure Inspector. The bridge inspection officer is currently on maternity leave, but is set to return in Mid-May.
- 38. APPENDIX 1 shows the Rights of Way Operations output from 1st April 2016 to the 31st March 2018, and it includes a break-down of works undertaken by volunteers. A third column has been added including work completed up to the end of December 2018.
- 39. Capital projects update:
 - Iver bridleway no 30 bridge replacement; Completed
 - Chesham FP107 bridge renovation; Work underway, additional work Id'ed
 - Great Missenden FP33 A413 bank steps; Completed
 - Bledlow BW59 surface works; Project on hold Clearance undertaken
 - Thames Path Marlow 1 Surface/Bank stabilisation Completed
 - Stewkley FP2/2 surface and drainage works Completed
 - Great Marlow BW52 Gullied surface repairs Completed
 - Ivinghoe FP37 Bridge replacement Ordered commence March
 - Ellesborough BW51 surface works. Completed
 - Hillesden BW11A stabiliser badger setts Completed
 - Fawley FP12 Bridge Replacement Ordered commence March
 - 42 Extra capital money was acquired for works to be carried out in this financial year on Hillesden Bridleway 11A, Great Marlow BW52, Ivinghoe FP37 and Fawley FP12. This will reduce the amount of money available for capital projects for next year 2019/20 by the equivalent amount of overspend in 2018/19.

- 43 Wexham BW21 improvements have been put on hold due to a possible County Council planning application to carry out major groundworks on the site.
- 44 The County Council commissioned additional works crews for clearance over the summer which enabled the RoW north Gang to carry out important bridge repairs and replacements, with 64 bridges completed so far this financial year. However there are now 84 bridges awaiting repair or replacement, a slight increase over the year.
- 45 Launch of the new Rights of Way online reporting tool CAMs Web has been set back several months due to 'accessibility' compliance. However, testing is in the final stages and hopefully it will be due to go live shortly.

The main role of the LAF is to provide independent strategic oversight of public access in the county, but the LAF has volunteered to become involved in a number of specific projects as outlined below. Combined, these have has a positive outcome for public access.

The LAF successfully lobbied the county council in support of expenditure to purchase CAMS Web, a database and mapping system which aims to improve upon the public's experience reporting issues. It also aids disabled users planning trips and helps council officers with their day to day workload management.

Two LAF members led walks at the spring and autumn Chilterns Walking Festival, including a disabled ramble along the Grand Union Canal.

The LAF reviewed and comment upon two council strategies: 1) prioritising Definitive Map Modification Orders and Public Path Orders; and 2) the council's Rights of Way Planning Advice.

A LAF member provided help in editing the 2nd Edition of Rights of Way Restoring the Record, by Sarah Bucks & Phil Wadey.

The LAF regularly hear regular updates, monitor and provide advice on the work of the council's Definitive Map, Maintenance and Strategic Access teams and how this should be prioritised.
