# Summary

In April 2004 the Local Authority published a Statutory Notice and held a public consultation stating that from September 2007 Furze Down School would change from being a 5-19 special school to become an 11-19 aged special school. The proposed change was linked to the creation of a Complex Primary Special School in Aylesbury

However it subsequently became clear that there was a need for a 5-19 aged community special school providing specialist provision to be retained in the north of Buckinghamshire. Buckinghamshire County Council and Furze Down governing body therefore consulted on a proposal to reverse the Statutory Notice published in April 2004 and to instead allow the school to remain as a 5-19 aged community special school

## Recommendation

That the Cabinet Member for Achievement and Learning takes a decision to agree to Furze Down Community Special School remaining as an all-age community special school so that it does not change on 1 September 2007 to become a secondary special school

## A. Narrative setting out the reasons for the decision

In April and May 2007 the Local Authority in partnership with the governing body of the school undertook a public consultation that:-

The school should retain its status as an all-age community special school serving mainly the North Buckinghamshire community and provide education for children from 5 years of age through to 19 years of age with a range of difficulties including, cognition and learning, communication and interaction, physical and sensory and behaviour, emotional and social difficulties.

Furze Down intends to seek specialist status in the "Communication and Interaction" strand, catering for students with speech and language delay, impairments or disorders and specific learning difficulties. Some students, in addition, will have needs on the autistic spectrum and/or moderate to severe learning difficulties. Their communication needs are diverse and complex and they will include students for whom language and communication difficulties are compounded by sensory and physical impairment. There will be some students who will present challenging behaviour and others who will experience mental health difficulties at some time in their school careers.

Furze Down School would not therefore become a 11-19 secondary special school but would remain as a 5-19 special school

A consultation document was distributed to parents, staff, the local community and other partners. 42 responses were received and of these 41 or 98% were in favour of the proposal and 1 or 2% were against. A statutory notice was also published at the same time and no objections were received to the statutory notice.

There was therefore overwhelming support for the proposal put forward by Buckinghamshire County Council and the governing body.

## B. Other options available, and their pros and cons

Other alternatives were considered however the school has the staffing structure in place to educate and support the children at the school now and those that will be attending in the future.

One of the factors in leaving the school as an all-age community special school was that it meant that children from the north of Buckinghamshire would not have to travel down to Aylesbury or even further to attend school, thus reducing travel times, the potential stress on children and costs

## C. Resource implications

There are no immediate resource implications for the County Council and the school's budget is based on the anticipated number of children in the age-

range 5-19 years and there are therefore no resource implications for the school from the proposal.

Having a community all-age special school in the north of Buckinghamshire reduces the potential transport costs as children from the north of the county will not have to be transported long distances at considerable cost. There are obvious environmental benefits as well in reducing travelling distances.
