# ANTI-BULLYING STRATEGY FOR SCHOOLS

2006 - 2009

#### MISSION STATEMENT

"Buckinghamshire County Council will not tolerate bullying of any kind and expects schools to take action and work in partnership to ensure that all children and young people in Buckinghamshire's schools are safe from bullying."

#### **PRINCIPLES**

The Anti-Bullying Strategy for Schools is underpinned by a set of guiding principles:

- Everyone has the right to live in an atmosphere free from, victimisation, discrimination harassment and any other form of bullying behaviours.
- Everyone has the responsibility to promote care, respect and co-operation in their relationships.
- Everyone has the responsibility to value diversity in order to create and maintain safe and supportive environments, including schools, for children and young people.

#### WHAT IS BULLYING?

#### **Bullying**

- is hurtful, threatening, harmful and disrespectful behaviours. Bullying incidents involve a bully or bullies, a victim or victims and bystanders.
- can include behaviours, which hurt, threaten or frighten another person or group of people.
- can be unprovoked, can happen again and again and sometimes can continue for a long period of time.
- is hidden and often victims to not tell about their experience for complex reasons.
- reflects the misuse of power with one or more people victimised by the bully or bullies.

Bullying behaviours can include physical, social and psychological aspects such as:

- name-calling, taunting, mocking, making offensive comments,
- kicking, hitting, pushing, fighting
- taking or damaging belongings, stealing money with threats
- text messaging, emailing, chat-room insults (cyber-bullying)
- gossiping, spreading hurtful and untruthful rumours,
- socially excluding people from groups, e.g. not talking to them, excluding them from activities.

Bullying is harmful to all involved, not just the bullied, and can result in long-term outcomes of self-doubt, lack of confidence, low self-esteem, depression, anxiety, self-harm and in extreme cases serious mental health concerns and even suicide.

There are other types of negative behaviour, which are sometimes mistaken for bullying. These often take place in the open and do not involve an imbalance of power such as when two individuals or groups get into an argument, which may escalate to a fight. Schools must deal with such conflicts in a fair and transparent way. It is important that schools recognise the difference between conflict and bullying, which is typically surrounded by a complex web of deceit and power misuse.

#### OPERATIONAL STRANDS

The guiding principles outlined above will support the implementation of six operational strands of the Anti-Bullying Strategy for Schools:

- 1. Encourage effective practice
- 2. Support effective school leadership and management
- 3. Engage children and young people
- 4. Promote effective partnerships with parents/carers and families as well as other agencies
- 5. Publicity and information
- 6. Performance Indicators

Children and young people identify bullying as a real issue of concern, both in schools and the wider community. This strategy focuses on bullying in

schools and the intention is that it will be used as a basis for wider action to address bullying with partners in the community.

The Anti-Bullying Strategy for Schools is directly linked to a range of existing policy agendas:

- Every Child Matters outcome to promote the safety and well-being of all children and young people
- National Educational Strategies, such as Behaviour and Attendance Strategy
- School-based strategies, for example, those linked with the National Healthy Schools Programme
- SEN and Inclusion Strategy and subsequent Implementation plan
- Children and Young Peoples' Participation Group as a sub-group of the Children and Young Peoples' Strategic Partnership
- Race Equality Schemes and Community Cohesion Strategy
- Community Safety Strategy
- Local Area Agreements

The Buckinghamshire County Council Anti-Bullying Strategy for Schools outlines key aspirations for the next three years 2006 - 2009. The strategy is intended to create schools, which are safe from bullying, by building the capacity of schools to address and take action against bullying

#### **Strand 1: Encourage effective practice**

A wealth of experience and innovative work already exists across the county's schools to prevent and respond to incidents of bullying.

Encouraging effective practice in schools will be achieved by:-

- ensuring schools' anti-bullying policies are regularly reviewed and integrated with their existing policies and procedures
- capturing effective practice and encouraging sharing
- measuring and recognising progress in a school through the Schools'
   Self-Evaluation Toolkit (SSET) and Ofsted Self-Evaluation Form (SEF)
- identifying effective practice through OfSTED reports
- promoting and encouraging schools to meet Buckinghamshire Healthy Schools standards
- disseminating information and effective practice guidance
- developing professional training packages for effective prevention strategies and responses to bullying
- conducting an annual audit of bullying incidents
- monitoring of prevalence of bullying
- establishing a BCC Anti-Bullying website with local and national links and casework examples of good practice
- regular reporting to the Children and Young People's Participation
   Group

- Annual Anti-Bullying partnership conference, to take place in May/June, will be established in Buckinghamshire
- Schools will be aware of local initiatives in National Anti-Bullying Week (November)
- Effective practice guidance will be updated, shared and disseminated
- School Governing Bodies will monitor preventative strategies and responses to bullying incidents in schools
- BCC Anti-Bullying Strategy for Schools will be implemented and reviewed annually through reports to the Local Safeguarding Board.

#### Strand 2: Support school leadership and management.

Buckinghamshire County Council believes that effective, strong and consistent leadership and management of school communities provide the essential basis for achieving all the Every Child Matters outcomes. The governing body, head teacher and senior management of a school will be supported to promote, across the entire school community, a set of shared principles, values, rights and responsibilities. These include a school culture or ethos, in which positive, respectful relationships between everyone are encouraged, bullying is neither accepted nor tolerated and action is taken if and when bullying incidents occur. A central component to this is a commitment to continuing learning and professional development.

Support of school leadership and management will be achieved by:

- auditing training needs for governors, schools and parents/carers
- reviewing and updating training and development programmes for school communities
- publishing training and development programme
- establishing a nominated school governor and lead professional to review and monitor a school's bullying policy and practice
- collating and disseminating effective practice guidance

Policies can draw on National and local guidance documents including:

- School Self-Evaluation Toolkit
- Curriculum guidance for the Foundation Stage
- Primary Behaviour and Attendance Strategy
- Emotional literacy and Key Stage 3 Behaviour and Attendance Strategy
- Personal, Social Health Education (PHSE) /Citizenship curriculum
- National Healthy Schools Programme
- SEN and Inclusion Strategy and Implementation Plan
- Primary and Secondary Inclusion Strategy.

#### By 2009

75% schools will achieve Healthy Schools Standards

- A programme of training and professional development programmes will be established, delivered and evaluated for a range of education staff working in and with schools, e.g. governors, County Council members, teaching and non-teaching staff, support services
- Guidance and examples of effective practice will be available for schools

#### Strand 3: Engage children and young people

Consulting children and young people and empowering their participation is a Government requirement and a high priority for Buckinghamshire County Council. This is reflected within the Anti-Bullying Strategy for Schools. Children and young people will play an instrumental role in shaping the Anti-Bullying Strategy for Schools. Enhancing the participation of children and young people in the development and implementation strategy is a key objective.

Participation with children and young people in anti-bullying work includes:-

- advising on the development of anti-bullying resources in a range of accessible formats, which are specific and relevant to the needs of children and young people
- encouraging children and young people as young ambassadors to promote the work undertaken as part of the implementation of the Anti-Bullying Strategy for Schools
- providing children and young peoples' perspectives of how to make schools safe from bullying, as well as their perspectives informing strategies and actions to address bullying.

- Children and young people will have made a contribution to the strategy and its implementation
- Children and young people will report a reduction in bullying behaviours in schools
- Children and young people will help evaluate interventions and resources

# Strand 4: Promote effective partnerships with parents/carers and families as well as other agencies

The Anti-Bullying Partnership Group will support the delivery and implementation of the Anti-Bullying Strategy for Schools. It will facilitate collaborative work and promote and implement an Anti-Bullying Strategy for the wider community.

The Anti-Bullying Partnership Group will promote a sense of shared values, purpose and goals, which are linked directly to the operational strands of the Anti- Bullying Strategy for Schools and the wider behaviour agenda in the community.

The Anti-Bullying Partnership Group will engage parents/carers with the strategy and its implementation emphasising their responsibilities in promoting shared principles, values and understanding of bullying and its negative impact on children and young people in schools and the wider community.

- Buckinghamshire Anti-Bullying Partnership Group will be established for the wider community
- Shared values, purposes and goals for partners will be established and published
- Wider range of interventions, resources and practices will be available for all partners including parents/carers
- Shared information and performance indicators will inform target setting in service planning
- Reported incidents of bullying will decrease
- Children and young people, particularly those who are vulnerable, will report they are safe from all forms of bullying at school and in the community
- Parents/carers will have clear guidance about how to report and respond to bullying

#### **Strand 5: Publicity and information**

Schools, children and young people and their parents/carers, and other agencies will receive up to date information about to how to report and respond to bullying incidents. Information about the progress of the Anti-Bullying Strategy for Schools and other local, regional and national anti-bullying initiatives and events will be reported, through a range of formats, e.g. local media releases, reports, newspaper articles, newsletters and websites.

- A range of guidance and advice about bullying will be available for schools, children and young people and parents/carers
- Children, young people, their parents/carers will have clear guidance and information about how to report and respond to bullying
- School communities will have clear guidance, information and development opportunities to respond effectively to bullying
- All schools will have embedded policies and procedures to reflect the BCC Anti-Bullying Strategy for Schools
- A BCC Anti-Bullying website will be established with links to national websites such as Childline, Kidscape and website visits monitored
- News and events will be communicated to schools using a range of media including 'SchoolBulletin'
- Effective practice will be shared regularly

#### **Strand 6: Performance Indicators**

A key priority of the Anti-Bullying Strategy for Schools will be the establishment of a clear and simple framework to report and record bullying incidents across the county's schools. This is important in order to respond effectively to the Every Child Matters inspection frameworks targets and indicators against which Buckinghamshire County Council's effectiveness in addressing bullying will be measured. The information gathered is essential so that we can work together to tackle the underlying causes of bullying, work preventatively and proactively as well as reacting in response to bullying incidents.

Performance Indicators are contained in various plans (Appendix A). In addition, information gathered from School OfSTED reports, Healthy Schools Standards, and other initiatives will give an overall picture of progress.

Central to the gathering of accurate baseline information will be the development of a simple, clear and consistent framework for recording and reporting incidents of bullying both in schools and the local community to inform future planning, evidencing effective contribution of services to improving anti-bullying outcomes for children and young people

- A framework for systematic information gathering from schools will be established and any trends identified
- Baseline established for prevalence on reported bullying in schools
- Targets set to reduce prevalence of bullying in schools based on baseline data
- Clear information about types of bullying and possible trends will be reported
- Annual report of reported bullying incidents in schools is communicated as required
- Information will be available for APA and JAR inspections

- Information gathering framework adopted by wider community partnerships
- Develop targets for reducing prevalence of bullying in the wider community

#### **Performance Indicators and Plans:**

Performance Indicators are in the following Statutory Plans:

BCC Corporate Plan:

Support all schools in addressing bullying, 100% of OfSTED reports indicating effective practice where support has been given.

• Local Area Agreement:

Medium Term Priority G

% of schools inspected which are judged to have taken action to reduce anti-social behaviour, such as bullying and racism

Medium Term Priority F

Number of incidents of bullying and racist incidents reported by schools (indicator to be developed - may be expected to increase at first)

- Children and Young People's Plan:
  - 1. % of 11-15 year olds who state they have been bullied in the last 12 months. The target for 2006/07 is 60% of schools returning information on bullying incidents, increasing to 90% in 2008/09.
  - 2. % of 10-19 year olds admitting to bullying another pupil in the last 12 months, the target being 60% of schools returning this information in 2006/7, increasing to 100% by 2007/8.

Please note that these targets may need to be revised in the light of national and local factors
