

THE BUCKINGHAMSHIRE COUNTY COUNCIL (WYCOMBE DISTRICT) (CONSOLIDATION) ORDER 2014 (AMENDMENT NO. 1020) ORDER 2019

Notice is hereby given that Buckinghamshire County Council proposes to make the above-named Order under the Road Traffic Regulation Act 1984. The effect of the Order is to introduce No Waiting At Any Time / No Loading At Any Time (double yellow line) at High Street and The Causeway; Introducing No Waiting At Any Time/No Loading At Any Time (double yellow line) on Pound Lane and Station Road. The proposals have been developed to achieve the required lines of sight in guidance with the health & safety guidelines of the proposed pedestrian crossing point on the High Street / The Causeway.

For facilitating the passage on the road or any other road of any class of traffic (including pedestrians).
The Causeway South of Burgers of Marlow	Conversion of two parking bays in The Causeway to 'No Waiting At Any Time/No Loading At Any Time (DYL's)'	
Pound Lane junction with High Street	'No Waiting At Any Time/No Loading At Any Time (DYL's)'	
Station Road junction with High Street/The Causeway	'No Waiting At Any Time/No Loading At Any Time (DYL's)'
