**BUCKINGHAMSHIRE COUNTY COUNCIL** (hereinafter referred to as "the Council") in exercise of the powers under Sections 84(1) (a) and (2) of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and having regard to Section 122 of the Act and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order: -

1. No person shall drive any motor vehicle at a speed exceeding 20 miles per hour on the length of road specified in the Schedule to this Order and shown for the purposes of identification on the plans attached this Order.

2. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.

3. This Order may be cited as "The Buckinghamshire County Council (Hag Hill Lane, Hag Hill Rise, Cavendish Close & Green Close) (20 mph Speed Limit) Order, 201" and shall come into operation on xxxxxxxx 201.
