Cabinet Member for Education and Skills - 20 Apr 2016

ED07.16 - Adult Learning Fees 2016-2017 (Decision taken)

The Cabinet Member AGREED that the proposed fees and concessions set out in the paper are adopted for the 2016-17 academic year

The Cabinet Member AGREED that the proposed waiting restrictions proposed for Bentinck Close, Bull Lane, Bulstrode Way, East Common, Layters Way & West Common be implemented as advertised

T06.16 - Proposed Parking Restrictions Various Roads - Marlow (Decision taken)
