PE02.16 - Definitive Map and Local Land Charges Team - charging review

The Cabinet Member:

- a) APPROVED the charging schedule for providing an enhanced/commercial service for providing environmental information pursuant to the Local Authorities (England)(Charges for Property Searches) Regulations 2008 (Appendix 1)
- b) APPROVED the charges for the enhanced service to be effective from 4 July 2016
- c) APPROVED the introduction of charges to private residents for Highway (adopted) Extent search requests and that no fee waiver is in place

- d) APPROVED the approach to be taken when receiving EIR 2004 requests and to keep this under review as to whether charges should be levied for this service or not
- e) APPROVED the decision to no longer accept payment by cheque for Con29R and O and Highway Extent searches
- f) AUTHORISED the Director Environment Services in consultation with the Cabinet Member to review and revise the policy one year after and at appropriate intervals thereafter.
