### **Cabinet Member for Children's Services and Cabinet Member for Education and Skills**

#### **CS02.16 - Children's Therapies Re-commissioning (Decision taken)**

The Cabinet Members AGREED:

- I. That Children and Young People's Speech and Language Therapy, Occupational Therapy and Physiotherapy services are tendered as a jointly commissioned single, integrated service, in partnership through a Section 75 pooled budget arrangement with the Buckinghamshire Clinical Commissioning Groups (CCGs).
- II. That the contract length is three years plus option to extend for two further years.
- III. That at the time of contract award, delegated authority for the decision of provider is given to the Managing Director, Children's Social Care and Learning.
- IV. To progress to full tender to enable seamless service delivery and the new contract to commence from April 2017.
