## Policy Framework 2016.17

- ✓ BCF intended to be the financial incentive to drive integration
- Bring budgets together and agree integrated spending plan
- 2015.16 allocation was £3.8bn rising to £3.9bn in 2016.17 nationally
- Establish a section 75 of the NHS ACT 2006 with one or more pooled budgets
- Requirement for Health and Wellbeing Boards to jointly agree plans for how the money will be spent and formal sign off by the CCGs.
- A requirement that the plans are approved by NHS England in consultation with the DH and DCLG

## National and local conditions

Plan submitted sets out how the following national conditions are met.

- Maintain provision of social care
- Delivery of 7 day services across health and social care
- Better sharing of data between health and social care based on NHS number
- Joined up approach to assessment and care planning and accountable professional
- Agreement around consequential impact on providers of the plan
- Agreement to invest in NHS commissioners out of hospital services which may include a wide range of services including social care
- Agreement on local action plan to reduce delayed transfer of care
