### 2019-20 Update

- The BCF 2019-20 plan has been submitted and has been through regional calibration. It is now with NHS England for formal approval in December 2019. This is a year long plan covering up to 31<sup>st</sup> March 2020.
- The Q2 return has been submitted. There was no Q1 reporting due to the delays in publishing the planning guidance.
- The current position for 2020-2021 is unknown as any announcements are on hold until after the general election. Policy guidance is expected in January 2020 at the earliest.

# Better Care Fund Performance July – September 2019

### Non-elective admissions (NEAs)

- The 2,807 target for Q2 was achieved with performance at 2,529
- The number of NEA is similar to Q2 last year the downward trend represents typical seasonal demand e.g. fewer falls, warmer weather
- There have been quarterly reductions in NEA since Q3 2018-19
- The system continues to support patients to have their care provided in the most effective setting




Quarterly NEA performance for Buckinghamshire, per 100,000 population

### **Admissions to care homes**

- The yearly admissions target of 400 is on track to be met
- Since April 2018 there has been an average increase of 11% in client's domiciliary care hours, which equates to almost a 1,000 more hours being commissioned each week. This indicates that clients with more complex needs are living in their own homes.


N.B there is movement in these figures due to backdating of records on the Adult Social Care IT system. The 2018/19 Q4 position moved by 16% but still met the end-of-year target

**Better Care Fund Performance – July to September 2019** 

### **Effectiveness of reablement\***

\*Data published annually

- The target for 2018-19 of 75% was not achieved but was an improvement on 2017-18 performance.
- The proportion of people who's independence has been improved by the BCC reablement service has been variable this year – October's performance was 52% which is above the 50% BCC target.
- A therapy based delivery model is being established for the BCC reablement service and a joint remit with Rapid Response Intermediate Care delivered by Bucks Healthcare Trust is currently being developed.

# **Delayed Transfers of Care (DTOC)**

### **Overall delays:**

- The total number of people delayed in hospital for Buckinghamshire in September was **1,486** compared to 1,643 in August
- This equates to an average of 49.5 people delayed in hospital per day in September therefore the target of 31.8 was not met
- BCF winter pressures funding has been focused on creating capacity to support timely discharge from hospital through additional domiciliary care and access to six intermediate care beds

# **Delayed Transfers of Care (DTOC)**

### **Delays attributable to Adult Social Care (ASC):**

- The number of patients delayed in hospital attributable to ASC has decreased from 222 August to 167 in September. This met the ASC target of 203 set by BCC.
- The most frequent reason for an ASC delay was reason E Care Package in Home, accounting for 95 days delayed (57%)
- Buckinghamshire NHS Trust contributed 68 days and Frimley Health NHS Foundation Trust contributed 40 days. Milton Keynes University hospital also contributed 41 days in September
