


Welcome from the Co-Chairs

CQuins - Lead Roles Register page 3


Nassrin Saeedi said that she had tried to contact the Behaviour Specialist listed on the Lead Roles Leaflet but could not make contact with anyone.

Bucks Connect

Liz Sheppard

Bucks Connect is a new on-line directory, for social service users and self funders, providing information and advice for Care and Support and Community Services such as groups, societies, organisations and events. It has replaced the "bucksinfo.net" website and will be launched on 20th April 2012.

Liz said that the website is for everyone to use and is a good way to find out what is going on in the local area.

Providers have been asked to register and keep their details up to date. Currently there are over 500 entries. It is a way for groups or organisations to advertise their service for free.

<u>Comments</u>

Jeremy said that he thought it was a really good idea. Liz was asked how people could access the information if they don't have a computer or know how to use the internet. She said that the directory has always been intended as an online service.

Published copies of the services provided would be out of date too quickly and too expensive to produce. If people needed to access the

information and had no access to a computer, they could speak with the In Touch team, telephone **0845 3708090** who would be able to signpost people to the relevant care providers, groups or organisations or they could go to a Bucks County Council library and have free internet access to the information.

With all the changes regarding Day Opportunities, people are needing more help with independent travel and will require travel training.

With reference to Health Checks, Ainsley had reported to the Health Action Group that Bucks need to improve on their numbers for people with a learning disability having a Health Check.

Health continued

Only 37 out of 59 surgeries had signed up to partake which makes Bucks below the national average. Ainsley had said that they need to find a way of getting back into the surgeries to raise awareness.

Ridgeway have produced a new Health Action Plan. It is a very colourful 37 page document but early feedback was that it will cause issues with print costs. This will be raised with Ridgeway as it could mean that the document will not be used.

Ainsley had asked members of the Health Action Group to submit a proposal for her to present to the Clinical Commissioning Board (CCB) to provide a piece of targeted work on Health Checks, Health Passports and GP training.



Executive Partnership Board Update Talkback


On 20th February the Executive Partnership Board (EPB) held its meeting at which the priority outcomes for each Partnership Board were to be presented.






Peter Bolton said:

"Autism is where someone struggles with new faces, they are more likely to keep themselves to themselves and need to get to know people before they will speak to them more easily."

Peter spoke of his son who is on the autistic



Ojalae thanked Peter for his explanation and said that he couldn't have explained it better himself.

Ojalae said that Buckinghamshire is developing its own Autism Action Plan to improve the health outcomes for adults with autism.

The Government's vision is that:

"All adults with autism are able to live fulfilling and rewarding lives within a society that accepts and understands them. They can get a diagnosis and access support if they need it, and they can depend on mainstream public services to them fairly as individuals, helping them make the most of their talents."

The guidance clearly describes what organisations need to do to work together.








There are 4 main areas:

- 1. A responsibility and challenge to increase awareness and improve training.
- 2. Look out how people in Bucks are diagnosed
 - currently not constant or clear
 - be clear about who to contact for support
- 3. Transition (from child to adult)
 - need to make sure both groups work together so as this is a smooth process
 - need to be clear about what they do
- 4. How to take it forward

Ojalae said that Bucks are developing a plan to improve the journey of people with autism. They will be running workshops for people with autism and carers. Dates will be circulated.













<u>Comments</u>

Polly Wilkinson said that some young people with autism are not eligible for social care but are in great need of support with employment etc. She asked if Bucks County Council would be addressing this.



Ojalae said that people should contact him if they would like to be part of the steering group.
