




Welcome from the Co-Chairs


Health Self Assessment Framework Ainsley MacDonnell - BCC/PCT

(See attached document Easy Read Report to LD HSAF 2012)

Ainsley explained that the Health Self Assessment Framework looks at the issues of keeping good health for people with a learning disability.



30 questions needed to be answered to see how Bucks are doing:



In the document colours are used to show how well Bucks have done:



The Services and Activites Health Action Group have seen and approved the full document. It has been sent to the Strategic Health Authority (SHA) for them to look through. Once this has been done they will come to a Partnership Board meeting or the Services and Activities Health Action Group to talk about the main areas which need to be worked on.



Health Self Assessment Framework continued Ainsley MacDonnell - BCC/PCT

The Health Action Group have added the 'red and amber' areas to their workplan for those areas to be worked on.

Bharti explained the document to members. She said it was to help Bucks improve things for people with a learning disability. She said the red areas (Level 1) are the biggest priority. One of these is improving Health Checks for people with a learning disability. Work will also be done on the amber areas (Level 2).





Bharti said that there are a lot of action points but there is also lots being done well.



Health Self Assessment Framework continued Ainsley MacDonnell - BCC/PCT

Comments

Nassrin said it would be a good idea to enrol relevant people to achieve the aims to get things done.

Ainsley said Health Checks were a big issue. People needed to be supported properly when they go for a Health Check.

A leaflet will be distributed in the New Year explaining how people can be supported when they go for a Health Check.

The Health Check document is a 30 page document which is complicated to fill in. The Community Nurses are looking at how they can make it more accessible for GP's to use.

Ainsley said that she thought that the situation would be different from April 2013 when the GP's will have to take on the responsibility for making sure people with a learning disability have a Health Check.











Health Self Assessment Framework continued Ainsley MacDonnell - BCC/PCT

Nassrin said that the NHS have started to send letters out to people to tell them about the "Summary Care Records".

They have been contacted to see if an accessible version is available as the Easy Read version is not suitable.



She said that there are 1.5 million people with a learning disability in the UK and very often these people are not properly considered when producing information material.

Members agreed that the Learning Disability Partnership Board should send a letter to the person leading on this in Bucks.

Action: Letter to be agreed by LDPB and sent to Bucks lead of the Summary Care Records team NS/FC (Talkback).






People's Working Groups

The People's Working groups have been meeting every two weeks. People with a learning disability have said that they have some issues with the following:

- For those in paid jobs, some of them are very busy and expected to cope unsupported under pressure.
- Reduced standards of care within some homes.
- Adjusting to the changes with Day Opportunities.
- Money understanding the changes ie. direct payments.
- Need to talk more about the changes, need more help to understand what is going on.

Action: Areas of concern will be forwarded to the relevant Service and Activity groups and Advocacy for Change. Outcomes will then be fed back to the Working Groups.

Health

The Services and Activities Health Group met on 11th September 2012.

The Health Path was completed and will be used in a positive way forward.

Continuation of the Health Passport is a high priority. The use of the Health Passport links in closely with people having effective Health Checks. There is no current funding to reproduce the Health Passports going forward. The Health Services and Activities Group are considering how this can best be resolved. A Health Passport Focus Day and Workshop has been planned for Tuesday 15th January 2013.


Dignity In Care

Dignity Action Day is being held on 1st February 2013 where these awards will be presented.





Keeping Safe - Safe Place Scheme

A Safe Place Scheme meeting was held at Aylesbury Vale District Council offices (AVDC), co-ordinated by Cath Marriot from Bucks County Council. It was attended by a team of people who are involved in making sure that people "keep safe". Nassrin and Sue attended on behalf of the Learning Disability Partnership Board.



The Learning Disability Partnership Board were not aware that there are already 2 Safe Place Schemes in Bucks. One of these is in Burnham and the other is about to begin in Chesham.

Sue and Nassrin prepared a 5 point action plan for businesses that sign up to the scheme.

They said that it would be better to have a logo that could be recognised nationally rather than each council having their own logo.

Nassrin spent a lot of time finding out if we could use the same logo that is being used in Slough. They are still waiting for a decision to be made.

This scheme is for everybody not just people with a learning disability. All the Partnership Boards need to get involved and help to promote this project.


Telecare or Assistive Technology is special equipment that helps people to live on their own and reduce risks.

Amy showed members a selection of equipment and how they work.



The equipment is set up in the home and lets other

people know if help is needed. In an emergency the team at the Telecare Monitoring Centre will get help and assistance arranged as soon as possible.

A Telecare Assessor will arrange to visit you in your home for an assessment.

There is a show flat in Downley and group visits can be arranged.

120,000 people in Bucks are using Telecare at present and the numbers are growing.

The equipment works really well to help people avoid crisis situations and gives people more choice and independence.
