

1	APPOINTMENT OF CHAIRMAN
	It was agreed that the Chairmanship would be shared on a meeting by meeting basis by the three County Councillors.

2	APPOINTMENT OF VICE CHAIRMAN
	It was agreed that John Gibbs from Wycombe District Council be Vice Chairman for the ensuing year.
3	APOLOGIES FOR ABSENCE/CHANGES IN MEMBERSHIP
	Apologies were received from Dennis Green, John Hughes, Miv Hughes, David Devine, John MacMillan and Bill Bendyshe-Brown.
4	DECLARATIONS OF INTEREST
	There were none.
5	FUTURE OF LOCALITY WORKING IN BUCKINGHAMSHIRE
	Members received the report, the purpose of which was to inform the LCP of the County Council Resolution made on 10 July 2008 regarding the reviewed GC2C Strategy. The Terms of Reference for the Local Area Forums and Local Community Partnerships were agreed at County Council on 10 July and a summary sheet was circulated at the LCP meeting.
	Wycombe Local Committee ceased meeting in July 2008 and a community engagement pilot is currently being undertaken, where there will be two levels of meetings. Downley, Disraeli, West Wycombe and Stokenchurch are piloting the Level 1 meetings which will be based on NAG areas. The Level 2 meetings are where the County Council will deliver its services in the future. and will consist of County, District, Town and Parish Councils.
	With regard to the terms of reference for the LCP, the following was agreed:

1

- The LCP will meet quarterly, meetings to commence at 7.00pm
- Where possible, the Parish Councils will host the meetings and provide refreshments. However, it was noted that not all Parish Councils run the village halls. Other facilities were offered by the RAF representative and Fire and Rescue representative.
- on the size of population and the make-up of the parish areas it was agreed that Hughenden Parish Council may send up to three representatives to the meeting and Princes Risborough Town Council may send up to three representatives. There will be one nominated representative from each of the other Parish Councils, although any number of members may attend the meetings. This could be reviewed in the future if necessary.
- Community Groups will attend as members of the public.
- Meetings will be advertised through posters, parish council newsletters and the press. It was agreed that a press release should be issued advertising the first meeting.
- Joint forum meetings can be held if a number of LCPs wished to work together on a particular issue.

The LCP meetings will identify local issues and contribute towards any decision-making. It was important to take into account parish plans when discussing issues.

The delegated budget for highway maintenance will continue. Previously, each Local Committee received £125,000 to carry out environmental improvement schemes. This will now be split between the LCP areas. PR LCP will receive £30,368.99. An assessment matrix will be used to score schemes which are submitted. These will then be brought to the LCP for consideration.

Members noted that the full budget could be used for a particular project if the LCP considered it was necessary. The District and Parish Councils could also add money to any scheme if they wished. However, in the case of parish council money, it could only be spent within their own parishes. Council Members may also wish to use their Community Leaders Funding. In time, it was expected that other services will work with LAF/LCPs in the same way as Transportation, both in terms of funding and devolved services. However, there was some uncertainty about whether the devolved funding would increase in future years, because of budget constraints and smaller government grant funding.

Members of the Local Community Partnership NOTED the report.

#### 7 ACTION LIST OF ITEMS OUTSTANDING FROM LAST MEETING

Members noted the responses to the actions from the last two meetings.

Other points of note:

- With regard to the 'Think!' signs, concern was expressed that not all the signs had been removed. However, it was noted that those signs that could be removed, had been. Members were informed that the County Council has a working party on street clutter. (Addendum: Subsequent to the meeting further information was obtained on this item. The County Council does not have a working party on street clutter. However, a Consultant has been asked to work on a Signing and Lining Policy. This will work as a prevention tool for the future to ensure extra signage is not erected. If there are concerns about signs in the Princes Risborough LCP Area and if 20 roads can be identified as being affected, then officers will investigate the situation and report back at a future LCP meeting.)
- In order to try and stop lorries going through Hughenden, traffic from High Wycombe was being
  given notification of unsuitable roads and roads where weight restrictions are in place. Sat Nav
  continues to be a problem in directing lorries through unsuitable areas. Marsh was another
  area of concern regarding signage and this was also being investigated.

• It was agreed that HGV Issues should be put on the Forward Plan.

Action: Ian Reed re Forward Plan

 Karen Adamson from Adult Social Care reported that the Surgery held on 16 July in Princes Risborough had been successful. The local PCSO had also attended and given advice on crime prevention. Joint working will also be taking place with the LATs and the Fire and Rescue Service in the future. The next Surgery will be held on 4 December between 10.00am and 1.00pm and posters advertising the Surgery will be sent to the Parish Clerks. The Fire Safety vehicle and the Mobile Library will be used to hold surgeries in rural areas.

#### 8 QUESTION TIME

A member reported on concern from residents regarding the NATS (National Air Traffic Services) consultation. The Chairman reported that the County Council had made representations and the Aylesbury Vale Local Area Committee had also held a special meeting where representatives from the London-Luton Airport Consultative Committee and the Civil Aircraft Authority had been invited. The Chilterns Conservation Board had also responded to the consultation.

Many members considered that aircraft were already flying at lower altitudes and it was suggested that members could look at monitoring aircraft noise and report back to a future meeting.

During discussion the following points were highlighted:-

- There was a leaflet on home fire safety checks and smoke alarms, which are provided free of charge.
- The poster on inconsiderate parking shows how some fire engines find it difficult to reach their destination because of poor car parking along narrow roads. The Fire Service had no enforcement powers and had to rely on the goodwill of the public. Parking over footways is also a problem. Although it is illegal to park on the pavement, parking on the road can block roads and the Police tend to assess the situation before taking any action. Jo will also provide A4 size leaflets for the Parish Councils.

Having informally discussed the petition with them, it is apparent that the collision and casualty record through Longwick is such that the criteria for a safety camera will not be met. In the last 3 years there have been 1 serious and 4 slight collisions in the 40mph stretch. The serious accident was speedalcohol related, 1 slight was speed related and 2 slights were defined as "in a hurry". The site does not come under the rules for a core site, but could well be considered for exceptional enforcement as a Community Concern Site.  TVSRP have logged this site onto its community concern database and they are waiting for responses.  For your information, Community Concern Sites are a new initiative where TVSRP will undertake speed camera enforcement at sites which

# Main Road, Naphill: Petition raised by local residents for footway and carriageway resurfacing.

#### 1 PURPOSE OF REPORT

a To inform the Local Committee of the investigation into the petition raised by residents of Main Road, Naphill for footway and carriageway resurfacing.

#### 2 PROPOSED ACTION

**b** The Local Committee is asked to **NOTE** the contents of this report. Officers will then notify the lead petitioner of the proposed action.

#### 3 SUPPORTING INFORMATION

- c The proposal contained in this petition was first brought to the attention of the Full Council in May 2008, where it was agreed that further investigations should be undertaken to judge the condition of both the footway and carriageway along the affected section of Main Road, Naphill.
- d During early June 2008 the site was inspected and it is considered that several localised areas of footway are in need of treatment, however the majority is in good condition. These works will be included in a footway slurry seal programme that is being arranged by the Wycombe Area Office to be carried out during Autumn 2008.
- e The petition draws comparisons with the surfacing of Coombe Lane, Naphill, which was resurfaced in 2002 as part of the County's Structural Surfacing Programme.
- The Material used for the above carriageway surfacing was a Stone Mastic Asphalt which can produce a quieter running surfacing but cannot be guaranteed as this is a side effect of it's make up rather than a design parameter. It should be noted that the main cause of Traffic

Noise within a 30pmh speed limit comes from the vehicles engines and not road surface conditions.

- g At the same time the carriageway was inspected and following noted. The majority of the surface is Hot Rolled Asphalt, which has good consistent surface texture and although some localised minor defects are present, it is considered that no treatment is necessary.
- h It should be noted that Stone Mastic Asphalt will be used as the resurfacing material at such point that treatment is necessary.

The issue of the interpretive installation at Whiteleaf Cross was discussed at length by the members of the County Council's Overview and Scrutiny committee where representations from local residents and appropriate organisations were heard. After due consideration by this committee the following outcomes were recommended to and agreed by the Community Services Portfolio holder; Mrs Margaret Dewar:

1. The Timeline Panels should be retained in situ as they currently exist and not reduced in number or relocated elsewhere on the site.

**Response -** The Cabinet member endorses this.

- 2. a) Ensure that in future, consultations clearly identify the individual key elements within schemes that are to be developed to ensure that they are not overlooked
  - b) If a local county/national organisation (e.g. Chiltern Society, CPRE) registers an objection to a scheme, a decision should not be taken without the involvement of the Cabinet Member/ (PAG) and the appropriate Local Member.

**Response** - The restoration was very complex and the Cabinet Member believes that extensive consultation was carried out with the public/community and that all parts of the project were clearly defined. However, the recommendation is accepted and the suggested actions will be integrated into future consultation exercises.

3. Improve internal processes in place for responding to concerns and objections by individuals/groups to ensure that appropriate actions are taken by those to whom the concern/objection is addressed.

**Response** -The Cabinet Member will ensure that where possible and when within her remit this will be carried out.

#### **Excessive Speeding of Vehicles**

As from the end of October there will be 8 sets of Community Speedwatch equipment available across Buckinghamshire through the Thames Valley Police, to be used in local communities in partnership with their local neighbourhood officers & PCSO's. This equipment can be used free of charge and is another initiative in the speed "toolbox" for local communities to tackle real or perceived speed issues as well as gathering evidence to prove or disprove if a road has indeed a speeding issue. Information on how to book the equipment, should you wish to utilise this facility, can be obtained from the Wycombe Area Office.

Temporary Speed Indicator Devices: - One is available for booking for the Wycombe District (excluding the tranquil TSID) - The Parish should contact Highways on Call for an application pack which should be completed and returned (together with the appropriate fee). The system will then generate a risk assessment inspection for the

Local Area Technician to carry out. A licence will then be issued showing when the device will be on site. The cost is £100 for a 2 week deployment, which covers the cost of the LATs for risk assessment of the site, erection & demounting

In terms of looking at 'speeding' sites it is important that NAGs are aware that traffic calming measures are not installed solely to address speeding problems, they are implemented as a casualty reduction measure and generally County funding will only be made available for this reason. The exception to this rule is where traffic calming is funded by others such as Parish Councils or Developers. The NAGs should be made aware of the County's Traffic Calming portfolio which explains a lot of this.

# PATHFINDER COMMUNITY ENGAGEMENT – WYCOMBE DISTRICT PILOT: CREATING THE LINKS BETWEEN THE LOCAL COMMUNITY PARTNERSHIP AND THE WYCOMBE PARTNERSHIP

This item specifically deals with the issue of creating a link between the Local Community Partnership and the Wycombe Partnership/Bucks Strategic Partnership.

The creation and development of Local Community Partnerships within Wycombe District is an integral part of the Wycombe District Pilot being undertaken as part of the Pathfinder Community Engagement Workstream. A copy of the current structure is attached.


One issue that has already emerged is the opportunity and benefit of creating a link between each Local Community Partnership and the Wycombe Partnership (the District wide Local Strategic Partnership). This would enable appropriate wider strategic issues to be referred on to the Wycombe Partnership and also enable more area—based matters to be considered by the appropriate Local Community Partnership. This would naturally develop over time and would from part of the formal evaluation of the Pilot in Spring 2009 by the Pathfinder Joint Improvement Board.

Government Statutory Guidance issued in July 2008 (Creating Strong, Safe and Prosperous Communities) supports this approach by identifying one of the roles of the Local Strategic Partnership a:

"Have oversight of, and co-ordinate, community consultation and engagement activities of individual partners and where appropriate combine them".

The Wycombe Partnership, at its meeting on 7 November 2008, considered this issue and have suggested that one way of creating a link would be for the Chairman and/or Vice Chairman of each Local Community Partnership to be members of the wider Wycombe Partnership. This would enable Minutes of meetings to be submitted and issues that require District wide consideration to be raised and progressed.

The views of the Local Community Partnership are sought and, if the above approach is not considered appropriate, the Wycombe Partnership would welcome suggestions on how to create and strengthen the necessary links with each other.

## Buckinghamshire Pathfinder Wycombe District Community Engagement Pilot

#### News Bulletin No 8 - November 2008

#### What's it all about?

The Wycombe District Pathfinder Community Engagement Pilot is seeking to:

- Make it easier and simpler for communities to engage with the whole Public Sector:
- Develop and strengthen community engagement and partnership arrangements based on geographical communities within the Wycombe District; and
- Focus on actions and service improvements to meet local priorities.

#### **LEVEL 1: PILOT COMMUNITY ACTION GROUPS**

#### Downley & Disraeli 1st Pilot Community Action Group meeting held on 27th October.

- 40 people attended
- 41 comments/issues/questions were recorded issues currently being looked at by partner agencies
- Results to be fed back at the next Neighbourhood Action Group Meeting on 8<sup>th</sup> December 2008

#### Key points to highlight:

- The meeting was jointly chaired by the Police and a District Councillor (in her Ward role) with public sector agencies present, showing an excellent example of joined-up working.
- A willingness from the Parish Council of Downley to reach out and assist with the development of the Disraeli community, which is unparished.
- An increased attendance from the community than at a normal Neighbourhood Action Group meeting for the area, although (as expected) the Disraeli community remains under-represented as do the youth of the area. It was hoped however that the launch of the Disraeli & Downley Youth Working Party will help to address this.
- The business conducted demonstrated that it could probably cover the work of both the Neighbourhood Action Group and wider issues and included three elements
  - focus on local issues and priorities with action points
  - feedback on services provided by agencies (questionnaire approach)
  - consultation opportunity from Amersham and Wycombe College on their plans for a site in the community area of Downley and Disraeli.
- Issues on Health, transportation and young people were identified, which interestingly are a wider set than the existing set of NAG priorities.
- Quick wins have been identified and are being actioned, for example,

- £300 has been secured for a joint Newsletter covering the Downley and Disraeli Community [further discussions to be held to see how this can be taken forward] and a desire to include Disraeli in the Downley Day event next year.
- Establishment of a social networking site (Wycombenetwork.com) to engage people in the Downley and Disraeli area to offer views.
- Encouragement to the Downley Parish Council to prepare their Parish Plan and work will start in early 2009.

**Stokenchurch, Radnage, West Wycombe, Lane End, Piddington & Wheeler End**: 1<sup>st</sup> Pilot Community Action Group meeting was held on 25<sup>th</sup> November 2008.

35 people attend, all 5 communities were represented, Thames Valley Police along with their NAG representatives, Voluntary Sector, Parish, District & County Councillors/officers

#### Agenda items included:

- Update on current young people activities/provision
- Discussion on future actions/requirements
- M40 Chilterns Environmental Group: update on work so far & proposal to submit report via Sustainable Communities Act
- Developing the Community Action Group
- Questionnaire

More information will be given in next month's newsletter.

### The Pathfinder Countywide Community Engagement Project Board – Feedback from the meeting on 13<sup>th</sup> November

- Decision to proceed with the production of a Headline Business Case for the development of a single shared community engagement framework, to assist with the evaluation of the Pilots in Spring 2009. The Project Board recognised that this required the full support of all partners in helping to develop the Business Case and to consider the findings.
- Additional risk identified for the work stream relating to the conflicting National Guidance on different partners, which potentially removed flexibility for integration and/or rationalisation at the local level. Potential for securing freedoms and flexibilities to be pursued.
- Strong support for the community appraisals approach using Bucks Community Action to achieve Countywide coverage within 3 years - work programme to be shared when available.
- Presentation to the next meeting on the opportunities for shared working from the Sustainable Communities Act.
- Participatory Budgeting workshop to be arranged for Spring 2009 to help share learning from the Buckinghamshire County Council Pilot.
