Recommendations

- 1. That the Committee endorse the proposed revisions to the BCC Constitution to go forward to Full Council for approval on 20 November 2014.
- 2. That the Committee recommend that the proposed changes endorsed are reflected in the content of draft Operating Framework to ensure the Council's core governance documentations are aligned.

Summary

This report outlines revision options for the Council's Constitution to support delivery of the Future Shape model. The revision options have been informed by steer from the Regulatory & Audit committee, advice from the Monitoring Officer and decisions resulting from the Future Shape Business Case. The final revised constitution will work in conjunction with the new Operating Framework to form the key documents for good governance of the authority.

Key changes

The proposed key changes to the Council's Constitution are outlined below. In addition, there are minor editing changes proposed to ensure that the document is updated with references to new officer titles, corrections, removing necessary duplication or general style editing.

The substantive changes are designed to support and enhance good governance. In particular, clarifying the key role of Members in commissioning and decision-making to ensure that the Council is able to function effectively to meet the democratically determined priorities of Members; as well as ensuring robust processes are in place for organisational assurance.
