A flyer to advertise this will be going into the next newsletter.</p> <p>The Youth Café in Quainton will be opening towards the end of September in the Baptist</p>

	<p>Church. Madeleine advised the Forum that she had some updated notes on the actions highlighted in the report and will send out with the minutes.</p> <p><b>ACTION: Madeleine to obtain an update to be attached to the minutes.</b></p>
7	<p><b>FUTURE OF LOCALITY WORKING IN BUCKINGHAMSHIRE</b></p> <p>The Chairman asked the Forum to note the report regarding the County Council resolution made on 10 July 2008 and advised that the link for the report had been distributed for background information. Members were asked to consider the 11 resolutions passed by Council. A discussion took place on the membership on the Local Area Forum (LAF) and the Chairman noted that members of the Waddesdon Local Area Forum (the Forum) comprises of representatives of the County, District and Parish Councils and the key partner representatives include Thames Valley Police, the Fire and Rescue Service and the Primary Care Trust. Members were advised that it is open to the Forum to decide whether they should invite other local organisations to join.</p> <p>Members were advised that the Forum will hold four meetings a year.</p> <p>Members were invited to ask questions and the following points were made:</p> <ul style="list-style-type: none"> <li>A member asked what the process was for adding an item to the agenda. Madeleine Howe suggested that Parishes contact either herself <a href="mailto:mphowe@buckscc.gov.uk">mphowe@buckscc.gov.uk</a> or Katy Macdonald <a href="mailto:kmacdonald@buckscc.gov.uk">kmacdonald@buckscc.gov.uk</a>.</li> <li>A member queried who was representing each Parish Council and enquired how voting rights were determined. The Chair advised that each Parish Council had been invited to send a representative whom should ideally be a named representative. With regards to voting it would be one Parish Council, one vote.</li> </ul> <p>The Forum was asked to consider the Terms of Reference and membership issues and these were approved unanimously.</p>
8	<p><b>PROPOSAL FOR CHANGE OF NAME OF FORUM</b></p> <p>It had been proposed to change the name of the Forum from Waddesdon LAF to Waddesdon and Winchendons LAF to better reflect the geographical spread of the area covered. After discussion it was agreed to leave the name as Waddesdon LAF but to put a list of the names of all the Parishes included at the top of the agenda.</p> <p style="text-align: right;"><b>ACTION: Madeleine Howe</b></p>

<p><b>9</b></p>	<p><b>QUESTION TIME</b></p> <p>The Chair clarified that Question Time is a 20 minute period for public questions. Members of the public are encouraged to submit their questions in advance of the meeting and these questions will be dealt with first and any verbal questions thereafter.</p> <p>There were no public questions.</p> <p>The Chair asked members if they had any questions. The following points were made:</p> <ul style="list-style-type: none"> <li>• A Parish Council representative asked how the Local Area Forums will be publicised. Madeleine Howe (Local Area Co-ordinator) reported that as this was the inaugural meeting of the Local Area Forum, constitutional issues were still being considered. However, future meetings would be advertised through a poster, previously used at the Waddesdon Local Committee, which relied on Parish Clerks putting them on their noticeboard and in addition local newspapers and community/parish newsletters. Members were also advised that ensuring all members of the public can attend the forums is considered very important and a hearing loop has been purchased and venues will be fully accessible. Janette Eustace (Area Lead Officer) reminded members that they also had a key role in promoting the LAFs through their own networks.</li> </ul> <p style="text-align: right;"><b>Action: Madeleine Howe</b></p> <ul style="list-style-type: none"> <li>• The representative from Grendon Underwood explained that parents of children attending the village school use the village hall car park during school dropping of and collection times. The village hall car park is in need of repair/upgrading. A bid to the Delegated Budget scheme had been applied for unsuccessfully. The village hall committee are keen to know whether there are other sources of funding. Madeleine and Ann-Marie Davies will help the village hall committee to look at the options.</li> </ul> <p style="text-align: right;"><b>Action: Ann-Marie/Madeleine/Paul Jackman</b></p> <ul style="list-style-type: none"> <li>• A Parish representative asked about Local Committees and whether they were still continuing. <p><b>11</b></p>	<p><b>FIRE AND RESCUE SERVICE</b></p> <p>A presentation was given by Paul McShane for the Bucks Fire and Rescue Service and covered the following issues:-</p> <ul style="list-style-type: none"> <li>• Vision</li> <li>• Organisation</li> <li>• Understanding community risks</li> <li>• Pressures and realities</li> <li>• Proposed objectives</li> <li>• Potential prevention schemes</li> <li>• Integrated Risk Management Plan (IRMP)</li> <li>• Summary and contacts</li> </ul>

	<p>Their website can be found at <a href="http://www.bucksfire.gov.uk">www.bucksfire.gov.uk</a></p> <p>The Fire and Rescue Service highlighted how they could contribute to LAFs by addressing priorities identified and working together to try and resolve them. After discussion the following points were made:-</p> <ul style="list-style-type: none"> <li>• There was a leaflet on home fire safety checks and smoke alarms, which are provided free of charge.</li> <li>• Domestic Sprinklers can be installed in houses where the occupants were disabled or would have difficulty getting out of the house quickly in the event of a fire.</li> <li>• Posters on inconsiderate parking were available and show how some fire engines find it difficult to reach their destination because of poor car parking along narrow roads. The Fire Service had no enforcement powers and had to rely on the goodwill of the public. This leaflet has been circulated to Local Area technicians, highlighting partnership working.</li> <li>• Youth Diversion Scheme, which targets young people and aims to educate children, young people and their families in fire safety skills and divert them from fire crime and associated antisocial behaviour.</li> <li>• Members asked what the Fire and Rescue were doing regarding road safety. Paul McShane informed members that they currently work in partnership with the police, for example by providing Biker Drop-Ins held in villages where friendly advice and information is offered.</li> </ul> <p style="text-align: right;"><b>Action: Parish Councils/Fire Service Partnership</b></p>
12	<p><b>ADULT SOCIAL CARE</b></p> <p>A presentation was given by Karen Adamson and Elaine Bedford for Adult Social Care.</p> <p>They highlighted how Adult Social Care could contribute to LAFs by working in partnership with local communities and other agencies to ensure local communities receive the services needed locally. Adult social care surgeries are held locally and aim to bring adult social care services closer to residents by offering support and advice to those who may not be able to get to the main social care offices. After discussion the following points were made:-</p> <ul style="list-style-type: none"> <li>• Elaine Bedford is the local Adult social care representative for Waddesdon LAF and will be attending the LAF.</li> <li>• Elaine asked that if anyone had any concerns about any vulnerable people in the community to contact herself <a href="mailto:ebedford@buckscc.gov.uk">ebedford@buckscc.gov.uk</a> 01494 475202 or Karen Adamson <a href="mailto:kadamson@buckscc.gov.uk">kadamson@buckscc.gov.uk</a> 01296 383847.</li> <li>• The last surgery resulted in 12 people joining the in-touch programme which is a free call four times a year to see how people are getting on and whether they might like to receive any help. Clients who have received calls have commented favourably about the programme mentioning that the caller might have been the only person they had spoken to that day.</li> <li>• The next surgery will be at Quinton Memorial hall on 20 January 2009.</li> </ul> <p style="text-align: right;"><b>Action: Parish Councils/Adult Social Care Partnership</b></p>
13	<p><b>NAG</b></p> <p>A presentation was given by PC Gareth Morley from Waddesdon Police Station. Gareth made the following points:</p>

- Neighbourhood Action Groups (NAGs) were originally set up under neighbourhood policing and they were set up to be separate from the Police, with the intention that the NAG was to give information to the police.
- Thames Valley Police can no longer hold a committee post on the NAG.
- Peter Stray is Chairman of the Waddesdon NAG and will be attending Waddesdon LAF representing the NAG in future.
- Thames Valley Police will attend Waddesdon LAF in future regarding policing roles.

Gareth provided members with a report 'Waddesdon with Quainton, Grendon Underwood and Marsh Gibbon District Neighbourhood' – Neighbourhood Profile 2008. After discussion the following points were made:

- The priorities for the NAG and Neighbourhood Policing team for 2008/2009 are:
  1. Excess speed offences – three areas have been identified to address speeding issues. Station Road, Quainton where the average speed was 44 mph. Station Road, Marsh Gibbon where the average speed was 50 mph and Blackthorn Approach, Marsh Gibbon where the average speed was 50 mph.
  2. Parking –Lower Street in Quainton where there is a time specific problem (school times) with parking and Baker Street, Waddesdon where short term and long term solutions such as double yellow lines are being considered.
  3. Criminal damage/vandalism/graffiti – following visual audits Waddesdon and Westcott will be targeted. A clear up day has been arranged and ways of engaging younger children in this day are being looked at.
- A member commented that the improvements in the Neighbourhood Policing have been amazing.
- A member asked if NAG would get involved in school travel plans. Gareth advised that it is part of Neighbourhood Policing responsibility to support travel plans.
- Gareth advised the Forum that if Parishes wanted a speed check completed anywhere to contact him and he could arrange this.
- A member asked how night time speeding was tackled. Gareth advised that a traffic officer has been assigned to tackle speed offences committed day and night. He will initially be looking at identified areas.
- A member asked how they could ensure that intelligence gets through. Gareth informed the forum that all intelligence goes through Aylesbury and highlighted the need for members to continue to report any problems as it helps to build up a local picture.

## *Working in partnership to make our community safer*

**Neighbourhood Policing lies at the very heart of how we work in Thames Valley Police, and it is our aim to work in partnership to make our community safer.**

Neighbourhood policing is a truly local policing style, working with local people, partners and voluntary organisations to identify and tackle issues of concern in their neighbourhood. It seeks to increase contact between the police and the public in order for us to be more responsive to the needs of local people and therefore improve the quality of service we give. By tackling local priorities with our partner agencies and making use of the specialist skills within the organisation we can increase public confidence in the police and make a real difference to people's lives. Key to improving public confidence is ensuring we keep our communities up-to-date with the work we are undertaking to address the priorities in our area.

Every neighbourhood now has its own dedicated neighbourhood policing team made up of Neighbourhood Specialist Officers, Inspectors, Sergeants and Police Community Officers supported by Special Constables, Police Staff and Volunteers.

# Introduction

**Neighbourhood policing is about putting the 'local' back into policing. It's about making sure that the police, working with other agencies, provide the service that people want by tackling those issues that are important to local residents.**

Your neighbourhood has its own team made up of police officers and police community support officers whose entire focus is on your area.

Thames Valley Police has led the way to the introduction of neighbourhood policing. It was one of a small number of forces which took part in the Government's national reassurance policing programme which was the precursor to neighbourhood policing.

The Neighbourhood policing team is led by the Neighbourhood Action Group, which is set up to deal with key issues identified by public consultation. This may happen in the form of a public meeting, through surveys done face-to-face or by mail, or a combination of methods.

The Action Group is a volunteer working group made up of representatives from the community. It includes residents, the police, local authority and other organisations, such as local businesses and schools.

This group is key to the success of neighbourhood policing as it is this group who will plan on behalf of the community and organise for tasks to be completed. In effect, they are the 'doers' accountable locally for responding to problems a community wants to tackle.

The group is always open to new members and fresh ideas on how to tackle the priorities. If you wanted further information on the Action Group please contact us at Waddesdon Police Station.

The public consultation survey for 2008/2009 identified that the priorities for the NAG and Neighbourhood Policing team are:

- 1. Excess speed offences,**
- 2. Parking, and**
- 3. Criminal damage/vandalism/graffiti**

# Neighbourhood Team



## **Sergeant Bryn Scott**

As the Neighbourhood Sergeant I am responsible for the line management of the NSO and PCSOs. I also act as a quality controller for the work of the team, agreeing tactics and strategies for dealing with locally set neighbourhood priority issues.



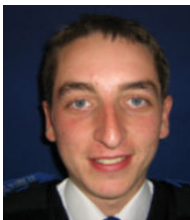
## **Neighbourhood Specialist Officer (NSO) PC Gareth Morley**

As the NSO I am dedicated to this area and not removed for any other duties. This enables me to forge close links with the residents and traders in the neighbourhood and with partner agencies such as the Local Authority, Youth Services, Social Landlords, the Fire Service to name just a few. The informed knowledge that I develop from my work not only enables me to target local offenders and bring them to justice, but to deal with those important quality of life issues that affect everybody in the community from low level incivility to anti-social behaviour and disorder.



## **PCSO Craig Essam PCSO Antony Hurd**

As PCSO's we play a vital role by complementing the work of police officers. We provide a highly visible, accessible, familiar, knowledgeable and accountable, patrolling presence within the neighbourhood. We contribute to community safety by tackling quality of life issues such as anti-social and nuisance behaviour, alcohol abuse, anti-social driving and dealing with abandoned or unlicensed cars.



# Priority 1: Excess Speed Offences

Speeding through our villages is a problem experienced by residents in many of the villages across the neighbourhood. The Neighbourhood Action Group has decided to concentrate though on three specific areas. These are:



## **1. Station Road in Quanton**

The speed limit on the road is 30mph however the average speed is 44mph.

## **2. Station Road in Marsh Gibbon**

The speed limit on the road is 30mph however the average speed is 50mph.

## **3. Blackthorn approach in Marsh Gibbon**

The speed limit on the road is 50mph however the average speed is also 44mph.

So far our efforts have been focused on enforcing the speed limits and on education. Several schemes are underway which have involved the use of a speed indicator device that shows a smiling or frowning face to drivers depending on whether they are speeding. We have also made use of new laser speed guns issued to stop motorists and issue penalty tickets.

Consideration is being given as to the purchase of the community speed watch equipment which will mean local residents enforcing their own speed limits in their villages. For more information on this please contact the Neighbourhood team at Waddesdon Police Station.

We will measure the average speeds in April next year to see if we have made a difference to these areas.

# Priority 2: Parking

The Neighbourhood Action Group decided in April as a result of the survey to focus on the following areas:

- 1. Baker Street in Waddesdon**
- 2. Lower Street in Quinton**

When people park their vehicles on road junctions, block driveways and park on the narrow pavements they hinder access for wheelchair and pushchair users. Also parking on both sides of the road can hinder emergency service access and slow response times.

The Neighbourhood policing team in conjunction with local residents have setup a system of reporting illegal parking. As a result of these reports we distribute letters to car owners who have parked inconsiderately. We have so far distributed over forty letters.

Our partners in Waddesdon Parish Council are also exploring the possibility of providing alternate parking spaces.

So far we have seen a vast reduction in illegal parking down Baker Street. Some repeat offenders have either been spoken to over the telephone or spoken to in person. In one extreme case a ticket was issued as the male driver had received a number of letters.

In Quinton the Neighbourhood team are in consultation with the primary school about the best way to tackle the school parking problem.



# Priority 3: Criminal Damage

The Neighbourhood Action Group decided in April as a result of the survey to focus on the following areas:

1. **Waddesdon**
2. **Westcott**



The problem in Waddesdon appears to take place at various locations throughout the village. Main areas include; the skate park, Baker Street and the Football Pavilion. Waddesdon had the highest number of recorded offences last year (46) with the damage being spread evenly between damage to buildings, vehicles and other items.

The largest amount of illegal graffiti found in the neighbourhood was at Westcott. Despite this Westcott residents have reported a low number of recorded criminal damage offences.

So far as a result of patrols carried out at the hotspots at key times, we have arrested and interviewed several youths in relation to various forms of criminal damage, vandalism and graffiti.

We are actively supporting initiatives for young people in the villages in an attempt to tackle some of the boredom issues. One example is the Youth Café in Waddesdon Village Hall and the Youth Club in Waddesdon.

We strongly encourage the reporting of damage in the villages to get a greater understanding of when and where the damage occurs.

So far as a result of our efforts criminal damage has dropped by 50% in Westcott and 18% in Waddesdon on last year.

# Schools Liaison

**The NSO and PCSO's for the Neighbourhood actively liaise with all the schools, their staff and their pupils. We provide a friendly, accessible face in schools and help with more serious issues of anti-social behaviour and criminal activity. The initiative essentially adds reassurance to school children, parents and supports educational staff with the difficult work we carry out.**

As part of this liaison we tackle truancy issues, share information on youths causing anti-social problems in the villages and educate the children through lessons about personal safety, internet safety and other relevant topics.

The schools are very supportive of this intervention and we will continue to work hard with the schools to tackle and change the behaviours and beliefs of children acting in an anti-social or criminal way.

## Police Surgeries

**The team regularly conducts Police Surgeries in the villages. This is an opportunity to speak to your 'village bobby' and the PCSO's.**

At the Police Surgeries you can raise any issues or questions with the team, ask about the work we are doing, ask about how to get involved in a Neighbourhood Watch scheme or the Neighbourhood Action Group, you can also seek crime prevention advice. The Police Surgeries are scheduled as follows:
