

**THE BUCKINGHAMSHIRE COUNTY COUNCIL (A413 BUCKINGHAM ROAD
FROM BUCKINGHAM PARK ROUNDABOUT TO WHITCHURCH) (50MPH SPEED
LIMIT) ORDER, 201***

Notice is hereby given that the Council proposes to make The Buckinghamshire County Council (A413 Buckingham Road from Buckingham Park Roundabout To Whitchurch) (50mph Speed Limit) Order, 201* under the Road Traffic Regulation Act 1984. The effect of the Order is to introduce a 50 miles per hour speed limit on the A413 Buckingham Road from Buckingham Park roundabout to Whitchurch. The proposal is intended to reduce the number of collisions and casualties on the section of the A413 stated above.

A copy of the Order and Plan showing the length of the road affected, together with a copy of the Statement of Reasons for proposing to make the Order, can be viewed on the Buckinghamshire County Council website or via prior arrangement.

STATEMENT OF REASONS

Buckinghamshire County Council has conducted a review of Network Safety Schemes and the proposed speed limit reduction is intended to reduce collisions and casualties at the junction through the following measure:

- Reducing the existing 60 miles per hour speed limit to a 50 miles per hour speed limit on the A413 Buckingham Road from Buckingham Park roundabout to Whitchurch.

A Traffic Regulation Order prohibiting the above will enable Thames Valley Police to carry out enforcement to deter motorists from carrying out dangerous manoeuvres and driving at excessive speed on the bends on the single carriageway.

In accordance with Road Traffic Regulation Act 1984, traffic regulation orders are required for A413 from Buckingham Park roundabout to Whitchurch:

For avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of such a danger.

The Department for Transport Circular 01/2013 'Setting local speed limits' sets out how speed limits should be assessed.

BUCKINGHAMSHIRE COUNTY COUNCIL (hereinafter referred to as “the Council”) in exercise of the powers under Sections 1(1), 2(1) and 2(2) of the Road Traffic Regulation Act 1984 (“the Act”), and of all other enabling powers, and having regard to Section 122 of the Act and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. No person shall drive any motor vehicle at a speed exceeding 50 miles per hour on the length of road specified in Schedule One to this Order.
2. This Order may be cited as “The Buckinghamshire County Council (A413 Buckingham Road from Buckingham Park roundabout to Whitchurch) (50mph Speed Limit) Order, 201*” and shall come into operation on * 201*.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into effect of this Order, any speed limits operative prior to this Order coming into effect, relating to the roads specified in Schedule One are revoked to the extent that this Order takes effect.
4. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.

SCHEDULE 1

A413 Buckingham Road, Weedon / Hardwick / Whitchurch which extends from a point 15 metres north of its roundabout junction with Martin Dalby Way, Aylesbury, and continuing northwards, for approximately 4.68km, to a point 28 metres south of the junction with Bushmead Road, Whitchurch.
