Support to the voluntary sector assists the Council in targeting disadvantaged communities.

Sustainability Implications

Support to the voluntary sector assists the Council in targeting disadvantaged communities and in building sustainable communities, through empowering community action. Projects funded through the community grants programme support community participation that impacts positively a number of key objectives including community cohesion, health and wellbeing, the local environment and community safety.

Background

- 1 Chiltern District Council's Community Grant Aid Scheme has been in operation for over ten years supporting a diverse range of local voluntary organisations. Following the completion of the 2012 grants programme, Cabinet requested a review of the scheme to focus on simplifying the application form, increasing member involvement and developing a more consistent scoring process. (See **Appendix 1**).
- 2 The new arrangements were introduced for the 2013/2014 scheme and included;
 - a. A new streamlined application form
 - b. Members invited to feedback on projects delivered in their own respective wards
 - c. A traffic light evaluation system highlighting how each application supports the Council's key corporate objectives in relation to developing community capacity, improving health, supporting the local economy, enhancing community cohesion, protecting the environment and improving community safety
- 3 Responses to the new scheme have been positive. For example, fifty three application forms were submitted, the highest number ever received. There has also been positive feedback from applicants regarding the new application form and specifically comments regarding how much easier and less complicated it is to complete.

"This updated form was certainly more straightforward and concise than the previous one. The previous application form seemed rather confusing when it came to answers about the Chiltern District Council objectives and how our work matched the local aims etc. I liked this new one much better."(Relate)

"I was impressed by the clarity of the web application, particularly the flow of questions. It was more logical than many others I have used." (Amersham Rugby Club)

4 Councillors have been more involved in the scheme not only feeding back their views on applications but also being made aware of the diverse range of activities that are delivered within their respective wards.

Evaluation Process - 2013/14 Community Grant Aid Scheme

5 This year's scheme attracted fifty three applications that collectively requested funding totalling £85,188. The cumulative value if all the applicants' schemes were delivered totals £801,754, which would be achieved by applicants accessing funding from other grant awarding bodies, running internal fundraising events and utilising reserves. The total grant fund available for Chiltern's Community Grant Aid scheme is £32,000 which includes a £2,000 contribution from the Community

Safety budget. The higher volume and improved quality of applications has resulted in the decision making process becoming even more challenging.

- 6 All applications were arranged into three distinct categories. Those attaining the **Green** standard strongly support a broad cross section of the Council's key objectives, have strong councillor support and have successfully secured additional funding. It is proposed that applicants achieving Green status receive 60% of their requested grant apart from those requesting £500 or less who will receive 100% funding. Applicants achieving **Amber** status partially support the Council's objectives, have councillor support and contribute funding towards their project receive up to 25% of their grant request. Applicants classified as **Red** status do not strongly support the Council's objectives, have limited or no match funding, have limited/no councillor support and/or can secure funding from an alternative source receive no funding.
- 7 Details of how the applying organisations are categorised is detailed in Tables 1, 2 and 3.

Conclusion

11 Positive applicant feedback and the high volume of application forms demonstrate a promising start for the new community grant aid scheme. This increased level of demand has placed additional pressure on the Council's limited resources with £85,188 being requested from an available budget of £32,000. To reduce reliance of Chiltern District Council funding all applicants were invited to attend a

Community Impact Bucks funding advice surgery session to help lever in more external funding.

- 12 To provide a fair and consistent approach, all applications were assessed and evaluated with their overall quality categorised as Green, Amber or Red. Using this assessment approach results in the Council awarding £32,698 to forty different community organisations.
- 13 All application forms have been placed in the Members' Room (since 19th July) along with a summary report highlighting each applicant's key strengths and weaknesses along with associated councillor comments.
- 14 Members are asked to agree the proposed allocation of funding as detailed in Tables, 1, 2 and 3 of this report.
- 15 Following the completion of this year's programme a review of the scheme will be undertaken to identify areas for improvement that can be introduced next year.
