1. Purpose of Report

- 1.1 The Planning Committee, at the meeting held on 7 July 2016, considered a report relating to a planning application for minor works to Chesham Leisure Centre. INTRODUCTION

This application is for some minor works to Chesham Leisure Centre and is referred to Planning Committee due to it being on Council-owned land.

THE APPLICATION

The application proposes the replacement of the louvre panels with a noise attenuation array to the exterior of the plant room at Chesham Leisure Centre. The array would measure approximately 9m in width by 1.8m in height and would project 600mm from the face of the building.

POLICIES

Core Strategy for Chiltern District - Adopted November 2011: Policies CS4, CS20, CS28 and CS29.

The Chiltern Local Plan Adopted 1 September 1997 (including alterations adopted 29 May 2001) Consolidated September 2007 & November 2011: Saved Policies GC1, GC3 and CSF1.

ISSUES

Principle

1. The application site is located within the built-up area of Chesham wherein development for leisure and sports facilities is acceptable in principle subject to complying with the relevant Development Plan Policies.

Character and appearance

2. The application building is a large leisure centre which is bordered by a surface car park and a school. The building is not easily visible from White Hill. The proposal would replace a number of louvre panels with an attenuation array to attenuate sound from the plant room. It would have the same material, polyester powder coated aluminium and the same blue colour and it would have the same measurements and cover the same area as the existing panels. The only difference would be that it would project forward by 600mm from the wall. Core Strategy Policy CS4 encourages sustainable development and the National Planning Policy Framework, which is a material consideration, also places great emphasis on sustainable development. Given the design of the attenuation array and its location, it is considered that the proposed array would not detract from the functional appearance of the building or the character and appearance of the locality. As such, it is considered that the proposed attenuation array would not have an unduly detrimental impact upon the character and appearance of the existing building, the street scene or the wider locality. No objections are therefore raised with regard to Local Plan Policies GC1 and Core Strategy Policies CS4 and CS20.

Amenity of neighbouring properties

3. Given its distance from residential properties (around 80m), it is considered that the attenuation array would not adversely impact upon the amenities enjoyed by their occupants. In fact, the purpose of the proposed array is to reduce noise and hence improve local amenity. No objections are therefore raised in relation to Local Plan Policy GC3.

Human Rights

4. The following recommendation is made having regard to the above and also to the content of the Human Rights Act 1998.
