

Table 1 above indicates a deterioration in the assurance levels from 2011/12 to 2012/13, however, this has not continued into 2013/14 with a slight increase in the number of substantial assurance audits. At this time there is no indication that the overall control framework at South Bucks has significantly reduced as a result of the joint working with Chiltern Council and the transformation arising from the many service reviews. Further trends will be undertaken at the end of 2014/15 financial year.
