#### 33. MINUTES

The minutes of the Governance and Electoral Arrangements Committee held on 29 October 2018 were approved and signed by the Chairman as a correct record.

#### 34. **DECLARATIONS OF INTEREST**

## 35. RESPONSES TO THE SECOND STAGE OF CONSULTATION FOR THE COMMUNITY GOVERNANCE REVIEW

On 26 June 2018, the Committee agreed to conduct a Community Governance Review on the governance arrangements for Denham, Farnham Royal and Stoke Poges Parish Councils. This was in response to requests received from those Parish Councils.

At the previous meeting, held on 29 October 2018, the Committee considered the responses received during the first stage of consultation on the proposed changes to the governance arrangements for those Parish Councils, and agreed the draft recommendations for the second stage of consultation.

The Committee considered the responses received during the second stage of the consultation, and noted that these all supported the draft recommendations. One response, whilst supporting the Committee's recommendation to reduce the size of Stoke Poges Parish Council from 13 to 11 Councillors, did express preference for a larger reduction to 10 Councillors. Members noted the guidance on electorate supported a Council size of 11.

The Committee's final recommendations were subject to agreement by Full Council on 27 February 2019. Once agreed, a Reorganisation Order would be made setting out the changes to Denham, Stoke Poges and Farnham Royal Parish Councils'

governance arrangements. The Order would set an implementation date for when the changes took effect which was likely to be 1 March 2019.

#### It was then then **RESOLVED**:

1. That the representations received during the second stage of the Community Governance Review consultation be noted.

#### AND RECOMMENDED TO FULL COUNCIL:

- 2. That the Committee's final recommendations be agreed as follows:
  - a) Denham Parish Council Removal of all Parish Wards
  - b) Stoke Poges Parish Council Reduce the size of the Council from 13 to 11 Parish Councillors
  - c) Farnham Royal Parish Council Remove 1 Parish Ward (by combining Farnham Royal South with Farnham Royal Central) to create a total of 2 Parish Wards called Farnham Royal North and Farnham Royal South.

#### 36. POLLING DISTRICT AND POLLING PLACES REVIEW

The Committee received a report setting out the process and proposed timetable for carrying out a UK Parliamentary polling district and polling places review that had to be completed between 1 October 2018 and 31 January 2020.

A review had been completed in 2018, resulting in St Andrews United Reformed Church being designated the polling place for the polling district (SIR) Iver Richings Park. Since the completion of that review further information had been received indicating that the building may not be available for use as a polling station in the future. It was proposed that as part of the forthcoming review that St Leonards Church Hall be re-designated the polling place Iver Richings Park.

It was also noted that the Districts of Aylesbury Vale, Chiltern, South Bucks and Wycombe (Changes to Years of Elections) Order 2018 postponed the 2 May 2019 District and Parish Elections to 7 May 2020. In effect the term of office for District and Parish Councillors had been extended by one year.

Members noted that the Notice of Review would be published on 1 February, and following the consultation the Acting Returning Officer would publish a report setting out the existing and proposed polling places. This would then be subject to a second consultation, and the results of which would be considered by the Governance & Electoral Arrangements Committee in October 2019 when the Committee would be asked to agree the final recommendations to be implemented.

#### **RESOLVED:**

- 1. That the requirement to complete a UK Parliamentary polling district and polling places review by 31 January 2020 be noted.
- 2. That the proposed timetable for carrying out the necessary consultation and consideration of comments and representations be noted.

#### 1. Purpose of Report

As required under the Electoral Registration and Administration Act 2013 the Council commenced a UK Parliamentary polling district and polling places review in February 2019. The Committee noted the timetable for the review at the meeting held on 16 January 2019. This report sets out the recommendations of the Acting Returning Officer following the public consultations that have taken place.

#### **RECOMMENDATIONS:**

That the designations of polling districts and polling places as set out in the Appendix be agreed.

#### 2. Reasons for Recommendations

Following the recent review of polling district and polling places the above recommendation aims to ensure that suitable locations are in place for polling purposes.

#### 3. Content of Report

The Council is required by the Electoral and Administration Act 2013 to review the UK Parliamentary polling districts and polling places in its area between 1 October 2018 and 31 January 2020. Local authorities can also carry out a review of all or some polling districts and polling places at other times.

A review commenced on 8 February 2019 and the attached report, issued by the Acting Returning Officer (ARO), sets out their recommendations as well as the representations received during the public consultations.

Members are asked to consider and agree the Acting Returning Officer's recommendations as shown in the Appendix.

Members will be aware that the Chief Executive left the Council on 31 August 2019 and the role of Returning Officer and Electoral Registration Officer was carried out by the Chief Executive. As agreed by both Councils the role of Returning Officer and Electoral Registration Officer will be carried out by Joanna Swift, Head of Legal and Democratic Services from 1 September 2019 to 1 April 2020 (vesting day of Buckinghamshire Council).

#### 4. Consultation

The Notice of Review of Polling Districts and Places was published on 8 February 2019 which invited public comments and submissions by 15 March 2019.

Publication of ARO's report for proposed and existing polling places took place on 21 June 2019 and a further opportunity to comment was provided until 12 August 2019.

#### 5. Options

The Committee can decide whether to agree the proposed re-designation as set out in the attach report.

### **Polling District and Place Review 2019**

#### **Summary**

Pursuant of the Electoral Registration and Administration Act 2013, the District Council is required to undertake a review of parliamentary polling districts and places. Electors within the District, or within the parliamentary constituency, may make a representation concerning any views regarding the existing structure of polling districts, polling places and access to polling stations.

The Review commenced on 8<sup>th</sup> February 2019 and this report, issued by the recommendations as Returning Officer sets their out representations received during the public consultation. The public and interested parties were able to submit further comments and submissions relating to the Acting Returning Officer's (ARO) recommendations set out in this 2<sup>nd</sup> August report 2019. The ARO's provisional decisions and be recommendations will to the Governance and Electoral presented Arrangements Committee on 10 October 2019 for a decision.

#### The remit of the Review

The Council is required by the Electoral and Administration Act 2013 to review the UK Parliamentary polling districts and polling places in its area between 1 October 2018 and 31 January 2020. This review is being conducted ahead of the next

UK Parliamentary elections scheduled to take place on 5<sup>th</sup> May 2022. The local authority conducted a preliminary polling district and place review in 2017 which concluded in 2018. This captured a number of changes to polling places which based on comments and submissions were deemed unsuitable as use of polling stations. The current review has sought to review all polling districts and places to ensure any proposed changes can take effect for future elections.

There is an obligation for the Council to ensure that polling stations are suitable and for all electors.

The requirements are that:

- 1. Electors have such reasonable facilities for voting as are practicable in the circumstances, and
- 2. As far as is reasonable and practicable, that polling places are accessible to all electors, including those who are disabled, and when designating a polling place, have regard to the accessibility needs of disabled persons.

#### Recommendations

The Acting Returning Officer's recommendations to the Electoral and Governance Arrangements Committee on 10 October 2019 are as follows:

1) To re-designate St Leonards Church Hall as the polling station for polling district 'SIR- Iver Richings Park'

The Acting Returning Officer's proposals and considerations are summarised in *Appendix 1*. The comments and submissions from the consultation period are summarised in *Appendix 2*. The Electorate totals for the polling places are listed in *Appendix 3*.

#### **Definition of Terms**

- A polling district is a geographical area created by the sub-division of a parliamentary constituency or ward into smaller parts.
- A polling place is the building or area in which polling stations will be located.
- A polling station is the area within the polling place where voting takes place.
