Proposed Extension to the Contract of the Deputy Police and Crime Commissioner for the Thames Valley

I am writing to you on behalf of the Thames Valley Police and Crime Panel about the proposed extension to the contract of the Deputy Police and Crime Commissioner (DPCC) for Thames Valley, Councillor David Carroll, to Wednesday 11 May 2016. The Panel received detailed paperwork at the meeting held on 27 November 2015 concerning the role of the DPCC. The Panel, through discussion and examination of evidence agreed:-

- The answers provided by both you and Councillor Carroll highlighted the value of the position of DPCC, particularly in relation to building relationships with key partners across the Thames Valley. There was also some discussion about whether it would be more appropriate, given the PCC's additional responsibilities; a full time post should be considered.
- Cllr Carroll also highlighted a number of key areas where he has taken a lead and as such added value to the work of the Office of the Police and Crime Commissioner, these include:
 - Chairing the Complaints, Integrity and Ethics Panel
 - Supporting you in the development of the priorities for the Police and Plan by engaging with partners.
 - As a Member of the Management Team contributing to financial and policy issues.
 - Attending meetings with stakeholders and the public across the Thames Valley influencing policing and crime issues.

The Panel agreed that the candidate demonstrated a range of experience in the field of police and crime and was confident and knowledgeable in these areas. After deliberations members agreed to: Endorse the proposed extension of Councillor David Carroll's appointment as Deputy Police and Crime Commissioner for Thames Valley to the 11th May 2016.
