RECOMMENDATION TO COUNCIL

To approve a supplementary estimate for the purchase of land detailed in Appendix A, section 1, not to exceed the figure set out in Appendix A section 12 once the final figure has been confirmed.

Reason for Decision

To secure the land referred to in Appendix A for the reasons set out in Section 1 of the Appendix.

Corporate Implications

1. The Council has the power under Section 120 of the Local Government Act 1972 to acquire land by agreement, inside or outside its area, for the purpose of any of its functions under the 1972 Act or any other enactment, or for the benefit, improvement or development of the area. In terms of funding, the proposal is to utilise balances held on bank deposit known as the Repairs & Renewal Fund, to gain a better return. The rental income would be credited to the fund and not the Council's revenue budget to support the funding the Repairs and Renewals Programme.
