68 14/06781/FUL - LAND REAR OF THE NAGS HEAD, 63 LONDON ROAD, HIGH WYCOMBE, BUCKINGHAMSHIRE, HP11 1BN

Members voted in favour of the motion to defer the application for Officers to liaise with the applicant to resolve the following outstanding issues:

- Being a new build, amenity space was required for all flats (without reducing car parking provision);
- Poor relationship with the ground floor flat and rear car parking area (noise, disturbance and outlook); and
- Appropriate affordable housing provision.

PROPOSED: that the application be approved, contrary to Officer's recommendation, subject to the following planning condition:

Within six months of the date of this permission the front dormer window at 3A Cressex Road, shown modified on plan 2014/3/01 hereby permitted, shall be demolished, the resulting materials removed from the site and the roof made good, unless the modifications to this dormer window hereby approved are completed along with the construction of the matching dormer window at number 3B Cressex Road as indicated on the approved plan. The development shall thereafter be retained as such unless otherwise agreed in writing by the Local Planning Authority.

Reason: The completion of the works proposed is required to ensure a development in keeping with the character and appearance of the pair of semi-detached properties and the street scene in general.
