#### 34 MINUTES OF THE PREVIOUS MEETING

**RESOLVED**: That the minutes of the Planning Committee meeting held on 29 July 2015 be approved as a true record and signed by the Chairman.

#### 36 PLANNING APPLICATIONS

**RESOLVED**: That the reports be received and the recommendations contained in the reports be adopted, subject to any deletions, updates or alterations set out in the minutes below.

# 37 14/07003/FUL - WINDSOR HOUSE, 33 - 39 SPITTAL STREET, MARLOW, SL7 3HJ

The Committee noted a revised recommendation as presented in the Update sheet and voted in favour of the motion to delegate authority to the Head of Planning and Sustainability.

**RESOLVED:** that the application be delegated to the Head of Planning and Sustainability to grant conditional planning permission upon:

- a) the submission of revised drawings to ensure that the development did not protrude onto the pavement (and Condition 2 to be updated accordingly to reflect the changes to amend drawing numbers), and,
- b) once alternative options to move the bin store have been reviewed again, but if a better solution cannot be found then the bin store can remain as currently indicated on the plans submitted.

The Committee was addressed by Mr M Blunkell on behalf of the Marlow Society and Mr M Croxon in objection and Mr D Howells on behalf of the applicant.

#### 38 15/06251/FUL - THE DISRAELI ARMS, FORD STREET, HIGH WYCOMBE, BUCKINGHAMSHIRE, HP11 1RU

The Committee voted in favour of the motion to approve the application, subject to the addition of planning conditions requiring the following –

- 1. That the Velux windows in bedroom of Flat 5 be fixed shut and obscure glazed.
- 2. That the Velux windows in the kitchen of Flat 5 be obscure glazed and be fitted with restrictors.
- 3. That the fence, bordering Brook Lodge and the application site be lowered to 2 metres, as measured from the application site, unless the top 0.5metres has been replaced with a trellis.

**RESOLVED:** that the application be approved subject to the amendments stated above.

The Committee was also addressed by Mr M Crook, on behalf of the immediate neighbours in objection and Mr M Cotton on behalf of the applicant.

**RESOLVED:** that the application be permitted subject to the inclusion of the condition to remove Permitted Development on both properties.

# 40 15/06161/OUT - OS PARCEL 9166 BOXER ROAD & OS PARCEL 6576, WALNUT TREE LANE, LONGWICK, BUCKINGHAMSHIRE

The Committee's attention was brought to paragraph 5.37 in the main report and Members were reminded that suggested dates / timeframe for progression of Neighbourhood Plan was not set in stone and there was no guarantee as the progression of each stage was dependent on each other and as such anticipated timeframes may well reasonably change.

The Committee voted unanimously in favour of the motion to refuse the application.

**RESOLVED:** that the application be refused.
