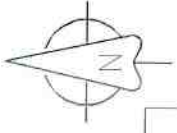

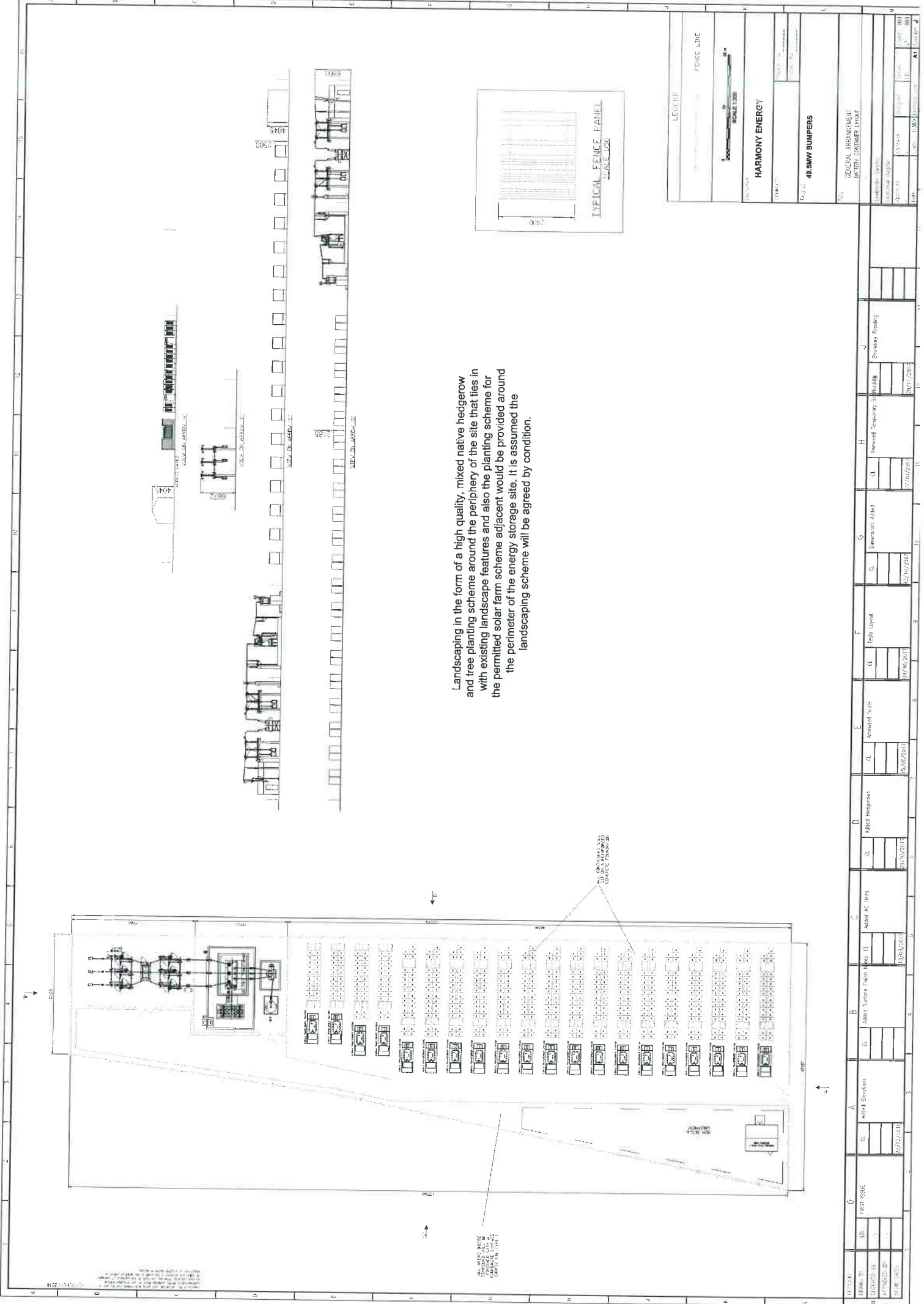
BLOCK PLAN

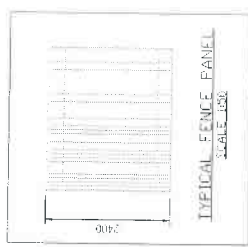

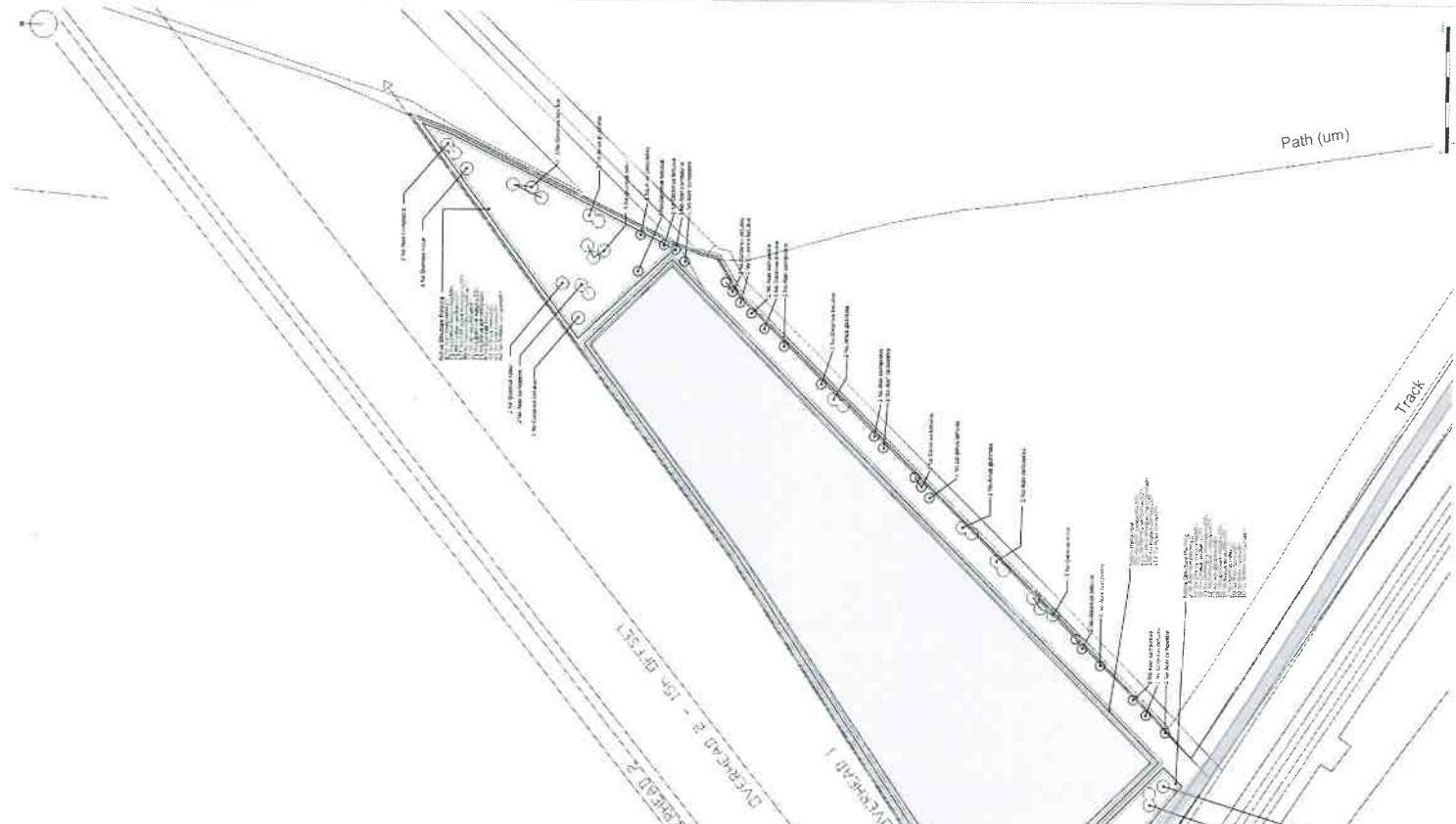
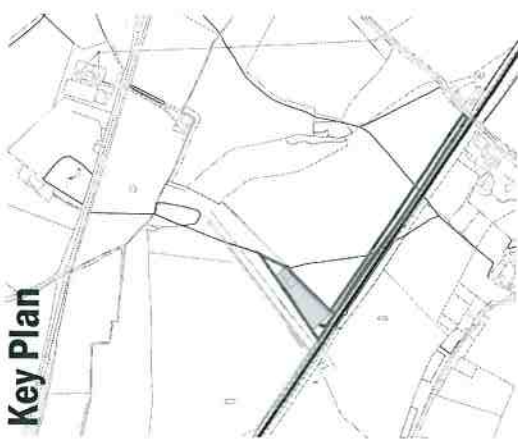

GENERAL ARRANGEMENT BATTERY COURSE LAYOUT

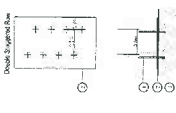

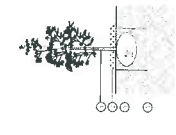
