### **CONSERVATION & ARCHAEOLOGY IN MILTON KEYNES**

## Update, March 2022

#### DEVELOPMENT MANAGEMENT

The Conservation & Archaeology Team received 414 planning consultations during the second half of 2021, 170 of which were archaeology related, 244 building conservation related.

#### FIELDWORK

10 fieldwork projects took place between July and December, full list appended. Projects comprised:

5 excavations; 2 trial trench evaluations, 1 geophysical survey; and 2 watching briefs.

Highlights included excavations in relation to a large mixed-use development to the east of the M1 between Milton Keynes and Newport Pagnell, known as MK East Strategic Urban Extension (MKESUE). This first phase of mitigation excavations carried out by Pre-Construct Archaeology, focused on land to the west of the River Ouzel close to the M1 motorway. A multi-period landscape was revealed spanning early Bronze Age funerary monuments (ploughed out barrows / ring ditches) to Iron Age and Romano-British rural settlement sites. Artefacts recovered included an Iron Age log ladder from the base of a presumed waterhole / well (**image below**):

#### HERITAGE AT RISK

The March 2022 version of the register lists 27 heritage assets that are at risk, down from 31 in 2021. Work continues to decrease the level of identified risk at each of these heritage assets with the aim of removing them from the Heritage at Risk Register.

A recent success is the conservation and repair of the Chapel and Farmhouse at Bradwell Abbey. Respectively a scheduled monument and a grade II listed building, both form part of the medieval monastic complex, one of the key heritage assets in the New Town and home to the Milton Keynes City Discovery Centre. The two-year project to restore the buildings was jointly funded by the Council and Historic England with support from the Conservation & Archaeology and Heritage teams. Both structures have now been removed from the local Heritage at Risk register with the scheduled Chapel also being removed from the national register.

Archaeological work carried out as part of the project revealed reused masonry within the fabric of the 17th century farmhouse, including a carved stone head (**below**) that may have originally formed part of the priory church.

#### **CONSERVATION AREAS**

The council is continuing to review its 27 Conservation Areas. During 2021, five more reviews were completed for Castlethorpe (**below**), Hanslope, North Crawley Stoke Goldington and Woughton on the Green. During 2022, five more reviews will be completed for Emberton, Ravenstone, Sherington and Weston Underwood. A report to Cabinet seeking approval of the revised boundaries and supporting documents will be made before the end of the year. This will bring the total number of conservation areas reviewed to 16.

#### MK NEW TOWN HERITAGE REGISTER

Invitations have been sent out to potential members of the selection panel that will assess nominated assets against the adopted selection criteria. It is hoped that an introductory session will be held for the panel in April with nominations being considered in the summer of 2022. Outreach projects for spring and summer have been programmed and an architectural drawing strand of the project is nearly complete. Meanwhile, a project officer will be recruited to collate information regarding those nominations to be taken to the panel.

#### **HISTORIC ENVIRONMENT RECORD (HER)**

The Historic England sponsored audit of the HER was completed in late 2021 and a new action plan drawn up.

#### 1. Recruitment

Since our last meeting, the Heritage Team has been through a busy period of recruitment and reallocation of resources. The following positions have now been successfully filled:

- Tineke Rennie Heritage Officer (Permanent FTE)
- Nicola Bishop Heritage Officer (Permanent FTE)
- Stephanie Parsons Assistant Heritage Officer (Fixed Contract FTE)
- Louise Sjogren Taylor Assistant Heritage Officer (Fixed Contract FTE)

The <u>Heritage and Archaeology Team Leader</u> position is also currently out to advert with a closing date of 10<sup>th</sup> April 2022.

#### 2. Local Heritage List Project

The Local Heritage List project has now received over **2000 nominations**. This is a significant landmark and testament to the hard work of the project team, volunteers and community groups who have all engaged with the project and helped to identify local assets across the county. We want to keep this momentum going by encouraging more volunteers to register on the <u>local list platform</u> and to view our outreach talks on our <u>YouTube channel</u>.

Project highlights to-date:

- Currently 2160 candidate sites nominated for Local Listing.
- We currently have **140 registered users** on our Local Heritage List web platform.
- A core group of **18 volunteers** are busy nominating, researching and enriching sites online.
- Currently involved with **38 groups and organisations.**
- **15 parish councils** are working with us to nominate and enrich sites.

The Council remains on target to submit nominations to Members for adoption by Autumn this year.

- Mentmore Towers warrant for access and survey completed, working to find solutions and currently considering options.
- Whiteleaf Cottages fire-damaged cottages, Whiteleaf The owner has submitted a pre-application request for advice on the reinstatement of the cottages and enabling development. Negotiations ongoing.
- **Brunel Shed, High Wycombe** Building work is on site nearing completion and progressing for the conversion and extension of this Grade II LB.
- **2-3 High Street, High Wycombe** Building work now completed on this Grade II LB, cocktail bar due to open soon.
