Could you or someone you know foster?

With a national and local shortage of Foster Carers, coupled with an increase in demand, Buckinghamshire Council has set up a dedicated task force to look into how we can improve our support to Foster Carers as well as review our processes and procedures to increase the number of people applying, being approved and staying as a Buckinghamshire Council Foster Carer.

The task force are looking into all options and are working on a package of incentives which will make fostering for Buckinghamshire Council a unique and favourable option in a very competitive market. Following feedback from our current Foster Carers one quick win before Christmas was the issuing of larger size wheely bins to all current foster carers which was a welcomed support for fostering families.

We will also be reaching out to our local community partners and would welcome your insight and help too, to ensure we are reaching more of the right people who could care for our children.

With over 500 Buckinghamshire children needing; caring, supportive and loving homes on long and short term basis we're committed to building our fostering community and taking good care of our fostering families. As our unique offer is developed we will keep you updated and seek your support in reaching your local residents and communities.

Regeneration framework - what it means for our towns

Our regeneration framework sets out an over-arching approach to deliver our vision to create places where people want to be, driving local revitalisation and creating vibrant, thriving spaces for people to live and work across the county. It sets out the opportunities to build on our strengths as well as the economic and social challenges we need to respond to.

As well as setting out our vision for three town centres – Aylesbury, High Wycombe and Chesham – the regeneration framework provides a toolkit to enable areas to develop and progress their own plans for renewal.

Our Local Plan: what, why and how

Local plans are at the heart of the planning system and are the main consideration used in deciding planning applications. A local plan sets out the long-term vision and framework for future development of an area – the Local Plan for Buckinghamshire will go up to 2045.

It will look at future needs for housing and employment across the county, identifying where development should take place and protected places where it needs to be carefully controlled.

The Local Plan is our opportunity to set out how we intend to manage and accommodate future growth, meet our local social, economic and environmental needs and get the right infrastructure in place. We have already started preparatory work with two recent public consultations covering an **Attitudes Survey** and our **draft vision and objectives**.

Our next consultation will invite people to have their say on a selection of different strategic growth scenarios for how we can accommodate new homes and jobs throughout Buckinghamshire. This will help establish the guiding principles which will help to shape where and how we will plan to deliver new housing in the next Local Plan. This is likely to take place in spring this year.

Housing Strategy – vision for future housing supply

We have recently completed a public consultation on our first Housing Strategy. The strategy sets out how all the partners involved in delivering housing in Buckinghamshire will work together to ensure that the housing offer delivers the housing our residents need. It focuses on three main priorities:

- Responding to the needs of our diverse population
- Better homes which are good quality, sustainable and matched to need
- New homes which are affordable, accessible and appropriate

It sets out the challenges we face, the opportunities we can use and how we are responding to these.

Buckinghamshire all-age autism strategy

Buckinghamshire Council is launching its first autism strategy, bringing together an all-age plan of lifelong support for autistic people in Buckinghamshire. The strategy has been coproduced with autistic people, their families and professionals in Health and Social Care.

Our vision is to help autistic people live as independently as possible and have the same life opportunities and experiences as everyone else. We want to ensure autistic people can

access the right support whenever they need it and contribute to shaping how the council works.

The all-age autism strategy focuses on the following areas:

- Improving awareness and understanding of autism
- Tackling health and social care inequalities
- Developing a needs-based approach so that autistic children and young people get the best start in life
- Developing better support for employment and meaningful activities
- Ensuring more adults with autism maintain their independence

The strategy has been consulted on and is looking to be adopted in March – subject to Cabinet approval.

Background

- A. 'Energy Doctor' scheme (Domestic Resource Efficiency Service) approved by <u>Cabinet on 5th January</u> 2023
- B. £1,957,841 (includes 4% management fee for Strategy and Partnerships) has been allocated to support the scheme until the end of March 2025 from the Council's allocation of the Government's UK Shared Prosperity Fund (UKSPF).

Key Objectives:

- Over 1200 properties visited by 31st March 2025 (DLUHC requires 400 visits)
- 300 tonnes of CO₂ saved p.a.



Eligibility Criteria

'To qualify for a visit your home must meet all of the following criteria:

- you rent the property through a private rental agreement, or own and live in the property
- your household has an income of £30,000* or less (before tax), is in receipt of means tested benefits such as Universal Credit and Council Tax Support, or a member of your household is disabled
- the domestic property you live in has an energy performance certificate (EPC) rating
 of D, E, F or G, or does not legally require an EPC

We will prioritise visits for those who meet these eligibility criteria and live in Opportunity Bucks areas.

How to apply

Please contact Better Housing Better Health in the first instance who can assess eligibility for an Energy Doctor visit and other services.

DREO Visit Components

Each visit takes 3 hours (approx.) and the Energy Doctors each complete up to 7 visits per week

- 1. Advice given on support available (grants etc.) to help reduce resource consumption and costs
- 2. Suggestions made for appropriate behavioural changes that will help reduce energy and water consumption and costs
- 3. Energy bills and tariffs checked and advice given to change if better is available
- 4. Low-Cost Easy Retrofit Resource Efficiency (LCERRE) measures installed

Project Gigabit

Project Gigabit

Programme Summary

Buckinghamshire County Council have been allotted with Hertfordshire and East Berkshire in Lot 26. Building Digital UK (BDUK – Central government's executive agency responsible for managing Gigabit contracts) have awarded the contract for this region to CityFibre and this will amount to £58m worth of investment, providing gigabit coverage to over 35,000 business and residential premises. Buckinghamshire are expected to benefit from the bulk of this investment due to poor connectivity in our rural and hard to reach settings – coverage volumes anticipated to be between 20,000 – 25,000 premises.

Contract Timeline



CityFibre

CityFibre are an alternative network provider (altnet) who have been installing fibre networks since 2015. Altnets are smaller operators which use private investment to rival large providers such as Openreach & Virgin.

CityFibre do have an existing commercial footprint in Buckinghamshire and were most recently building networks in and around High Wycombe.

Similar to how Openreach services are delivered by BT, CityFibre also use internet service providers (ISPs) to deliver their services to end users – these include Zen Internet & Giganet.

CityFibre have invested significant resources into winning government contracts and to ultimately support the target of 85% Gigabit coverage by 2025.

Have won 9 Project Gigabit contracts – covering Leicestershire, Warwickshire, Kent, Sussex, Bedfordshire, Milton Keynes, Northampton Shire, Cambridgeshire, Norfolk, Suffolk & Hampshire.

These contracts will use £780m worth of government subsidies and will provide Gigabit coverage to over 400,000 premises.

Have existing footprint in High Wycombe but provide fibre services to over 3 million premises nationwide and this commercial development will continue to grow alongside their Project Gigabit contracts.

Will create over 40 apprenticeships as part of the contract and will also help grow the economy by creating jobs as part of their network to facilitate the rollout of their infrastructure.




Projects by Organisation Type
