The Council are consulting on the following two draft transport plans for High Wycombe, which are being developed through local engagement.

1. High Wycombe 2050 Transport Strategy

This sets the ambition for the town's transport system and consists of:

- a vision statement "By 2050, High Wycombe will be among the best connected and most innovative towns in the Thames Valley, where all journeys, from start to finish, are low emission, seamless, and safe for everyone".
- 3 'Connecting' themes [locally; regionally; green spaces], each with key outcomes.
- 26 transport schemes across 6 categories: (1] walking and cycling; 2] public transport, 3] shared and new mobility, 4] highways and congestion management, 5] land-use, planning and parking; and 6] behavioural change.

2. High Wycombe Local Cycling and Walking Infrastructure Plan (LCWIP)

This is a supporting plan to the draft High Wycombe 2050 Transport Strategy, which aims to recommend ways to make cycling and walking in the High Wycombe area safe, accessible and attractive for all users. It consists of:

- 5 concepts that identify interventions to improve cycling and walking networks: 1] walkable core; 2] main radial routes and key links; 3] healthy neighbourhoods; 4] wider network and strategic routes; 5] a cohesive and connected network.
- a future walking and cycling network covering High Wycombe and links to surrounding areas. This includes proposals for public right of way improvements, recognising the need to maximise the benefit for all users, including equestrians.

The Local Access Forum are encouraged to participate in and promote the public consultation amongst local networks. The public consultation launched on Friday 14th October and closes on Monday 28th November. The online survey can be accessed at <u>buckinghamshire.gov.uk/HWtravel</u>. Printed copies of the plans and survey are available

at High Wycombe Library. Daytime drop-in sessions are being held on Saturday 5th November [Eden Shopping Centre] and Friday 18th November [High Wycombe Library].

E. Strategic Access Update

- 1. HS2 continue to apply for planning permission under the HS2 Act. These drawings generally outline the landscaping, landform, bridges and planting areas. Rights of way are not included, but the maintenance tracks and bridges provide the forerunner to Schedule 4 applications, which in due course, will divert all rights of way impacted by the development. Only one Schedule 4 application has been received so far.
- 2. Further information has been provided on the 'Buckinghamshire Cycleway' provision running north-west from Wendover, utilising maintenance access tracks seldom used by vehicles. Appendix A illustrates the route between Ellesborough Road and Nash Lee Lane, surfaced with Type 1 stone to dust and 3.3m wide. It's described as a cycleway but will likely be accessible for equestrians. Details of the route's formal status are yet to be confirmed.
- 3. Further information is also coming to light on the underpass for non-motorised users at the HS2 crossing of the A4010 Risborough Road [Stoke Mandeville] in the vicinity of the Goat Centre. A 3m wide, 2.8m high underpass will link to the former A4010 and be accessible for horses, cyclists and pedestrians. A link is also provided to the Stoke Mandeville Link Road cycleway see Appendix A.

F. ROW OPERATIONS UPDATE (Joanne Taylor)

- 1 The current staff structure allows for 7 FTE staff this is 1 Rights of Way Team Leader, 3 Area RoW Officers (one vacant post), 2 Assistant RoW Officers and 1 Bridge Structure Inspector. Additionally, we have a part time temporary post covering the capital work programme. Congratulations to Savannah Fradley on her promotion to Rights of Way Officer. Savannah's vacant post as Assistant RoW Officer has been filled full-time by James Dixon. Regrettably the RoW Operations team will be losing Sophie David at the end of December. Sophie has been with the team for 8 years and will be greatly missed. Recruitment for Sophie's replacement is underway.
- 2 **BVPI Rights of Way Condition Survey** the 5% network survey was carried out over the winter 21/22 and the results are:

•	Percentage of paths rated 'Easy to Use'	73.5%
•	Percentage of structures rated 'Easy to Use'	92.7%
•	Percentage of paths signed from road	92.6%

This winter's 5% survey will be undertaken very shortly, using volunteers and officers, with results available at the March 2023 LAF meeting.

4 Berry Hill Footbridge, Taplow Public Footpath [TAP/12/1] – Capital Programme
The 37 metre mid-section of Berry Hill footbridge across the Jubilee River in Taplow
was removed in December 2021. The structure has been closed to the public since

May 2021 after suffering unforeseen structural deterioration. The design has been finalised. The Council's contractor is currently seeking approval from the Environment Agency (EA), but work will not be undertaken until 2023 as the EA is undertaking its own major works on the Jubilee River this year, and this will impact on the timetable for replacing and reopening Berry Hill Footbridge. Commencement likely to be summer 2023.

5 Rights of Way revenue works 2022/23 under review

The priority works on rights of way found in year is currently under review and will depend on budget; projects identified so far, apart from ongoing projects, as outlined above - include bridge replacements for Little Marlow, and surface repair works in Stewkely, Penn, and Denham, and a flight of concrete steps in High Wycombe.


- 6 **Summer/winter Clearance** work on the summer clearance schedule commenced mid-May 2022 using 2 external contractor teams we carried out an estimated 80km of surface clearance. NB a large percentage of summer clearance on RoW is undertaken by parish councils as part of Parish Devolvement Agreements. Several projects for winter clearance have been identified and where budgets are available work will be issued to contractors over the next few weeks.
- Rejuvenating the route of the Bernwood Jubilee Way [BJW] 61-mile Historic Trail
 Regrettably this project has been held, due to the very sad news of the death of Her
 Late Majesty The Queen. It has been possible to rebrand the web pages for the





HS2 - Bucks Cycleway through Wendover

1. KBI Flexi-pave [Gavin Caspersz]

Following the KBI Flexi-pave presentation at the July 2022 meeting, Gavin Caspersz will arrange a display of samples to view during the 11am tea break.

2. Ridgeway Delivery Group meeting 14th September 2022 [Brian Worrell]

<u>a] Signage</u> – the overall message proposed was 'respect all users', with preference for 'Be Nice, Say Hi' slogan, developed by Cycling UK, along with 'Leave no Trace'.

<u>b] Grant funding 22/23</u> – proposed to be targeted on gates, benches and vegetation clearance where it improves access.

<u>c] Grant funding 23-253</u> Targeted on surfacing: e.g. World Heritage sections, Ivinghoe Beacon and Chequers [Ellesborough]. Any other ideas, please email: sarah.wright@Oxfordshire.gov.uk;

d] <u>Ridgeway 50th Anniversary [2023]</u> has a dedicated website <u>The Ridgeway National Trail 50th anniversary</u>; focussing on the top 50 places to visit and is aimed at new audiences. Any areas that don't show the Ridgeway in a good light?

3. Great Missenden Train Station: Disabled Access

The LAF were consulted in March 2022 by Network Rail on the desirability of installing a lift and ramps to link north and south-bound platforms at Great Missenden station. The existing connection for disabled and push chair users is outside the station along a steep and longer alternative path. The chairman wrote in support of the application on 7th March 2023. We have now heard from Chiltern Railways' Stakeholder Manager to say the application to Network Rial was ultimately delayed from Spring 2022 to September 2022 and they anticipate an answer from Network Rail in early 2023.

4. Opening of the new Berryfields to Buckingham Park Cyleway

Richard Jennings has inspected this new route and attended the opening ceremony. Richard to provide a summary Appendix C.

5. West End Road, High Wycombe - Public Spaces Protection Order

Members may recall voting at the July 2022 meeting supporting the above order which closes Footpath HWU/80/1 for a further 3 years to combat anti-social behaviour. On 5th October 2022, the Deputy Leader and Cabinet Member Health and Wellbeing, on behalf of the Leader of the Council, extended the order for a further three years commencing 10th October 2022.

Cllr. Lesley Clarke and other LAF members enquired if it was possible to extinguish the footpath permanently to avoid repeating the process every 3 years. In answer to that question, a summary is provided by the rights of way team in Appendix D





Berryfields and Buckingham Park linking path showing the Aylesbury Gardenway and existing paths






Proposed deletion of Footpath HWU/80/1 – West End Road, High Wycombe

Discussions have been held internally between the Definitive Map team and Rights of Way Operations teams about the above proposal and we have concluded that we should continue with the current Public Spaces Protection Order which is the most appropriate use of legislation for this issue.

A complete extinguishment of the route can only be achieved under s118 Highways Act 1980, and this will only succeed if it can be clearly demonstrated the route is not needed for public use. The legislation is very clear on that: reasons of anti-social behaviour cannot be taken into account. As the route is currently closed under a PSPO, it cannot be demonstrated that it is not needed for public use as the public have no choice but to not use it. The route would have to be reopened whilst the Order ran its course – which would most likely subject the residents to anti-social behaviour throughout. However, even if the route was reopened, we are still not convinced the legal tests would be met. The route is a through-route and connects with the wider PROW network. It provides a short cut, which could be beneficial to those less able bodied as opposed to the roadside footway. Proving it is not needed for public use is going to be far from easy.

The general theory behind a PSPO is that it allows time for miscreants to leave the area and criminality to reduce. If the wider area was to redevelop as maybe the case, this may drive the anti-social behaviour away. Once a PROW is extinguished, it is gone for good. Whereas the issues that are occurring along the route may only be temporary. It would seem unfair to seek full closure of a public highway for something which may be overcome over time.

It is therefore our view that the PROW remains closed under a PSPO and the situation reviewed as and when the Order expires. PSPOs are available for this very reason – to combat anti-social behaviour, but not to the long-term detriment of wider public access.

Open Access Land advice

The Forum provided the National Trust with informal advice on their ash die-back tree works on West Wycombe Hill. In addition, advice was provided to Natural England on open access restrictions at Wayside Farm and Chawley Manor Farm, Bledlow. This resulted in changes to the original proposals to the benefit of walkers.

National Government

The Forum wrote to the Rt Hon Michael Gove MP, Secretary of State for Levelling Up, Housing and Communities, with concerns about the slow progress of Definitive Map Modification Orders referred to the Planning Inspectorate for determination. They also lobbied for an extension of the 2026 cut-off date for submission of Definitive Map Modification Orders.

Improving public access: making a difference

Member are involved in following voluntary activities:

- 1. publishing and leading walks in the Chilterns;
- 2. surveying promoted routes and completing BVPI reports;
- 3. trouble-shooting new cycling and walking routes;
- 4. attending Ridgeway Delivery Group meetings;
