#### 5 Community Safety

TVP – Inspector James Ellis –. The report was attached to the agenda pack

- Newsletters being produced quarterly to capture highlights in the area.
- Home Burglaries generally seen a downturn in offending rates in first half of the year. There has been some organised groups offending and some successful prosecutions.
- Affluent areas are being targeted in the arterial road network.
- Window film recommended to place over vulnerable windows to prevent burglaries.
- Pony and Trap racing met with Bucks Council on site at A413 to discuss concerns. This is a developing group who spans the whole country in significant numbers. Would like to see the characteristics of the road changed – discussions are ongoing. Thank you to the Board for the successful platform and partnership working that has taken place regarding this activity to forming a holistic approach.
- Keyless thefts criminal devices have become more sophisticated. There are products out there to protect your keys and protect your cars.
- Trades vehicles and theft of tools this is an ongoing operation
- Rural crime poaching, theft of plant machinery and prevention information sharing
- Police issues forum 26 July, all are invited and will cover the above.

Question — Cllr Carl Jackson — ASB from secondary school pupils intimidating residents. How should this be reported. **Answer** — further presence in the area by TVP and look at interventions with parents of pupils and working with Bucks Council Community Safety Team. Residents to be encouraged to report incidents on line rather than 999

13 assisting ambo, 6 animal rescues. Look to lower the numbers with
prevention activities.

Questions – Cllr Carl Jackson – are there any fire stations predicted for closure eg Marlow? ANSWER – public consultation will begin with regards to "do you want the closest station or the quickest station to attend." Confident that the crewing is improving for Marlow Fire Station and they will remain functional.

Cllr Thomas Broom – thanking BFRS for the responses made during summer pressures.

**Insp Ellis** – water safety video being promoted looking at risks and highlighting the dangers. Please circulate the video **ACTION LC** to attach to meeting notes and circulate to wider Board membership.

RE Acton Group: Community Safety

- 1 My apologies to those attending for my being unable to take part in Tuesday's Community Board meeting due to IT problems.(I had been using internet throughout the day without problem but had trouble logging into MSTeams, then found neither video nor microphone would work, nor could I use the chatbox. I did listen to most of the meeting however and this is what I intended to say ref Community Safety
- I have discussed this prevliousy with Liz Charter as coordinator and we generated a short list of issues we think merit most attention. Mindful of the limited funding we should look for other actions his action group can recommend
- A significantly increasing problem concerns Fraud, and how we as smaller communities can help challenge it. I include in this cold calling especially to garner house and garden repairs; but internet and telephone activity is reaching serious levels

These activities cross over with ID theft and other criminal activity. Sadly the profile of the victims tends to be the more vulnerable in the community,

The issue is often in getting advice to those sectors of the community, and providing them with the knowledge to resist scams. A number of organisations already provide this sort of service (eg Help The Aged). It would be helpful to find out what advice is available in the different communities this board services

Of concern to residents in the SL9 area in particular is the Pony Trap racing on the A413. We hope to receive an update of the work Bucks Council and Thames Valley Police have been investing in by way of partnership. This is an extreme example of several Public Order issues which need to be compared from community

to community

- In two previous years we have discussed CCTV and we were asked by Buckinghamshire Council to think twice about investing in new systems and/or software whilst they agreed a uniform approach across the county.
- 6 CCTV goes hand in hand with another issue: Fly Tipping. Again an exchange of information between communities can be helpful as much of this activity takes place along country lanes between communities
- Speeding and Parking issues continue to irritate members of the public. In some communities (eg ChStPeter) inconsistent enforcement leads to abuse of free parking facilities, yet one hour free parking is often the make or break for survival of many small businesses. What is your experience? Should the larger T&PC's be allowed to contribute towards the cost of additional enforcement. Chalfont St Peter have been asking for this for at least three years

#### CORPORATE UPDATE

**Play Streets launched** - gives children the opportunity to play safely outside on their doorstep through a new scheme where residents can apply for a Play Streets session to temporarily close their road. #### Ultrafast broadband boost for rural businesses

Working with Openreach and Buckinghamshire Local Enterprise Partnership, we have now completed Phase 3 of the Bucks Rural Business Broadband project. This project has successfully delivered ultrafast gigabit capable fibre connections to 723 rural business and residential premises in 38 towns and villages

#### **Bucks Rural Business Grant – Rural England Prosperity Fund**

The Bucks Rural Business Grant scheme launches on 21 June to provide financial support and help to create opportunities for rural businesses in Buckinghamshire. Funding in the form of capital grants ranging from £2,500 up to £300,000 is available for small-scale investment in micro and small enterprises employing fewer than 50 people in rural areas.

#### Spreading the word about the Bucks filming locations database

Buckinghamshire Film Office promotes locations, minimises impact on residents and business and maximises the economic and social benefits of filming. Did you know that feature films and high-end TV dramas are estimated to spend between £8,000 and £108,000 per day in the local area? Buckinghamshire Film Office hosts a free database open to all land/property owners to offer their property as a shoot location.

**Ward boundaries consultation -** These recommendations were made public on 30 May and see a reduction in the number of councillors from 147 to 97. Wards will remain at 49, with the new boundaries coming into effect at the local elections in May 2025. The report can be viewed at <u>Buckinghamshire | LGBCE</u>.

#### CORPORATE UPDATE cont...

**Local Plan and Local Transport Plan** - Consultation on draft vision complete, feedback to be reviewed and expecting to publish later in the year. In the winter a further consultation to invite views on a series of possible growth scenarios which will look at a range of potential options for Buckinghamshire to meet its future housing needs and provide quality employment opportunities.

**Local transport plan – next steps -** Using feedback and comments from the consultation, we will develop the policies and an implementation plan for the LTP5. We will hold a consultation on these in winter 2023 with the aim to adopt the Local Transport Plan in summer 2024.

Cost of Living funding and focus - Our Cost of Living and Helping Hand programmes continue to strive to reduce the impact of increased financial hardship that residents may be experiencing. Our Helping Hand continue to provide emergency support and signposting to residents, and the council is preparing the Holiday Activities and Food (HAF) programme for the summer holidays.

We continue the promotion of local initiatives such as Food Champions and the Community Food Chain and the social media campaign continues to signpost residents to support.
