#### Agenda Item

#### 1 Chairman's Welcome

Howard Mordue, Chairman welcomed everyone to the meeting and highlighted that the temporary banking hub had officially launched in Buckingham Library. A permanent hub was in development and an official press release would be released the following day.

#### 2 Apologies for Absence

Apologies were received from: Caroline Cornell, Frank Mahon, John Chilver, Angela Macpherson, Michael Rand, Jilly Jordan, Thornton Parish Meeting, Stowe Parish Council, Gawcott with Lenborough Parish Council, Foscote Parish Meeting, Calvert Green Parish Council, Tingewick Parish Council, Buckingham Canal Society, Project Street Life, Trading Standards and David Williams.

#### 3 Declarations of Interest

There were none.

#### 4 Notes/Actions of Previous Meeting

Alice Williams, Community Board Manager updated on the actions from the previous meeting. All action were either complete or ongoing. No required changes

to the previous notes were requested.

# **RESOLVED:** Action notes of the previous meeting were AGREED as an accurate record.

Members of the community board raised some concerns about the banking hub as they felt it was unclear who was responsible for the operation and management. It was clarified that Cash Access UK is a national company and the service is funded by the major UK banks. Social media had played a part in confusion due to mixed messages but the official press release should provide clarification. Buckingham temporary Banking Hub opens | Buckinghamshire Council

#### 5 Corporate Update

Sara Turnbull, Service Director for Adult Social Care and the service director representative for the Buckingham and Villages Community Board presented the update circulated with the agenda.

Sara highlighted the consultation for the proposed relocation of Furze Down School sixth form to Wells Street, Buckingham (to share a space with the Buckingham Opportunities Centre).

Members of the board raised concerns over the risk of congestion during school pick up hours. It was highlighted in response that the school would stagger collection times in order to manage traffic volume. Other members of the board expressed their support for the proposal, as the building is currently underutilised. The move would provide better opportunities for Special Educational Needs (SEN) students and would support OFSTED recommendations. Transport officers had reviewed the space and would take measures to reduce congestion. The school would advocate for walking to school. Members of the board were encouraged to read and participate in the consultation.

#### 6 Domestic Resource Efficiency Service (Energy Doctors) Introduction

Vicky Nash, Energy Doctor conducted a presentation about the scheme and the initiatives available to improve energy efficiency. There were small measures that could be undertaken to make improvements to homes. The scheme would run until 2025. There was a limited budget and the service would source additional funding if required.

In response to queries about how the scheme was rolled out, it was clarified that the scheme would commence in March 2023 in Opportunity Bucks areas (Aylesbury, Chesham and Wycombe) before being rolled out more widely. Initially it would be specifically available to private rentals. Residents could request an assessment online:

#### 7 Community Board Project Update - Bringing the Skies to You

Ross Hockham provided a project update from UK Astronomy (project received funding from the Buckingham & Villages Community Board).

The presentation included details of the project beginnings and how it has developed into an educational charity, teaching people of all ages about astronomy. UK Astronomy now has an inflatable planetarium that can be used to conduct sessions during poor weather. The project will soon be rolled out to local secondary schools. The planetarium could fit 40+ young people. It was most suitable for Year 6 and above but they have recently acquired software that was targeted towards younger children.

Ross highlighted that free software is available- <u>Stellarium Astronomy Software</u>. This can be accessed from home for self learning.

#### 8 Community Board Update

Alice Williams highlighted the funding report on page 15 of the agenda pack.

As part of the update, the funding process was clarified. Applicants were required to speak to the Community Board Manager before submitting an application to ensure that the project was suitable for community board funding. There were two funding streams- community project funding (over 1,000) and small grants (up to £1,000). Contributory funding was required for project funding but not small grants.

The Community Board priorities had been set for 2023/24. These were: Youth, Health and Wellbeing, Road Safety and Economic Regeneration. Action groups would be formed around the theme of each priority to initiate and develop projects around these themes. An online form has been set up for residents to submit ideas, this would be shared and promoted on social media: https://forms.office.com/e/9EJWVumtGQ

Alice gave thanks to all who had attended the Community Engagement and Partnerships / Proud of Bucks Awards event on 4 May 2023. A member of the board raised that the social media posts celebrating the winners / highly commended nominees did not explain why they had won their awards. Alice responded that the reason for this was to keep social media posts short and concise, however the community board summer newsletter would provide detail.

Alice advised that she frequently worked "on the patch" and her schedule was to

base herself at Molly's Community Café, Steeple Claydon on Wednesdays, 10am-1pm and Buckingham Library on Thursdays, 10am-1pm. Board members were welcome to drop in at these times, but were advised to let Alice know beforehand in case there were diary conflicts.

## Share your views and help us keep Buckinghamshire safe

The Safer Buckinghamshire Board is a local Community Safety Partnership that brings together experts from the police, fire service, probation, health and social care services. The board develops an annual action plan to reduce crime and anti-social behaviour in Buckinghamshire and help keep it a safe place to live and work.

To help develop this plan, we want to hear from local residents to understand:

- the impact of crime and anti-social behaviour in their local area
- their experience of reporting crimes
- how safe or unsafe they feel in Buckinghamshire

## Local Plan – progress and next steps

The Local Plan for Buckinghamshire (LP4B) provides a major opportunity to shape the growth of Buckinghamshire over the next 15 years and beyond. It will identify areas for new housing and employment, while also designating areas for protection and enhancement, such as our valued landscapes, natural habitats and heritage.

Earlier this year we carried out a public engagement survey on the draft vision and objectives for the LP4B. We received about 700 responses to the Local Plan for Buckinghamshire Vision and Objectives which we are in the process of analysing and considering.

We have now published an <u>interactive map and basic details</u> of the 1,000 or so sites which were submitted in response to our two Calls for Brownfield Sites and our Wider Call for Sites. We are assessing these sites for their suitability, availability and achievability

(including viability) to accommodate development. This work will help us to shape the first Buckinghamshire Housing and Economic Land Availability Assessment (HELAA).

Our next local plan public engagement work is likely to take place in early 2024, subject to Cabinet approval. This will be on possible high-level growth scenarios for the spatial distribution of new development to meet assessed levels of housing and employment need.

# PickMeUp expands to Flackwell Heath

Wycombe's PickMeUp on-demand bus service, introduced by Buckinghamshire Council to reach residents not serviced by regular bus routes, has expanded to include Flackwell Heath. The expansion will help improve links from Flackwell Heath to Loudwater, Cressex, Booker and other parts of town.

Launched as a pilot in September 2022, it is funded by a three-year, central Government Rural Mobility Fund grant. It has proved popular, providing 1,500 rides per week and running Monday to Friday from 6am to 7pm.

Now after reviewing how the service is being used, and in response to requests from the local community, the council and operator Carousel Buses are pleased to extend the benefits of the service to many more potential passengers.

An additional vehicle will now operate at the morning and afternoon peak to keep up with demand. Fares reflect other local bus services and bus tickets such as Wycombe Smart Zone tickets and Concessionary Bus Passes are valid.

With their agreement, these residents have been referred on to our Making Every Adult Matter (MEAM) Team who can offer intensive support to develop a better understanding of the challenges these residents are facing and help to connect them with additional services who can further support them.

#### **Welcoming Spaces**

There are locations throughout the county, including Buckinghamshire libraries and community venues such as churches and halls, that have continued to offer a Welcoming Space to residents throughout the summer months.

Now that we are moving into autumn we are looking at ways in which Welcoming Spaces can again offer residents warm and friendly places to go and meet with others this coming winter. More information on resources and guidance for setting up a Welcoming Space will be available shortly.

#### **Energy Doctor**

Buckinghamshire Council has introduced a new Energy Doctor scheme as one of the initiatives funded by its allocation of the Government's UK Shared Prosperity Fund.

Under the scheme, domestic resource efficiency officers are visiting qualifying homes to assess and advise on measures that can reduce energy consumption and costs.

The team also installs suitable low-cost measures in homes such as draught proofing, hot water cylinder insulation jackets, reflective radiator panels, secondary glazing film and LED lights.

To qualify for an Energy Doctor visit, applicants must meet all of the following criteria:

- They rent the property through a private rental agreement, or own and live in the property
- The household has an income of £30,000 or less (before tax), is in receipt of meanstested benefits such as Universal Credit and Council Tax Support, or a member of the household is disabled
- The domestic property has an energy performance certificate (EPC) rating of D, E, F or G, or does not legally require an EPC

#### **Revenues and Benefits**

Council tax collection remains on target despite obvious pressures in the community and as a result additional funding is being made available to the discretionary housing payment

fund to support residents who may have one-off difficulties preventing them paying their rent.
