## 3. Summary of the decision:

3.1 That an Enforcement Notice be issued and served for the following breaches of planning control at land at One Acre Cottage, Framewood Road, Wexham, Buckinghamshire S12 4QS ("the land").

"Without planning permission, the erection of an outbuilding shown hatched in the approximate position on the Plan"

3.2 That in the event that either Enforcement Notice is not complied with that the Head of Legal and Democratic Services is authorised to take legal proceedings to secure compliance therewith.

## 4. Reasons for the decision:

Having carefully considered recommendations from the Enforcement and Conservation Manager prepared by the Head of Legal and Democratic Services, I am satisfied that on balance, having regard to the personal considerations and general considerations relating to the land, the land owner and persons occupying the land, that these are not sufficient to outweigh the harm being caused to the Metropolitan Green Belt arising from the breach of planning control and thus do not amount to very special circumstances. When dismissing the appeals regarding application ref. nos. 12/01883/FUL and 14/01063/FUL for the retention of a detached outbuilding the Inspectors concluded that the siting and size of the buildings would adversely affect the openness of the Green Belt, which is one of its essential characteristics and only moderate weight was given to the potential permitted development rights which might exist for erecting a similar outbuilding elsewhere within the curtilage. I consider the taking of enforcement action to be proportionate ensuring the proper enforcement of planning control and the continued protection of the Green Belt from the inappropriate development.
