Coming into force in accordance with article 1(2)

Aylesbury Vale District Council ("the Council") in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 ("the 2007 Act"), has undertaken a community governance review and made recommendations dated 7th January 2020.

The Council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient:

The Council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section:

The Council makes the following Order in exercise of the powers conferred by sections 86, 98(3), 98(4) and 240(10) of the 2007 Act.

Citation and commencement

- (1) This Order may be cited as the Aylesbury Vale (Reorganisation of Community Governance) Order 2020
- 2. (2) This Order comes into force:-
 - (a) for the purpose of proceedings preliminary or relating to the election of councillors, on the day after it is made;
 - (b) for all other purposes, the Order comes into force on the ordinary day of election of councillors in 2020.

Interpretation

3. In this Order -

"district"

means the district of Aylesbury Vale;

"existing"

means existing on the date this Order is made;

"map"

means the map marked "Map referred to in the Aylesbury Vale (Reorganisation of Community Governance) Order 2020" and deposited in accordance with Section 96(4) of the 2007 Act: and any reference to a numbered sheet is a

reference to the sheet of the map which bears that

number;

"new Parish Council"

means the Parish Council constituted by article 5

"new Parish Meeting"

means the Parish Meeting constituted by article 9;

"ordinary day of election of councillors" has the meaning given by section 37 of the

Representation of the People Act 1983 as amended by "The Districts of Aylesbury Vale, Chiltern, South Bucks and Wycombe (Changes to Years of Elections) Order

2018 (2018 No. 1355)".

"registration officer"

means an officer appointed for the purpose of, and in

accordance with, section 8 of the Representation of the

People Act 1983.

"renamed Bierton Parish Council" means the Parish Council constituted by article 8

Effect of Order

4. This Order has effect subject to any agreement under section 99 (agreements about incidental matters) of the Local Government and Public Involvement in Health Act 2007 relevant to any provision of this Order.

Constitution of parish of Kingsbrook

5. A new Parish Council to be known as Kingsbrook Parish Council

Number of parish councillors for the parish of Kingsbrook

6. The number of councillors to be elected for the parish of Kingsbrook shall be 9 (nine).

Calculation of budget requirement for the parish of Kingsbrook

7. For the purpose of regulation 3 of the Local Government Finance (New Parishes) (England) Regulations 2008 there is specified in relation to the parish of Kingsbrook in the sum of £35.00 for a Band D rated property.

Constitution of the parish of Bierton

8. The former Bierton with Broughton Parish Council which includes Broughton Crossing to be renamed Bierton Parish Council and to comprise the wards Bierton and Oldham Meadow. The number of councillors to be elected for the parish of Bierton shall be 9, and as follows:-

Bierton Ward: 8 councillors

Oldhams Meadow Ward: 1 councillor

Parish Meeting

 The Broughton Hamlet Ward of Bierton Parish Council become a new Parish Meeting known as Broughton Hamlet.

Election for the parishes of Bierton and Kingsbrook

The election of all parish councillors for the parishes of Bierton and
 Kingsbrook shall be held on the ordinary day of election of councillors in 2020.

Annual meeting of Kingsbrook Parish Council

11. The annual meeting of the new Kingsbrook Parish Council shall be convened by the Buckinghamshire Council. The meeting shall take place no later than 14 days after the day on which the councillors elected to the new parish council take office.

Electoral register

12. The registration officer of the district shall make such rearrangement of, or adaption of, the register of local government electors as may be necessary for the purposes of, and in consequence of, this Order.

Order date

 This Order is in accordance with article 1(2) for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008.
