Reason for decision: The scheme has been promoted by Buckinghamshire Council's Parking Services Team and the Development Management Team with the aim to control the competing demands for the available parking space whilst preventing obstructive parking to improve both road safety and the environment for local residents and others by introducing:

Executive summary

The authority had not reviewed all of its records of signs, lines, speed limits and moving traffic controls for some years and in February 2021, four new countywide orders were made (Static On-Street, Speed, Prohibition of Movement and Off-Street Parking Places). As part of this process a number of anomalies came to light.

This project aims to address those anomalies' and ensure that the On-Street signs and lines match the details within the various orders listed below.

Legal and financial implications

- The budget has been secured by Parking Services and Development Management to cover the consultation and implementation of restrictions at the various locations detailed above.
- The statutory consultation is required to comply with Road Traffic Regulation Act 1984.

Consultation and communication

No formal consultation has been carried out at this stage, ward councillors for the affected areas have been briefed on the various proposals and no objections received. Statutory Consultation will form part of the Traffic Regulation Order making process for the on-street static restrictions, speed limits and prohibition of movement.

Next Steps and Review

The Statutory Consultation is anticipated due to start in October 2021 and run for three weeks. Feedback will be collated and analysed by Transport for Buckinghamshire's On-Street Parking Services and the Design Team. The results and a recommendation will be submitted to the various Parish Council's and Members. Subject to the feedback received, a Key Decision Report (KDR) will be required to determine the next steps.
