Hope you are well?

After speaking with the "oider" members of the team at Little Marlow, they informed me the pipes were used to remove ground water from the site in order to construct the new works approx. 20 years ago. These pipes were left in. The pipes are capped off at both ends so they are not discharging into the lake.

If you then walk along the footpath to find the previous access point of the pipes into the Spade Oak Nature Reserve.

I hope this answers the question?

We also saw the notices about the algae bloom on the Spade Oak reserve signs, I hear it is a problem in a number of places around the country at the moment.

We do not pump anything into the lake, we discharge to the River Thame and the River Wye up at High Wycombe from Little Marlow Sewage treatment works.

David do you know if the investigations into the wildlife has been concluded, it would be good to understand, it is terrible.

Hi David,

Obviously a lot of interest in sewage in recent days. I will be interested to see what transpires in the Commons vote this evening.

I have received some questions below - I wonder if your knowledge of the site or contacts can provide a quick answer please?





We went for a family walk alongside the Treatment works yesterday in Little Marlow and came across these x2 pipes which feed into the Spade Oak Nature park lake.

They come out from the fence which runs alongside the path (which we were informed by local residents also out walking gets flooded with sewage when it rains heavily), the area which I have highlighted in red on the picture. Then when you look out onto the lake you can clearly see the water being moved where liquid is coming out onto the lake (I presume from the pipes).

We know where the outlet pipe that comes out into the Thames is located but did not know that they also 'possibly pump out liquid into the lake.

Also, we noticed just how muchalgal bloomthere is on the lake, and found out that Lake Windemere at the Lake District has the same issue:
