STATEMENT OF REASONS

The Buckinghamshire Council (Traffic Movement) Order 2021 (Amendment No. *) Order 202*

Buckinghamshire Council has conducted its annual review of its Network Safety Schemes. The proposals to close the right turn slip lane and central reserve thereby prohibiting turning movements from/at the A413 cross-over facility are intended to reduce collisions and casualties at this site.

In order to carry out these measures, it is proposed to implement the changes as a permanent Traffic Regulation Order (TRO).

With a Traffic Regulation Order prohibiting the "right turns and U-turns" at the central reserve, Thames Valley Police will be able to carry out enforcement to deter motorist from carrying out these dangerous manoeuvres on the A413 dual carriageway.

In accordance with Road Traffic Regulation Act 1984, traffic regulation orders are required for A413 Amersham Road:

- For avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of such a danger.
- For preserving or improving the amenities of the area through which the road runs.

The Buckinghamshire Council (Traffic Movement) Order 2021 (Amendment No. *) Order 202*

The Buckinghamshire Council (hereinafter referred to as "the Council") in exercise of its powers under section 1(1), 2(1) to 3, 4(1) and part IV of schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), The Transport Act 2000 and of all other enabling powers, and after consultation with the Chief Officer of the Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

- 1. This Order may be cited as The Buckinghamshire Council (Traffic Movement) Order 2021 (Amendment No. *) Order 202* and shall come into operation on the ** day of **** 202*.
- 2. In this order "central reservation" means the part of the road which separates the two carriageways of A413 Amersham Road, Gerrards Cross for the safety or guidance of vehicular traffic using that road.
- 3. No person shall cause or permit any vehicle proceeding from the Gerrards Cross golf club to make a right turn into the central island reserve towards the northbound carriageway of the A413 Amersham Road.
- 4. No person shall cause or permit any vehicle proceeding in the northbound carriageway of A413 Amersham Road to make a right turn and U-turn in the central reservation at the crossover facility towards Gerrards Cross golf club.
- 5. The Buckinghamshire Council (Traffic Movement) Order 2021 (Amendment No. *) Order 202* and shall come into operation on the ** day of **** 202* is amended as specified below:
