Dear Sir/Madam,

I am writing to you in connection with the application by Market Square Group Ltd for a premise license at Higginson Park. I have to object in the most strenuous terms.

As this is relevant, I should mention that I turned 90 a few months ago. I have also lived in my current home, which borders Higginson Park, since 1993. I have never in all these years seen such an increase in events and activities in Higginson Park as in the last couple of years. To put this in perspective, the most long-standing event, the Marlow Regatta, typically only lasted for two days. At present, the length of events has increased so much that last year Alfresco in the Park lasted for six days from early morning until late evening without any respite. Pub in the Park has grown to 4 days with a suggested eightfold increase in numbers! Who is in charge of managing the park?

With the exponentially growing number of events, there has also been a tremendous increase in noise and air pollution (from generators near my home). I have had significant difficulties sleeping when excessively noisy events are held in the park, which has been detrimental to my health. Even during the daytime, my well-being is affected by the endless and constant noise daily for many days on end. It is no longer unreasonable but has now become dangerous.

If the Market Square Group can now host weekly events, I will be at a loss. Unlike some of my neighbours who leave their homes and Marlow when the unreasonably noisy events are held in Higginson Park, I have nowhere to go. You cannot and should not allow the Market Square Group to host weekly events in the park! It is important to note that an application is also made to serve alcohol. Over the last almost 30 years in which I have lived next to Higginson Park, each time alcohol is served, it has led to consequences ranging from indecent exposure to my wife to unruly behaviours and even threats of violence.

In summary, your rapid and extensive increase in events in Higginson Park is at present interfering with my health. Depending on your immediate actions, you will leave me with no choice but to report you to the Health Authorities.
