#### Decision

Approval to proceed to Statutory Consultation and advertisement for the proposals in the New Denham area.

### **Reasons for the decision**

#### **Background**

Following S106 contributions to Buckinghamshire Council, Transport for Buckinghamshire (TfB) contacted Denham Parish Council and the Local Members of the Denham ward to discuss various options on how the S106 contribution could be utilised. It has been agreed with the working group, that comprises of local Buckinghamshire Councillors and parish council, that the following measures listed below would be taken forward:

- Upgrade the existing pedestrian refuge island on the A4020 Oxford Road, this includes a build out in the Denham shopping parade. The build out will remove two designated parking bays.
- Inclusion of singular designated motorcycle bay.
- Upgrade the uncontrolled crossing point on Willow Avenue.
- Replace the existing bollards on Willow Avenue.
- Resurface expanse of footway.

These proposals have been developed to provide more accessibility to all pedestrians travelling to and from the Denham shopping parade – see proposal in Appendix A. The Equality Act Chapter 2 Section 20 Clause 4 states the following *"where a physical feature puts a disabled person at a substantial disadvantage in relation to a relevant matter in comparison with persons who are not disabled, to take such steps as it is reasonable to have to take to avoid the disadvantage."* 

Buckinghamshire Council have secured funding for the statutory consultation and implementation of the proposals through Community Board.

# Authority to take this decision

The council scheme of delegation is contained within the Council's constitution.

# Other options available, and their pros and cons

Following discussions with key stakeholders it was collectively agreed that the measures listed above would be taken forward.
