<b>Decision:</b>	<b>Approval to take the proposal to introduce a 'Prohibition of Waiting, Loading and Stopping' and 'On-Street Parking Places' Traffic Regulation Order (TRO) on Rogers Lane, Stoke Poges to informal Consultation.</b>
<b>Reason for decision:</b>	<p>For preserving or improving the amenities of the area through which the road runs.</p> <p>For avoiding danger to persons or other traffic using the road or any other or for preventing the likelihood of any such danger arising.</p> <p>For preventing the use of the road by vehicular traffic of a kind which, or its use by vehicular traffic in a manner which, is unsuitable having regard to the existing character of the road or adjoining property.</p>

## **1. Background**

- 1.1 Proposals have been drawn up in Rogers Lane, Stoke Poges, in liaison with the Buckinghamshire local ward members and the parish council, to introduce a 'Prohibition of Waiting, Loading and Stopping' and 'On-Street Parking Places' Traffic Regulation Order (TRO) on Rogers Lane.
- 1.2 The proposal consists of stretches of no waiting at any time 20 metres from the junction of Bells Hill (B416), at sections along Rogers Lane (including the junctions with Duffield Lane and West End Lane, Aldridge Place, Stock Court Road, and Sefton Close ) as shown in the attached map tiles.
- 1.3 Stoke Poges Parish Council has secured funding of £12,048.19 for consultation and implementation of parking restrictions in Rogers Lane through the Beeches Community Board.

## **2. Authority to take this decision**

- 2.1 The pertinent Council scheme of delegation is contained within the Council's constitution.

## **3. Other options considered**

- 3.1 Any other options considered would also require an Informal Consultation followed by the Statutory Consultation process. The purpose of the informal consultation is to determine the most viable option to proceed with.

## **4. Local councillors & community boards consultation & views**

- 4.1 All Buckinghamshire local Ward Members have confirmed they are in favour of proceeding with the scheme and have supported the application through the Beeches Community Board.
- 4.2 No statutory consultation has previously been undertaken regarding this scheme.
