Decision: Approval to proceed to Statutory Consultation and

advertisement for the emergency access proposals on

London Road, Buckingham

Reason for decision:

- 1. For avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising.
- 2. For facilitating the passage on the road or any other road of any class of traffic (including pedestrians).

1. Background

- 1.1 Transport for Buckinghamshire (TfB) has been commissioned via the Buckingham and Villages Community Board to install an emergency access at the back of The Buckingham School on London Road, Buckingham. TfB liaised with The Buckingham School to finalise the proposals before proceeding to statutory consultation.
- 1.2 It has been agreed by both parties that the following measures would be taken forward:
 - Bespoke "EMERGENCY ACCESS KEEP CLEAR" marking placed within the school's property boundary.
 - Installation of dropped kerb

- Introduction of BUS STAND within the existing layby operating Monday to Friday 8am to 5pm.
- Introduction of no waiting at any time restrictions at both ends of the layby.
- 1.3 These proposals have been developed to encourage compliance with Highway Code Rule 243 which states that you must not stop or park "anywhere you would prevent access for Emergency Services".

2. Authority to take this decision

2.1 The council scheme of delegation is contained within the Council's constitution.

3. Other options considered

3.1 No other options were considered as part of the proposals.

4. Local councillors & community boards consultation & views

4.1 Buckinghamshire Council has secured funding for the statutory consultation and implementation for the proposals.
