1. Executive summary

- 1.1 All Local Authorities have a legal duty to prepare an accessibility strategy for schools for which they are responsible, which must be reviewed every three to five years.
- Following public consultation and routine review of the Accessibility Strategy, Councillor Cranmer is asked to approve the publication of the updated Accessibility Strategy 2022 to 2025.

2. Content of report

2.1 Background:

- a) Authorities have a legal duty to prepare an accessibility strategy for schools for which they are responsible. This strategy provides detail on how the Council will work with maintained schools to help increase accessibility, to enable all students to access education.
- b) Every three to five years, the Local Authority reviews the strategy in consultation with key stakeholders.
- c) Feedback received during consultation, supports the review of the strategy.
- 2.2 Strategy Review and Stakeholder Engagement
 - Review of the existing Accessibility Strategy was undertaken with stakeholder input from Specialist Teacher's within iSEND, School's Commissioning, Parents Representative Group FACT Bucks and Legal Services.
 - b) An Equality Impact Assessment was undertaken.
 - c) The revised draft strategy was shared with Children's Services Senior Leadership Team and Cabinet Member for Education and Skills, prior to consultation launch.
 - A targeted consultation was conducted in the Summer Term 2022 to secure feedback from maintained mainstream schools, maintained special schools, Health Services, Early Years Service's and FACT Bucks Parents Representative Group.
 - e) An online survey was published on the Council's consultation portal, Your Voice Bucks, throughout the consultation period.
 - f) Communications were circulated to encourage participation via Schools Bulletin, Schools Web, SENDIAS webpage, FACT Bucks Parent's Representative Group, Buckinghamshire Family Information Service webpage and targeted email.
 - g) Following the close of consultation period, responses were analysed, and an evaluation report was completed.
 - h) Consultation feedback was reviewed and incorporated into the revised strategy.
- 2.3 Main Changes to the Strategy

- a) Strategy layout was revised, to reflect clear separation of responsibilities of maintained schools and other education providers vs Local Authority.
- b) Language in the strategy was reviewed and adapted where possible to ensure intentions of the strategy were clear. A glossary has also been included.
- c) Information was updated regarding support available from Specialist Teacher's and the iSEND Service.
- d) Links to additional support resources were added.

- 7.1 A targeted consultation was conducted in the Summer Term 2022 and feedback has been incorporated into the revised strategy.
- 7.2 The updated strategy will be published on the Buckinghamshire Family Information Service webpage, as part of the SEND Local Offer.

- 8.1 The Buckinghamshire Accessibility Strategy 2022 to 2025 will be published within the SEND Local Offer.
