Title: Wotton Underwood Traffic Calming

Decision: To introduce dragons' teeth ahead of the existing two

village gateway features

Reason for decision: For avoiding danger to persons or other traffic using the

road or any other or for preventing the likelihood of any

such danger arising.

1. Background

- 1.1 On 13 June 2022, Transport for Buckinghamshire (TfB) was commissioned by the Haddenham and Waddesdon Community Board to implement Dragons Teeth and Rumble Strips on the approach to the two existing village gateways in Wotton Underwood.
- 1.2 Wotton Underwood Parish Council is promoting the project and has received reports from residents that vehicles travel through the village at excessive speeds. The council therefore wishes to calm the traffic past the buildings and junction with the main village.
- 1.3 Following design and feasibility work undertaken by TfB it was determined that the location was not suitable for Rumble Strips because of the noise generated, the local topography and the nearby dwellings.
- 1.4 In agreement with the Parish Council and ward Members the proposal was therefore changed to consult on Yellow Bar Markings instead of Rumble Strips.

1.5 A consultation took place with residents residing between the two white gateway features in the village between 4 November 2022 and 30 November 2022.



Wotton Underwood Traffic Calming Proposals

Note: Yellow Bar Markers are around the same height as centre line white markings (just one or two millimetres) however they can produce some noise. We propose to locate these further away from properties for this reason.

- 1.6 This report outlines the outcome of the consultation and the decision based on the feedback from residents, the Parish Council and Buckinghamshire Council ward Members.
- 1.7 No yellow bar markings to be installed following concerns raised through consultation of increased noise levels.
- 1.8 The Parish Meeting have secured the full funding through the community board to introduce dragons' teeth ahead of the existing two village gateways features in Wotton Underwood through the Haddenham & Waddesdon Community Board.
- 1.9 Highways Community Liaison Team is arranging installation of the dragons teeth

2. Authority to take this decision

2.1 The relevant Council scheme of delegation is contained within the Council's constitution.

3. Other options considered

- 3.1 Rumble strips were originally considered appropriate but following feasibility design this is not possible due to the topography and distance of the village gateways from dwellings. Following consultation, yellow bar marking has also been ruled out due to similar noise concerns from adjacent residents.
- 3.2 The Parish Council's long-term aim is to reduce the speed limit through the village, however current vehicle speeds are too high, and a speed assessment is unlikely to be successful.
- 3.3 The Parish Meeting considered all types of traffic calming measures before the commission was commenced.

4. Local councillors & community boards consultation & views

4.1 Local councillors and those connected with Wotton Underwood Parish make the following comments.
