

Annex 1 – Mandatory Conditions

The following conditions apply to all premises licences under the circumstances described, with the exception of community premises which are subject to the alternative licence condition. These following conditions are in addition to any conditions shown on the licence under Annex 2 and Annex 3.

Premises licences authorising the sale or supply of alcohol

Conditions 3, 4 and 6 do not apply to premises only licensed for consumption of alcohol "off" the premises.

Condition 1

No supply of alcohol may be made under the premises licence -

(a) At a time when there is no designated premises supervisor in respect of the premises licence; or

(b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Condition 2

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Condition 3

(1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises.

a) games or other activities which require or encourage, or are designed to require or encourage, individuals to –

(i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or

(ii) drink as much alcohol as possible (whether within a time limit or otherwise);

b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or

discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;

c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective; We hereby certify this to be a true copy of the original Winckworth Sherwood Winckworth Sherwood LLP Minerva House 5 Montague Close London SE1 9BB

d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

Condition 4

The responsible person must ensure that free potable (drinking) water is provided on request to customers where it is reasonably available.

Condition 5

(1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licences must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

(3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either:-

(a) a holographic mark or

(b) an ultraviolet feature.

Condition 6

The responsible person shall ensure that -

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures –

(i) beer or cider: ½ pint;

(ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and

(iii) still wine in a glass: 125 ml; and

(b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

Condition 7

A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

a. For the purposes of the condition set out in paragraph 1 –

(a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979

(b) "permitted price" is the price found by applying the formula –

 $\mathsf{P}=\mathsf{D}+(\mathsf{D}\mathsf{x}\mathsf{V})$

Where –

(i) P is the permitted price

(ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

(iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence –

(i) The holder of the premises licence

(ii) The designated premises supervisor (if any) in respect of such a licence, or

(iii) The personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and(e) "value added tax" means value added tax charged in accordance with the Value Added

Tax Act 1994.

Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

If the premises licence allows exhibition of films

Condition 8

Where a premises licence authorises the exhibition of film, the admission of children under the age of 18 to film exhibitions permitted under the terms of this licence shall be restricted in accordance with any recommendations made by:

(a) The British Board of Film classification (BBFC), where the film has been classified by that Board or

(b) The Licensing Authority where no classification certificate has been granted by the BBFC, or, where the Licensing Authority has notified the licence holder that section 20 (3) (b) applies to the film in question and the admission of children must be in accordance with any recommendation made by the Licensing Authority.

If the premises licence has conditions in respect of door supervisors

Condition 9

1. Where a premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, each such individual must:

(a) be authorised to carry out that activity by a licence granted under the Private Security Industry Act 2001; or

(b) be entitled to carry out that activity by virtue of section 4 of the Act.

2. But nothing in subsection (1) requires such a condition to be imposed:

(a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private SecurityIndustry Act 2001 (c12) (premises with premises licences authorising plays or films); or(b) in respect of premises in relation to:

(i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or

(ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act.

3. For the purposes of this section:

(a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and, which is licensable conduct for the purposes of that Act, (see Section 3(2) of that Act) and

(b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

Annex 2 - Conditions consistent with the operating schedule

1) Alcohol shall not be sold or supplied except during permitted hours.

In this condition, permitted hours mean:

- a) On weekdays, other than Christmas Day, 8.00am to 11.00pm.
- b) On Sundays, other than Christmas Day, 10.00am to 10.30pm.
- c) On Christmas Day, 12.00noon to 3.00pm and 7.00pm to 10.30pm.
- d) On Good Friday, 8.00am to 10.30pm.

The above restrictions do not prohibit:

a) during the first twenty minutes after the above hours, the taking of the alcohol from the premises, unless the alcohol is supplied or taken in an open vessel;b) the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;

c) the sale of alcohol to a trader or club for the purposes of the trade or club;d) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;

2) Alcohol shall not be sold in an open container or be consumed in the licensed premises.

b) The prevention of crime and disorder

1. A digital CCTV system will be installed, or the existing system maintained, such system to be fit for the purpose.

2. The CCTV system shall be capable of producing immediate copies on site. Copies of recordings will either be recorded digitally on to CD/DVD or other equivalent medium.

3. Any recording will be retained and stored in a suitable and secure manner for a minimum of 31 days and shall be made available, subject to compliance with Data Protection legislation, to the police for inspection on request.

4. The precise positions of the camera may be agreed, subject to compliance with Data Protection legislation, with the police from time to time.

5. The system will display, on any recording, the correct time and date of the recording.

6. The CCTV system will be maintained and fully operational throughout the hours that the premises are open for any licensable activity.

c) Public safety

There will at all times be adequate levels of staff maintained at the premises. Such staff levels will be disclosed, on request,

to the licensing authority and police.

d) The prevention of public nuisance

Adequate waste receptacles for use by customers shall be provided in and immediately outside the premises.

e) The protection of children from harm

1. The premises licence holder will ensure that an age verification policy will apply to the premises whereby all cashiers will be trained to ask any customer attempting to purchase alcohol, who appears to be under the age of 25 years (or older if the licence holder so elects) to produce, before being sold alcohol, identification being a passport or photocard driving licence bearing a holographic mark or other form of identification that complies with any mandatory condition that may apply to this licence.

2. Signage informing customers of the age verification policy adopted at the premises will be prominently displayed.

NOTES ON REGULATED ENTERTAINMENT

In terms of specific regulated entertainments please note that:

- Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.

Application to vary a premises licence.

This is an application to substantially vary the hours of operation for the above named premises.

The application is to=

- 1. Extend the hours for the sale of alcohol to 24 hours daily.
- 2. To include the provision of late night refreshment between the hours of 2300 and 0500 daily.
- 3. To remove certain conditions.
- 4. Include conditions as listed in Annex 2 boxes b to e.

The licence as it currently stands allows the sale of alcohol Monday to Saturday between the hours of 0800 and 2300, Sunday 10.00 to 22.30. With no non-standard timings.

The premise is a single story building located at the Junction of Mandeville road and Harvey road with the entrance facing out onto Harvey road. It has been at this location for many years, to my knowledge over 45. It is adjacent to a fish and chip shop which has also been there for many years. The fish and chip shop closes a 9pm each day it is open. It is surrounded on all four sides by dwelling houses, of which the ones opposite are a number of Old people's bungalows. The car park for the use of the premise is sat to the right of the premise as you look at it this itself is bordered on two sides by dwelling houses. To the front of the shop and chip shop is an open paved space surrounded by railings, with this space is seating and flower beds.

It is fair to say that over the years this area has seen few problems by either crime and disorder or public nuisance. It has not been termed a hot spot like some of our later opening premises. To be fair these are normally within the town as we have no other premises that are 24/7 other than the large supermarkets that sit outside the town on the industrial estates.

The premise in its application does not stipulate the style of its late night refreshment offering. Under this section it states that this provision will take place inside the premises but customers may leave the premises with items purchased. When asked, staff stated that the refreshment may consist of coffee and if requested they could provide Hot Dogs. The councils Licensing policy sets out the role of the council, at 1.5 and 1.6 it lays out its aims to make Buckinghamshire the best place to live, raise a family, work and do business. It goes onto talk about outstanding public spaces a place where residents, regardless of background have access to great opportunities, living healthy successful lives and aging well with independence, it states that they are the council's key priorities, and that licensing has a crucial role to play in achieving these goals.

It seeks to balance the interests of business and residents.

The police would not seek to object to this application by way of the Crime and Disorder objective under the licensing act, although this is untested at the moment as no 24hour licence is in place but would object under The prevention of public nuisance objective.

The council within their policy recognise at 3.35 the prevention of Public Nuisance and the causes of such problems. It quotes the negative effects of such things as, noise, light odour, dust and litter. It talks about noise escape from the premises, customer arrival and departure, customer parking, staff arriving and leaving, delivery of goods, outside areas, litter, street drinking.

The applicant has not within the application offered any conditions that would promote The prevention of public nuisance objective within or outside of the premises. It does not offer any conditions that would prevent Anti-Social Behaviour. The application as it stands offers nothing to prevent the area becoming a hot spot.

I acknowledge safe receipt of the premises licence variation application documentation (including proposed amended timings and operating schedule).

I am an authorised officer of the Council as set out in Section 69(2)(d) of the Licensing Act 2003. I fulfil the duties of a Responsible Authority as defined by Section 69(4)(e) of the Act in terms the Council's statutory functions associated with the minimisation or prevention of risks associated with pollution to the environment or harm to human health.

Environmental Health have reviewed the proposed variation to the licence and have established concerns in relation to potential noise from the premises which would not promote the prevention of public nuisance objective.

The premises is situated in a highly residential area with neighbouring residential properties being in close proximity on all four sides of the premises, namely properties on Mandeville Road, Kilner Road and Harvey Road. To the front of the premises and neighbouring takeaway, there is an open paved area with seating.

Environmental Health have not received any nuisance related complaints in respect of this premises, however it is felt that if the application were granted as applied for, the premises would pose a risk of becoming a source of noise nuisance during the late hours of the night/early morning. This could result from general customer noise, potential for noise from customers gathering in the open space outside of the premises and also potentially from the plant and equipment needing to operate for longer periods of time (i.e. air conditioning/heating, refrigeration equipment). The plant area for the premises is located at the rear of the premises and is within approximated 5 meters of the neighbouring property on Kilner Road.

Unfortunately, the applicant has not provided sufficient information in support of this application to allay Environmental Health's concerns in relation to the above. Whilst the addition of CCTV as a condition is a positive proposal, the only condition directly attributed to the prevention of public nuisance relates to adequate waste receptacles being provided. Environmental Health would have welcomed further controls to be proposed by the applicant which addressed areas such as;

- Waste and litter collection.
- Time restrictions on emptying waste receptacles to prevent disturbances for neighbours.
- Active monitoring of the premises and outside area.
- Training for staff to prevent disturbances.
- Complaints procedure and records/log.

It is also not clear whether the premises will be offering delivery services through online delivery platforms/apps. As such, clarity is requested in relation to this matter and if this is the case, Environmental Health would suggest that further controls would be required, should the application be granted. Such controls may include restrictions on timings for delivery services to be available etc. to prevent unreasonable levels of noise from delivery services going to and from the premises.

Without further information about the applicant's intentions or proposed controls, **Environmental Health hereby object to the application being granted in its current form**. However, engagement and further information from the application would be supported.

I am submitting a representation on behalf of the Licensing Authority in respect of this application to vary a premises licence. In drafting this representation, careful consideration has been given to the promotion of the four licensing objectives, the Buckinghamshire Council Statement of Licensing Policy, "The Policy" and the Secretary of State Section 182 Guidance, "The Guidance".

The current licence permits sale of alcohol between the hours of 08:00 and 23:00 hours Monday to Saturday and between 10:00 and 22:30 on Sundays.

The application is to allow 24 hour sale of alcohol for consumption off the premises only, to add late night refreshment between the hours of 23:00 and 05:00 and to amend conditions in Annex 2 of the current licence, including removal of restricting sale of alcohol hours on Good Friday and Christmas Day.

The premises licence for 79 Mandeville Road, previously held by Mid Counties Co Op Ltd, was transferred to the current licence holder Samy Limited on 06.02.2023. This shop, which I have seen is now trading as a Budgens, is next to a fish and chip shop and faces onto a paved area with railings around the perimeter and includes bench seating. There are parking spaces available for customers and residents to use to the side of the shops. There are residential properties in close proximity surrounding these shops. The fish and chip shop's website states that they are open between the hours of 16:00 and 20:00 Tuesday to Saturday and are also open 12:00 to 14:00 on a Friday and Saturday.

Paragraph 8.41 of the Guidance states: "In completing an operating schedule, applicants are expected to have regard to the statement of licensing policy for their area. ...applicants are also expected to undertake their own enquiries about the area in which the premises are situated to inform the content of the application."

The Guidance goes on to state, paragraph 8.42: "Applicants are, in particular, expected to obtain sufficient information to enable them to demonstrate, when setting out the steps they propose to take to promote the licensing objectives that they understand:

- the layout of the local area and physical environment including crime and disorder hotspots, proximity to residential premises and proximity to areas where children may congregate;
- any risk posed to the local area by the applicants' proposed licensable activities..."

At paragraph 8.43, "Applicants are expected to include positive proposals in their application on how they will manage any potential risks.

Finally, the Guidance states at paragraph 8.43, "It is expected that enquiries about the locality will assist applicants when determining the steps that are appropriate for the promotion of the licensing objectives. For example, premises with close proximity to residential premises should consider what effect this will have on their smoking, noise management and dispersal policies to ensure the promotion of the public nuisance objective. Applicants must consider all factors which may be relevant to the promotion of the licensing objectives, and where there are no known concerns, acknowledge this in their application."

Paragraph 3.11 of Buckinghamshire Council's Policy states:

"in line with the duty to promote the licensing objectives, the Licensing Authority's Policy is to respect the right of residents to peace and quiet. In general, the Licensing Authority will take a more stringent approach to licensing hours in areas of higher residential density where there is greater risk of public nuisance."

In paragraph 3.13 it states:

"Shops, stores and supermarkets will normally be free to provide sales of alcohol for consumption off the premises at any times when the retail outlet is open for shopping unless there are good reasons, based on the licensing objectives, for restricting those hours. Further, in the case of individual shops which are known to be a focus of disorder and disturbance then, subject to representations from, for example, the police or other persons, a limitation on licensing hours may be appropriate."

Having reviewed the application, I believe that the applicant has disregarded statutory guidance and Council policy.

There is insufficient detail within the application to determine the nature of the late night refreshments that will be on offer or who their anticipated customers will be.

The premises is located in a highly residential area. It is of concern that the proposed operating schedule gives no indication of the applicant being aware of the premises proximity to residential properties and fails to set out how they intend to meet the licensing objectives, in particular that of preventing public nuisance such as street drinking in the vicinity of the shop and the attraction of customers who may already be inebriated. There is no reference to logging refusals of sale of alcohol, signage advising customers to respect local residents when leaving the premises or actively discouraging the consumption of alcohol directly outside the premises.

Whilst it is acknowledged that the Licensing Authority are not aware of any current issues with street drinking or anti social behaviour in this area, there is a significant risk that the proposed increase in hours and the addition of late night refreshment, will have an adverse impact on promotion of the licensing objectives.

It is the recommendation of the Licensing Authority that this application be refused.

On behalf of the Aylesbury South East Ward Buckinghamshire Councillors and also the Aylesbury Town Council Mandeville & Elm Farm Ward Councillors who have all been copied into this email, our objections to the above application are as detailed below:

Prevention of public nuisance objective

We are raising an objection on the grounds that the large open space, with seating, in front of the shop could result in individuals congregating in the area, particularly in the early hours, causing a disturbance to the surrounding neighbourhood. License to sell alcohol over a 24 hour period in a predominately residential area, which includes a large number of bungalows for elderly residents, has been known to lead to problems of an antisocial nature. Maybe an extension to the license, only up to 12 midnight, could negate this issue and alleviate concern. Additionally the situation of the shop and the inevitable increase in delivery vehicles, especially early morning, may cause temporary obstruction and impact on the already congested roads.

Public safety objective

We are objecting on the grounds that 24 hour opening hours could give rise to increased litter which could cause hazards to the public. Parking in the area is also of concern as individuals currently using the shop together with the adjacent fish and chip takeaway, despite a parking area nearby, tend to park on the corners of the access roads and have been known to cause obstructions as a result.

Prevention of crime/disorder objective

Whilst there shouldn't be a risk of a crime and disorder incident as a result of the 24-hour licensing/food application, the fact that Individuals are likely to be congregating in the area, whilst drinking etc. could, in turn, lead to altercations and disruptive behaviour.

Protecting children from harm objective None, as hopefully the children would be safely at home during the late night/early hours.

General licensing objectives

The main objection is a concern that a license to sell alcohol over a 24 hour period in a predominately residential area could lead to problems of an anti social nature.

Conditions

- 1. A digital CCTV system will be installed, or the existing system maintained, such system to be fit for the purpose and to be to the reasonable satisfaction of the police.
- 2. The CCTV system shall be capable of producing immediate copies on site. Copies of recordings will either be recorded digitally on to CD/DVD or other equivalent medium. Images shall be provided to the police or to an authorised officer of the licensing authority within 24 hours of request.
- 3. Any recording will be retained and stored in a suitable and secure manner for a minimum of 31 days and shall be made available, subject to compliance with Data Protection legislation, to the police for inspection on request.
- 4. The precise positions of the camera may be agreed, subject to compliance with Data Protection legislation, with the police from time to time.
- 5. The system will display, on any recording, the correct time and date of the recording.

- 6. The CCTV system will be maintained and fully operational throughout the hours that the premises are open for any licensable activity.
- 7. There will at all times be adequate levels of staff maintained at the premises. Such staff levels will be disclosed, on request, to the licensing authority and police.
- 8. Adequate waste receptacles for use by customers shall be provided in and immediately outside the premises.
- 9. The premises licence holder will ensure that an age verification policy will apply to the premises whereby all cashiers will be trained to ask any customer attempting to purchase alcohol, who appears to be under the age of 25 years (or older if the licence holder so elects) to produce, before being sold alcohol, identification being a passport or photocard driving licence bearing a holographic mark or other form or method of identification that complies with any mandatory condition that may apply to this licence.
- 10. Signage informing customers of the age verification policy adopted at the premises will be prominently displayed.
- 11. All staff engaged or to be engaged in the sale of alcohol on the premises shall receive the following training in age restricted sales:
 - Induction training which must be completed and documented prior to the sale of alcohol by the staff member.
 - Refresher/reinforcement training at intervals of no more than 6 months.

Training records will be kept at the premises available for inspection by a police officer or other authorised officer on request.

- 12. All cashiers shall be trained to record refusals of sales of alcohol in a refusals register. The register will contain:
 - details of the time and date the refusal was made;
 - the identity of the staff member refusing the sale;
 - details of the alcohol the person attempted to purchase.

This register will be available for inspection by a police officer or other authorised officer on request.

- 13. An incidents register shall be maintained at the premises recording:
 - all incidents of crime and disorder occurring at the premises;
 - details of occasions when the police are called to the premises.

This register will be available for inspection by a police officer or other authorised officer on request.

- 14. All sales tills shall prompt the cashier making a sale of alcohol to verify that the customer is aged 18 or over.
- 15. Signage will be displayed in prominent positions within the store warning adults not to attempt to buy alcohol for those under 18 years of age.

- 16. Signage will be displayed at the exit of the premises requesting customers leaving the premises late at night to do so quietly and with consideration so as not to disturb nearby residents.
- 17. There shall be no sale of beer, lager, or cider with an ABV content of 6% ABV or above save for premium products which have been agreed with the police (email authority will suffice).
- 18. There shall be no self-service of spirits except for spirit mixtures with an ABV not exceeding 6% ABV.
- 19. There shall be no alcohol available by self-service within 5 metres of the store entrance.
- 20. The premises licence holder shall endeavour to eliminate or minimise any nuisance arising out of its licensable activities. In doing so the premises licence holder will work with enforcement authorities where any issues are identified. Local residents will be provided with contact details if necessary.
- 21. No collections of waste or recycling materials (including bottles) from the premises shall take place between 22:00 hours and 07:00 hours on the following day.
- 22. No deliveries to the premises shall take place between 22:00 hours and 07:00 hours the following day.
- 23. The licence holder will ensure that its staff monitor and keep clean the pavement area to the front of the premises.
- 24. The entrance door to the shop will be closed to customers between the hours of 2400 and

0600. Any sales between these hours will be made through the night pay window.

Should there be delivery of alcohol from the premises the following conditions will apply:

25. The licence holder will display a notice in a prominent position on the premises reminding all couriers:

- to ensure that their vehicles are not left idling.
- to keep noise to a minimum when collecting orders for delivery; and
- having collected their order to leave the immediate vicinity of the premises as quietly as possible.
- 26. Delivery of alcohol shall be to a residential address or place of work. The delivery of alcohol must be by way of hand over to a person.
