Thanks for giving me an opportunity to provide further information.

I would like to add that whilst I would prefer the permit to be renewed on the Broadway where I currently am, when Joanne Bowles and Caroline Steven met with me in Chesham on Wednesday 23 March 2022, along with Cllr Augustus and Cllr Macbean, the officers suggested a potential solution.

We discussed potentially moving my Kebab Van to the entrance of Star Yard outside of market days, on Mondays, Tuesdays, Thursdays and Fridays, and on the Broadway on Market days.
